Report on Race Meeting held at Gawler Racecourse
by the Gawler & Barossa Jockey Club on Wednesday, 10 October 2012

RACE 1 : CENTURY 21 ASSENT MANAGEMENT / GAWLER STOCK FEEDS MAIDEN
PLATE - 1716 metres

BAKLAVA BOY (NZ) (C. Lindop) and REGAL JASMINE (NZ) (T. Zanker) raced wide without cover in the early stages of the event.

In the vicinity of the 1300 metres, for a short distance, VIKING EXPRESS (NZ) (M. Kelly) and IMAGINARIUM (K. Bishop) were inconvenienced when the pace slackened.

L. Stojakovic, the rider of FLIMFLAMMERY, reported her mount had a tendency to shift away from other runners to its inside and as a consequence she was obliged to race wide without cover in the middle stages of the event.

In the vicinity of the 700 metres BAKLAVA BOY (NZ) (C. Lindop), which had commenced to improve, was obliged to steady off the heels of DEE JAYS DASH (B. Claridge) and alter course to its outside.

T. Pannell, the rider of NEW ORDER, pleaded guilty to a charge under ARR.137A(5)(a)(ii) in that he used his whip in excess of the number of times permitted under the Rules and was fined \$100.

M. Kelly, the rider of VIKING EXPRESS (NZ), was questioned regarding his use of the whip in a manner that raised his arm above shoulder height on two occasions in the straight and was reprimanded.

BAKLAVA BOY (NZ) was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 2 : SEARLE RACING / TARRAWATTA AGISTMENT / SABOIS 3YO MAIDEN
PLATE - 1211 metres

Acting on confirmed advice from Mr. L. Kavanagh, representing Mr. M.A.T. Kavanagh, the Trainer of LIFE IN A METRO that the filly had cut its tongue and would be unfit to race, Stewards withdrew LIFE IN A METRO at 9.00 am.

RACE 2 : SEARLE RACING / TARRAWATTA AGISTMENT / SABOIS 3YO MAIDEN PLATE - 1211 metres (Cont'd)

CLUBS ARE TRUMPS (J. Frew), MO SEANS (D. Tourneur) and TREASURE SON (K. Bishop) were slow to begin.

BEV'S DREAM (P. Gatt) jumped away awkwardly, shifted out and inconvenienced FLYING SKIPPER (A. Patterson).

FAMOUS FIGHTER (S. Cahill) jumped away awkwardly, knuckled at the start and as a consequence the saddle on the gelding slipped back, placing S. Cahill at a disadvantage for the remainder of the race.

Inside the 500 metres CLUBS ARE TRUMPS (J. Frew) became awkwardly placed on the heels of BEV'S DREAM (P. Gatt) for a number of strides as that horse raced greenly and was inclined to lay out.

From the entrance to the straight until near the 200 metres CLUBS ARE TRUMPS (J. Frew) became held up for clear running on the heels of BEV'S DREAM (P. Gatt) and to the inside of MO SEANS (D. Tourneur), which commenced to lay in and shifted in.

LATIN HERO (J. Holder) hung out rounding the home turn and raced wide into the straight.

BEV'S DREAM (P. Gatt) raced greenly and laid out in the straight.

MO SEANS (D. Tourneur) laid in, in the straight.

S. Cahill, the rider of FAMOUS FIGHTER, accidentally dropped his whip in the vicinity of the 200 metres and was reprimanded.

RACE 3 : ELDERS / SABOIS FILLIES & MARES MAIDEN PLATE - 1111 metres

AMYJAYE'S GIRL, which was fractious in its race day stall and slipped behind, was examined by the Club's Veterinary Surgeon who reported abrasions to both hind pasterns but declared the mare fit. AMYJAYE'S GIRL was again examined by the Club's Veterinary Surgeon on arrival at the barriers and ruled fit to race.

KLONDIKE LIL, which was kicked by another runner at the barriers, was examined by the Club's Veterinary Surgeon and ruled fit to race.

FLYING HANKERCHIEF (P. Gatt) and KRISTABELLA (D. Tourneur) jumped away awkwardly, came together and contacted at the start.

PIERREMONT ROCKS (A. Patterson) jumped away awkwardly.

In the vicinity of the 800 metres ELGIRANA (J. Kah) and FLYING HANKERCHIEF (P. Gatt) brushed on several occasions when racing in restricted room.

A. Patterson, the rider of PIERREMONT ROCKS, explained his instructions were to obtain a position mid-field with cover if possible but given the manner in which the mare began and its wide barrier he elected to take a position closer to the rail back in the field with cover. He added the mare was off the bridle and despite his efforts approaching the 500 metres, was initially reluctant to respond to his riding but then finished the race in a respectable manner and in his opinion the mare may be better suited to more ground. PIERREMONT ROCKS was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

FLYING HANKERCHIEF, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 4 : WINTULICHS SMALLGOODS / SABOIS MAIDEN PLATE - 1211 metres

The start of this race was delayed approximately two minutes owing to POWER BUTTON proving very difficult to load. Mr. P. Jolly, representing Mr. R. Jolly, the Trainer of POWER BUTTON, was advised the gelding would have to present at either an Official Barrier Trial or an Official Jump Out to gain approval to race.

BOLTIN' HENRY was examined by the Club's Veterinary Surgeon on arrival at the barriers at the request of its rider T. Pannell and ruled fit to race.

BOLTIN' HENRY (T. Pannell), whilst initially maintaining contact with the field, tailed off and raced uncompetitively.

SWISS CHALET (C. Lindop) jumped away awkwardly, shifted out and contacted HAMMERANDSICKLE (S. Price).

HALF BACK FLANK (L. Stojakovic) shifted out on jumping away and inconvenienced COBBY ROYALE (J. Holder).

SON OF NALA (J. Matthews) and CASH JOB (D. Stra) came together at the start and contacted.

In the vicinity of the 900 metres COBBY ROYALE (J. Holder) brushed the running rail.

In the vicinity of the 500 metres SWISS CHALET (C. Lindop) raced in restricted room for a number of strides between HAMMERANDSICKLE (S. Price) to its inside and POWER BUTTON (P. Gatt) to its outside.

Approaching the 400 metres SON OF NALA (J. Matthews) became awkwardly placed on the heels of HALF BACK FLANK (L. Stojakovic) as it improved its position.

Inside the 300 metres HAMMERANDSICKLE (S. Price) rolled out, taking SON OF NALA (J. Matthews) out, which then shifted out and away from HAMMERANDSICKLE across the running of POWER BUTTON (P. Gatt), which was obliged to be checked off the heels of SON OF NALA to avoid that gelding's heels.

T. Pannell, the rider of BOLTIN' HENRY, explained whilst the gelding began on terms he had to work hard in the early stages to maintain contact with the field and shortly thereafter the gelding was inclined to lay in and was off the bridle. He added that from in the vicinity of the 800 metres he had become concerned in the manner in which BOLTIN' HENRY galloped and thereafter at the entrance to the straight he elected not to persevere with riding the gelding to the finish. BOLTIN' HENRY was examined by the Club's Veterinary Surgeon who reported a lower than expected heart rate. Mrs. J. Banks, the Trainer of BOLTIN' HENRY, advised Stewards the gelding would now be spelled.

POWER BUTTON was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

Following the running of this event, Stewards downgraded the track retrospectively to a Dead 4 at 2.38 pm.

RACE 5 : GAWLER RIVER CATTLE CO. BUTCHERS' STEAKS RATING 0-62 HANDICAP – 1716 metres

The start of this event was delayed approximately two minutes owing to the late presentation of the runners in the mounting enclosure as a consequence of the prevailing weather conditions.

OKAMAN (D. Tourneur) pulled hard in the early and middle stages of the event.

**RACE 5 : GAWLER RIVER CATTLE CO. BUTCHERS' STEAKS RATING 0-62 HANDICAP –
1716 metres (Cont'd)**

In the vicinity of the 500 metres JEUNE'S LAGOON (T. O'Donnell) became held up for clear running for a short distance when racing behind MEADOWS MAGIC (J. Kah) and CURRAHEE (A. Patterson).

Shortly after the entrance to the straight BRUNO (J. Maund) became held up for clear running for a short distance when racing behind FRAACHARM (T. Pannell).

**RACE 6 : STANDOM SMALLGOODS WE GIVE A CONTINENTAL CLASSIC CLASS 1
HANDICAP - 1211 metres**

DAN'S A LADY (J. Toeroek) jumped away awkwardly, shifted out and was then inconvenienced when taken out by TIGGY (J. Holder), which jumped away awkwardly and shifted out abruptly. As a consequence of DAN'S A LADY being taken out, that mare inconvenienced QUICK THOUGHTS (B. Claridge) for a number of strides.

DANISH SPY (J. Matthews) jumped away awkwardly, shifted in and contacted PRECINCT (J. Maund).

In the vicinity of the 900 metres MOTZART (J. Bowditch), which had commenced to race very keenly, became awkward on the heels of KING ROSELAND (K. Bishop) and was obliged to shift to the outside of that gelding's heels and in doing so, brushed WAIKIKI GIRL (L. Stojakovic), taking that mare wider.

DAN'S A LADY (J. Toeroek) hung out throughout the event.

PRECINCT (J. Maund) hung out in the straight.

J. Toeroek, the rider of DAN'S A LADY, reported his mount hung out from in the vicinity of the home turn. DAN'S A LADY was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

**RACE 7 : SOUTH AUSTRALIAN BUNG FRITZ CLUB RATING 0-68 HANDICAP -
1511 metres**

SOUTHERN FORTUNE (A. Patterson) and FULL BORE (J. Toeroek) were slow to begin.

LIMBO QUEEN (L. Stojakovic) raced wide without cover in the early stages of the event.

J. Kah, the rider of SMOKE 'EM BILLY, explained her instructions were to take up a position mid-field with cover if possible but after stumbling shortly after the start, she was unable to comply with her instructions and was obliged to race back in the field. She stated that nevertheless she formed the view in the vicinity of the 800 metres the field was compact and she did not have concern for her position in running but when asked for an effort in the vicinity of the 600 metres the gelding was off the bridle and failed to respond to her riding and performed disappointingly. SMOKE 'EM BILLY was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

**RACE 8 : GAWLER RIVER CATTLE CO. QUALITY CHALLENGE RATING 0-62 HANDICAP –
1111 metres**

At the request of Mr. J. MacMillan, the Trainer of GUMNUTS, the Club's Veterinary Surgeon examined the gelding and found it to have a persistent cough. Acting on that advice, Stewards withdrew GUMNUTS at 2.45 pm.

**RACE 8 : GAWLER RIVER CATTLE CO. QUALITY CHALLENGE RATING 0-62 HANDICAP –
1111 metres (Cont'd)**

TRISTACAT (D. Stra) was slow to begin.

GENARKA STAR (A. Patterson) jumped away awkwardly.

CANNY PREVAIL (J. Maund) raced wide in the early stages of the event.

In the vicinity of the 900 metres SUKI (J. Holder) shifted in to take up a forward position and inconvenienced ROSE OF LINCOLN (J. Matthews). J. Holder was reminded of his obligations when shifting ground in future.

Approaching the 300 metres ROSE OF LINCOLN (J. Matthews) shifted out and improved to the inside of ODETTE (E. Boyd), initially making contact with that mare and thereafter tightening it onto CANNY PREVAIL (J. Maund), resulting in ODETTE having to be steadied and losing its position. As a consequence GENARKA STAR (A. Patterson), which was following, had to alter course to the inside of ODETTE to avoid that mare's heels. J. Matthews pleaded guilty to a charge of Careless Riding under ARR.137(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Saturday, 13 October and to conclude at midnight on Sunday, 21 October 2012; a period of four (4) meetings.

In the vicinity of the 200 metres MUSTANG SCHILLER (D. Tourneur) was initially disappointed for clear running between MEADOWS CAT (P. Gatt), which rolled in, and CANNY PREVAIL (J. Maund), which rolled out, and was then inconvenienced when racing in restricted room between these two runners. As a consequence MUSTANG SCHILLER was obliged to shift out away from CANNY PREVAIL and brushed with MEADOWS CAT. P. Gatt and J. Maund were reminded of their obligations when their mounts commence to shift ground.

J. Maund, the rider of CANNY PREVAIL, reported his mount was galloped on during the race. CANNY PREVAIL was examined by the Club's Veterinary Surgeon who reported a minor laceration to the near hind leg. First Aid was administered.
