### Report on Race Meeting held at Morphettville Racecourse by the South Australian Jockey Club on Saturday, 20 October 2012

### RACE 1 : SCHWEPPES HANDICAP - 2500 metres

OUR TIGER LIL (J Duffy) raced keenly in the early and middle stages of the event.

In the vicinity of the 600 metres and again approaching the 400 metres, FAINEANT (A Herrmann) shifted out to improve and in doing so brushed HOLLYWOOD AND VINE (L Hopwood).

HOLLYWOOD AND VINE, which performed poorly, was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in near foreleg. Mr M Whittle, the Trainer of HOLLYWOOD AND VINE, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

## RACE 2 : BOAG'S DRAUGHT HANDICAP - 1000 metres

WRITE NO MORE (S Price) jumped away awkwardly, shifted in and contacted NULLARBOR NYMPH (P Gatt).

SCREAMER (A Patterson) raced three-wide without cover throughout the event.

EXALTED WILLIAM (L Hopwood) raced greenly throughout the event.

From the vicinity of the 50 metres TALK OF ANGELS (J Duffy) shifted out under pressure inconveniencing NULLARBOR NYMPH (P Gatt). J Duffy was reminded of his obligations when shifting ground in future.

## RACE 3 : ADELAIDE CASINO HANDICAP - 1800 metres

MISS BALL (J Maund) and LE ROI (GER) (M Neilson) were slow to begin.

CORNISH (IRE) (L Hopwood) jumped away awkwardly.

MANGANESE (L Kah) raced wide without cover throughout the event.

# RACE 4 : ENDEAVOUR HOMES HANDICAP - 1200 metres

NOBLE SUCCESS (J Holder) jumped away awkwardly, shifted out and had to be steadied off the heels of FINNISS STORM (J Kah).

In the vicinity of the 800 metres EXALTED MOMENT (P Gatt) and FINNISS STORM (J Kah) came together and brushed for several strides.

Approaching the 200 metres NOBLE SUCCESS (J Holder) attempted a tight run between the heels of TESTATE (J Bowditch) and FINNISS STORM (J Kah) and became disappointed when TESTATE shifted out slightly taking NOBLE SUCCESS out onto the hindquarters of FINNISS STORM, which was tightened onto MR GOOD CAT (C Lever), which shifted in slightly. As a result of the contact MR GOOD CAT and FINNISS STORM were turned in, resulting in NOBLE SUCCESS being taken in onto the heels of TESTATE and having to be checked. J. Bowditch was reminded of his obligations when shifting ground in future.

PIONEER PRINCE was inclined to lay out under pressure in the straight. PIONEER PRINCE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

Correct Weight for this event was delayed to permit J Holder, the rider of the sixth placegetter NOBLE SUCCESS and that gelding's trainer Mr D Jolly, to view the official footage in the straight.

M Neilson, the rider of PIONEER PRINCE, was questioned regarding his use of the whip prior to the 100 metres. M Neilson pleaded guilty to a charge under ARR137A(5)(a)(ii) in that he used his whip in a forehand manner on more than five occasions prior to the 100 metres and was reprimanded.

## RACE 5 : DURBRIDGE STAKES - 1200 metres

CONSERVATORIUM (P Gatt) jumped away awkwardly and shifted out, contacting MEADOWS JIM (S Price).

SUPER SATIN (NZ) (M Neilson) was slow to begin.

ST FRASER (K Bishop) was unable to obtain clear ground from the vicinity of the 500 metres until the entrance to the straight when awkwardly placed inside the heels of JUSTIFY THAT (T Baker) and outside THE EIGHTH MAKER (J Bowditch).

M Neilson, the rider of SUPER SATIN (NZ), explained the gelding had travelled well in the early stages of the event, however, when placed under pressure inside the 600 metres, failed to respond to his riding and he became concerned with its action in the straight. SUPER SATIN (NZ) was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

CONSERVATORIUM, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

## RACE 6 : SABATINO BUILDERS P/L HANDICAP - 1200 metres

AMBROSIA (J Potter) raced keenly in the early and middle stages of the event.

In the vicinity of the 900 metres GLENARIFF (J Kah) shifted in onto SHOCTONIC (P Gatt), which had to steady momentarily.

# RACE 6 : SABATINO BUILDERS P/L HANDICAP - 1200 metres (Cont'd)

In the vicinity of the 700 metres LA POUPEE (S Cahill) rolled out and brushed LILLYOFTHEVALLEY (J Duffy), which was taken out onto GLENARIFF (J Kah), which was inconvenienced.

OUR MIMI (J Toeroek) laid in under pressure in the straight.

Approaching the 200 metres OUR MIMI (J Toeroek), which continued to lay in, attempted a tight run between VISUAL IMPACT (J Maund) and KATE'S DREAM (S Price) and became disappointed for that run, when VISUAL IMPACT commenced to roll out under pressure resulting in OUR MIMI (J Toeroek), which shifted in slightly, clipping the heels of VISUAL IMPACT (J Maund) and dipping. J Maund was reminded of his obligations when his mounts commence to shift ground.

OUR MIMI was examined by the Club's Veterinary Surgeon who reported the mare to be lame in near foreleg. Mr L Kennewell, the Trainer of OUR MIMI, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

## RACE 7 : FOX TUCKER LAWYERS HANDICAP - 1600 metres

SAVVY SMOKIN' (J Kah) shifted in on jumping away making heavy contact with CIRCLE OF TRUST (J Toeroek), which was hampered and lost its position.

CAPE CLEAR (S Price) jumped away awkwardly and shifted in onto FLASH MICK (J Holder).

Inside the 200 metres SIR GWYNN (M Pegus) had to be steadied momentarily when tightened onto the hindquarters of WARATONE (J Frew) by VON RADETZKY (S Westover), which shifted in. S Westover was reminded of his obligations when shifting ground in future.

DESIGNER lost its off fore plate during the event.

T Baker, the rider of NOTHING SHALL PASS, explained the gelding did not show its customary speed in the early stages and was unable to take up a position near the lead as it had in recent starts. He added that NOTHING SHALL PASS had not travelled well during the event and when a run presented in the straight, the gelding was not going well enough to improve its position. NOTHING SHALL PASS was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

## RACE 8 : SPORTINGBET HANDICAP - 1100 metres

Mr W Smart, the Trainer of CUTE TO BOOT, advised Stewards he would instruct Jockey J Potter to let the mare relax in the early stages and attempt to obtain a position with cover due to the mare failing to finish off its races in recent starts when ridden close to the lead.

The start of this race was initially delayed approximately five minutes owing to SILVER SLIPPERS, which was reluctant to proceed to the start, being examined by the Club's Veterinary Surgeon on arrival at the barriers. SILVER SLIPPERS was ruled fit to start.

The start was further delayed owing to CUTE TO BOOT requiring resaddling on arrival at the barriers and ANYTHINGTHATMOVES, which was fractious in the barriers, being examined by the Club's Veterinary Surgeon. ANYTHINGTHATMOVES was ruled fit to start.

ROSE OF LINCOLN (M Neilson) jumped away awkwardly.

# RACE 8 : SPORTINGBET HANDICAP - 1100 metres (continued)

YOU DEE CEE (J Duffy) jumped awkwardly, shifted out and brushed MOSSGIEL VILLAGE (S Price).

ANYTHINGTHATMOVES (B Claridge), MOSSGIEL VILLAGE (S Price) and MISTY EYES (J Toeroek) raced wide without cover throughout the event.

MISTY EYES (J Toeroek) made the home turn awkwardly and shifted out, inconveniencing ANYTHINGTHATMOVES (B Claridge).

L Stojakovic, the rider of ALMIGHTY BULLET, reported the gelding commenced to lay in from the vicinity of the home turn. ALMIGHTY BULLET was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

M Pegus, the rider of SILVER SLIPPERS, explained the gelding had travelled well in the early stages of the event, however, upon straightening, failed to respond to his riding and in his opinion had finished the race off poorly. On pulling up SILVER SLIPPERS collapsed and was deceased when the Club's Veterinary Surgeon arrived. The Veterinary Surgeon reported the gelding had signs that the aorta had ruptured.

GONSKI GIRL, which performed poorly, was examined by the Club's Veterinary Surgeon who reported the mare to be lame in the off hind leg. Mr C Curtis, the Trainer of GONSKI GIRL, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

MOSSGIEL VILLAGE, which performed poorly, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.
