Report on Race Meeting held at the Naracoorte Racecourse by the Naracoorte Racing Club on Sunday, 21 October 2012

RACE 1 : BILLY MACS RATING 60 & OVER HANDICAP - 1430 metres

The start of this race was delayed approximately three minutes owing to the late arrival of the Ambulance on course.

FRAACLASE, which was fractious in the barriers, was examined by the Club's Veterinary Surgeon and ruled fit to start.

OUR SHANAGOLDEN (A. Herrmann) was slow to begin.

OUR SHANAGOLDEN (A. Herrmann) was inclined to race ungenerously in the early and middle stages of the event.

Racing to the 900 metres FRAACLASE (K. Walters), which was racing ungenerously, had to momentarily steady away from the heels of FEELING INVINCIBLE (P. Marks).

RACE 2 : PATRONS / SABOIS MAIDEN PLATE - 1000 metres

Mr. D. Kolpin, representing Mr. M. O'Leary, the Trainer of DUBAI ME PEARLS, was questioned regarding the reason he had presented this mare with blinkers, which were not part of the mare's approved gear list. After considering Mr. Kolpin's explanation, Mr M. O'leary was reprimanded under ARR 140B(3).

KELJETT, which was kicked by another runner on arrival at the barriers, was examined by the Club's Veterinary Surgeon who ruled the gelding fit to race.

SANDHILL BOSS (C. Lever) proved difficult to load. Mr. S. Turner, the Trainer of SANDHILL BOSS, was advised an official warning had been placed on the gelding, which would be required to be approved to race by performing satisfactorily in a jump out or official trial prior to accepting for a future race.

SHADOW LAND (J. Toeroek) stood flat-footed and as a result was very slow to begin. Mr. P. Stennett, the Trainer of SHADOW LAND, was advised the mare would be required to perform satisfactorily in an Official Barrier Trial prior to accepting for a future race.

ROCHIRL (B. Claridge) jumped away awkwardly and shifted out bumping SMOOTH EXCELERATOR (D. Tootell), which shifted out, inconveniencing KELJETT (K. Post) and ROCKET BROTHER (A. Patterson).

RACE 2: PATRONS / SABOIS MAIDEN PLATE - 1000 metres (Cont'd)

CLASS BEATS (P. Marks) was inclined to lay out throughout the event. CLASS BEATS was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

On the home turn CLASS BEATS (P. Marks), which was continuing to hang out, shifted out, inconveniencing WHATWASITHINKING (A. Herrmann), which rolled out and took ROCKET BROTHER (A. Patterson) wider on the track.

RACE 3: BUSHMAN'S ARMS HOTEL RATING 0-61 HANDICAP - 2000 metres

KOBAN (J. Kah), which was fractious in the barriers and reared when the start was effected, was very slow to begin.

Correct Weight for this event was delayed to allow the Stewards, in consultation with the Official Starter, and J. Kah, the rider of KOBAN, to consider whether KOBAN would be deemed a starter. Stewards were of the opinion the actions of the gelding were its own and as a result it was declared a runner. Mr. C. Oxlade, the Trainer of KOBAN, was advised the gelding would be required to perform satisfactorily in an Official Barrier Trial prior to accepting for a future race.

RACE 4 : COOPERS / SABOIS MAIDEN PLATE - 1430 metres

HALOS LITTLE HUSSY (C. Ellis) was slow into stride.

OFF THE MAP (S. Harrison) was inclined to pull hard in the early and middle stages.

FIERCE STORM (W. Kerford) raced without cover throughout.

In the vicinity of the 100 metres RANDOM VALUE (D. Tourneur) shifted out to improve, resulting in SNEGUROCHKA (P. Marks) being taken wider on the track.

RACE 5: COOPERS RATING 0-61 HANDICAP - 1000 metres

On arrival on course ROYAL KELLY was examined by the Club's Veterinary Surgeon who reported the mare had a laceration to its wither and was ruled unfit. Acting on that advice, Stewards withdrew ROYAL KELLY at 1.45 pm.

NORTHERN GEM was a late scratching at 2.47 pm due to the track upgrade.

SPIRITOFTHESTORM (B. Carlile) jumped away awkwardly.

GENARKA STAR (C. Ellis) was inclined to lay out throughout the event.

RACE 6: LUCINDALE HOTEL RATING 0-65 HANDICAP - 1200 metres

EARS HENERY was a late scratching at 2.16 pm and OLYMPIC JOY was a late scratching at 3.34 pm due to the track upgrade.

On arrival at the barriers ICONSEEFRAARAWAY was examined by the Club's Veterinary Surgeon when its rider B. Claridge had concerns with the gelding's action. ICONSEEFRAARAWAY was ruled fit to start.

LAND CRUISER (W. Kerford) and GOD'S SECRET (K. Walters) raced wide without cover throughout the event.

RACE 6: LUCINDALE HOTEL RATING 0-65 HANDICAP - 1200 metres (Cont'd)

In the vicinity of the 500 metres until approaching the home turn HARRY'S ON SONG (B. Carlile) was held up for clear running when on the heels of STRAIGHT AS (E. Boyd).

ICONSEEFRAARAWAY was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 7: KINCRAIG HOTEL CLASS 2 HANDICAP - 1430 metres

TONTO'S PRIDE (B. Claridge) was slow into stride.

PERFECT BEAU was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the near foreleg. Mr. B. Jones, the Trainer of PERFECT BEAU, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

AL MUNIA was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 7: KINCRAIG HOTEL CLASS 2 HANDICAP - 1430 metres

On Monday, 22 October 2012 Mr. J. Opperman, the Trainer of COSTLY ARGUMENT, reported to Stewards that on return to stable the gelding was exhibiting signs of having jarred up.

RACE 5 : COOPERS RATING 0-61 HANDICAP - 1000 metres

On Monday, 22 October 2012 Ms. L. Conlon, the Trainer of ODETTE, reported to Stewards that on return to stable the mare was exhibiting signs of having jarred up and would now be spelled.
