## RACE 1: JONES ELECTRICAL / SABOIS 3YO RATING 0-64 HANDICAP - 1000 metres

REDLEAF ROSE (K. Bishop) jumped away awkwardly and shifted out at the same time as THE HEADLINER (S. Price) jumped away awkwardly and shifted in, resulting in WHERE HEARTS LIE (T. Baker) being inconvenienced.

TIGARA'S GEM (A. Patterson) was inclined to race ungenerously in the early and middle stages of the event.

Racing to the 600 metres HANK'S NEPHEW (E. Boyd), which was racing ungenerously, had to momentarily steady away from the heels of TIGARA'S GEM (A. Patterson).

# RACE 2 : EYRE PENINSULA OWNERS & TRAINERS RATING 0-68 HANDICAP – 1000 metres

SON OF A GUN, which was fractious in the mounting yard and dislodged its rider J. Potter, was examined by the Club's Veterinary Surgeon who ruled the gelding fit to race. J. Potter was uninjured in the incident. Mr. R. King, the Trainer of SON OF A GUN, was advised a warning had been placed on the gelding's pre-race manners.

SON OF A GUN (J. Potter) jumped away awkwardly and as a result was slow to begin.

OUTLOOK EXPRESS (E. Brooks) and VENTIC (W. Kerford) jumped away awkwardly.

Racing to the 700 metres NO VACANCY (T. Zanker) was inclined to ungenerously.

Racing to the 500 metres NO VACANCY (T. Zanker), which was continuing to race ungenerously, had to momentarily steady when racing on the heels of OUTLOOK EXPRESS (E. Brooks).

KOODA WONDER and SON OF A GUN were examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

## RACE 3: FRANK GARVEY CRASH REPAIRS / SABOIS MAIDEN PLATE - 1250 metres

SPITTING IMAGE proved difficult to load.

PROPSHAFT (J. Potter) jumped away awkwardly, shifted in and brushed KALINGA LOCK (T. Baker).

SPITTING IMAGE (W. Kerford) was very slow to begin and tailed the field throughout.

Racing to the 1000 metres KALINGA LOCK (T. Baker) made the turn awkwardly and shifted out, inconveniencing SING THAT SONG (S. Price), CORONA GIRL (E. Boyd) and DEBEERSONUS (S. Cahill), which were all taken wider on the track.

PROPSHAFT (J. Potter) was inclined to lay out under pressure in the straight.

Correct Weight for this event was delayed to allow S. Cahill, the rider of the third placegetter, to view the official films.

Stewards questioned Ms. J. Branford, the Trainer of SPITTING IMAGE, with regard to the mare's poor performance and she could offer no explanation for its effort today. SPITTING IMAGE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities. Ms. Branford was advised the mare would be required to perform to the Stewards' satisfaction in an Official Barrier Trial prior to accepting for a future race with regard to it being difficult to load and also its poor performance.

## RACE 4 : REVOLUTION ROOFING / SABOIS FILLIES & MARES RATING 0-68 HANDICAP 1250 metres

Ms. A. Cornell, the Trainer of SAUCY WAVE, was fined \$50 under ARR.140B(3) for presenting the mare in incorrect gear.

PICTORELLA (A. Patterson) jumped away awkwardly and as a result was slow to begin.

FRAARBELLE (T. Baker) jumped away awkwardly.

### RACE 5: LEADER DISTRIBUTORS RATING 60 & OVER HANDICAP – 1200 metres

PIONEER PRINCE (C. Lever) jumped away awkwardly.

From the 800 metres to the 400 metres DIRE WARNING (E. Brooks) raced wide without cover.

### RACE 6: LINCOLN SOUTH CLUB INC RATING 0-61 HANDICAP - 1350 metres

Mr. S. Drewitt, the Trainer of VOLATION, was fined \$50 under ARR.140B(3) for presenting the gelding in incorrect gear.

HUNTED ANGEL (E. Brooks) and LOW CUT (W. Kerford) were slow to begin.

MONTALTO (S. Westover) jumped away awkwardly, shifted out and brushed LOW CUT (W. Kerford).

MEADOWS MAGIC (L. Hopwood) knuckled on jumping away.

Racing to the 1200 metres VOLATION (S. Cahill) had to momentarily steady when GOING STRONG (T. Baker) shifted in. T. Baker was reminded of his obligations when shifting ground.

## RACE 6: LINCOLN SOUTH CLUB INC RATING 0-61 HANDICAP - 1350 metres (Cont'd)

Racing to the 1100 metres SILKEN THREAD (K. Bishop) had to momentarily steady when DESTONY HAWK (E. Boyd) shifted in. E. Boyd was reminded of her obligations when shifting ground.

Approaching the 100 metres LOW CUT (W. Kerford) shifted out to improve to the outside of DESTONY HAWK (E. Boyd), resulting in HUNTED ANGEL (E. Brooks) being taken wider on the track and brushing SAREM (T. Zanker).

From the 100 metres MONTALTO (S. Westover) was held up for clear ground when racing tight inside GOING STRONG (T. Baker).

SILKEN THREAD (K. Bishop) was inclined to lay in, in the straight. SILKEN THREAD was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

## RACE 7 : YALUMBA COLTS, GELDINGS & ENTIRES RATING 0-61 HANDICAP – 1200 metres

ARTECHS (J. Potter) was slow into stride.

Approaching the 600 metres NORTHSIDE STAR (E. Boyd), which was racing keenly, contacted the rail on two occasions.

Racing to the 400 metres NORTHSIDE STAR (E. Boyd), which was racing tight inside ARTECHS (J. Potter), had to steady and lose its position when racing keenly.

Rounding the home turn NATURAL HERO (E. Brooks) shifted wider on the track to improve around MEMORY COVE (W. Kerford), resulting in NATURAL HERO and OUR DESTINATION (K. Bishop) bumping for a number of strides.
