RACE 1: ARMAGH FINANCIAL SERVICES MAIDEN PLATE - 1050 metres

HALF BACK FLANK, which struck the gate when leaving the mounting yard en route to the barriers, was examined by the Club's Veterinary Surgeon on arrival at the start and ruled fit to race.

ROCKIN DEVIL (J. Maund) jumped away awkwardly and shifted out, brushing BEL STREAK (L. Hopwood), which shifted out, inconveniencing HALF BACK FLANK (L. Stojakovic) and BRIDGE WORKER (J. Bowditch), which were taken wider on the track.

BARRIER BOYS (J. Potter) stepped a section of the track near the 700 metres.

Approaching the 600 metres BRIDGE WORKER (J. Bowditch) was inclined to lay out resulting in HALF BACK FLANK (L. Stojakovic) being inconvenienced when taken wider on the track.

BARRIER BOYS (J. Potter) stepped a section of the track near the 300 metres.

BEL STREAK (L. Hopwood) was inclined to lay in under pressure in the straight.

L. Hopwood, the rider of BEL STREAK, was questioned regarding her use of the whip prior to the 100 metres. L. Hopwood pleaded guilty to a charge under ARR.137A(5)(a)(ii) in that she used her whip in a forehand manner on more than five occasions prior to the 100 metres and was reprimanded.

SUNRISE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 2: ADVERTISER NEWSPAPERS CLASS 1 HANDICAP - 1200 metres

JEWEL OF CADENCE (L. Stojakovic) jumped away awkwardly.

RACE 2: ADVERTISER NEWSPAPERS CLASS 1 HANDICAP - 1200 metres (Cont'd)

KOODA DAWN (B. Claridge) was inclined to race ungenerously in the early and middle stages of the event.

DE SOUBA STAR (S. Westover) was inclined to lay in under pressure in the straight.

Approaching the winning post KOODA DAWN (B. Claridge) was inclined to lay in under pressure, resulting in ANYTHINGTHATMOVES (D. Stra) having to steady momentarily.

S. Westover, the rider of DE SOUBA STAR, explained the gelding was off the bridle from the 1000 metres to the 700 metres and from that point he believed DE SOUBA STAR showed signs of improving but after entering the straight and starting to lay in under pressure, he was of the opinion the gelding didn't let down. He stated he believed today's track condition may have been too firm for the gelding. DE SOUBA STAR was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 3: TAB / SABOIS 3YO MAIDEN PLATE - 1300 metres

The start of this race was delayed approximately two minutes owing to SECRETMENSBUSINESS proving difficult to load.

REBER (J. Potter) stumbled shortly after the start.

JACKS JOURNEY (J. Kah), TERRAPINNA (A. Herrmann) and BEV'S DREAM (J. Maund) all brushed on jumping away.

REWIND TIME (B. Claridge) jumped away awkwardly and shifted out, inconveniencing CUT TO THE CACHE (B. Hoppo).

MAGIC NIELLO (C. Lindop), which was racing keenly in the early and middle stages, had to restrain off heels.

FLYING CLUB (A. Patterson) was held up for clear running racing from the entrance to the straight until the 200 metres when racing inside of CUT TO THE CACHE (B. Hoppo) and on the heels of SECRETMENSBUSINESS (S. Price).

From the 400 metres to near the 200 metres SECRETMENSBUSINESS (S. Price) and REWIND TIME (B. Claridge), which were both racing ungenerously, bumped on several occasions.

Near the 200 metres SECRETMENSBUSINESS (S. Price), which continued to race ungenerously despite the efforts of its rider, shifted in, inconveniencing REWIND TIME (B. Claridge), which shifted in and away, resulting in GENEROUS BELLE (S. Westover) having to steady and lose its position. REWIND TIME was inclined to race ungenerously for the remainder of the event.

REWIND TIME and SECRETMENSBUSINESS were examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 4: JACOBS CREEK / SABOIS FILLIES & MARES MAIDEN PLATE – 1300 metres

KLONDIKE LIL (D. Tourneur) jumped away awkwardly and shifted in.

SCRAMOGUE (A. Patterson) jumped away awkwardly and shifted out, inconveniencing DASHA CHILLI (T. O'Donnell), ANGEL EYES (L. Stojakovic) and RUBY'S TUESDAY (L. Hopwood), which were all slow to begin as a result.

RACE 4 : JACOBS CREEK / SABOIS FILLIES & MARES MAIDEN PLATE - 1300 metres (Cont'd)

Racing near the 800 metres OUR RUBY (J. Holder), which was racing keenly, had to steady away from the heels of SAKS ADDICT (A. Herrmann), resulting in ILLYAKHA (K. Bishop), which was racing ungenerously, having to steady and as a result made contact with the rail on a number of occasions. ANGEL EYES (L. Stojakovic), which was racing on the heels of ILLYAKHA, had to momentarily steady.

RUBY'S TUESDAY was examined by the Club's Veterinary Surgeon who reported a laceration to the inside of the near fore knee. First Aid was administered.

RACE 5: WOODSTOCK BOURBON RATING 0-62 HANDICAP - 2200 metres

HONG KONG MISSY was examined by the Club's Veterinary Surgeon on arrival at the start when its rider B. Claridge was concerned with the mare's action. HONG KONG MISSY was found to have a shortened stride behind and ruled unfit to race. Acting on that advice, Stewards withdrew HONG KONG MISSY at 2.58 pm. Mrs. S. Ratsch, the Trainer of HONG KONG MISSY, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

HOLD THAT CONQUEST (A. Patterson) jumped away awkwardly.

From the 800 metres until the entrance to the straight BELL RINGER (J. Maund) was inclined to lay out.

BAKLAVA BOY (NZ) (C. Lindop) was inclined to lay out under pressure over the concluding stages.

BELL RINGER was examined by the Club's Veterinary Surgeon who reported a lower than expected heart rate.

RACE 6: COOPERS / SABOIS MAIDEN PLATE - 1400 metres

SWISS CHALET (C. Lindop), which was fractious in the barriers, was slow to begin.

GARNESH (M. Pegus) was slow into stride.

GARNESH (M. Pegus) made the turn at the 800 metres awkwardly.

At the entrance to the straight PRESTIGE GLEN (J. Maund) shifted out when attempting to improve to the outside of CASH JOB (D. Stra), which shifted out, making contact with MR DODD (A. Herrmann). Shortly after GONE WITHOUT (J. Bowditch), when shifting out to improve behind CASH JOB, made contact with PRESTIGE GLEN, resulting in PRESTIGE GLEN being unbalanced for a number of strides.

KATH'S SECRET (A. Patterson) was held up for clear running from rounding the home turn until near the 100 metres where he shifted out to obtain clear ground.

Approaching the 200 metres FLYTASTIC (S. Westover) was disappointed for a run when racing tight between SWISS CHALET (C. Lindop) and MR DODD (A. Herrmann).

D. Stra, the rider of CASH JOB, was questioned regarding her use of the whip prior to the 100 metres. D. Stra pleaded guilty to a charge under ARR.137A(5)(a)(i) in that she used her whip on consecutive strides prior to the 100 metres and was reprimanded. D. Stra also pleaded guilty to a charge under ARR.137A(5)(a)(ii) in that she used her whip in a forehand manner on more than five occasions prior to the 100 metres and was fined \$200.

RACE 7: MY BUTCHER CLASS 2 HANDICAP - 1600 metres

VON RADETZKY (S. Westover) jumped away awkwardly and shifted out at the same time as QUICK THOUGHTS (J. Bowditch) jumped away awkwardly and shifted in, resulting in LIMBO QUEEN (L. Stojakovic), which was racing between those horses, being buffeted for a short distance.

HALOS LITTLE HUSSY (J. Potter) was very slow to begin.

PRECINCT (J. Maund) raced wide in the middle stages.

At the entrance to the straight VON RADETZKY (S. Westover) was inclined to lay in.

S. Westover, the rider of VON RADETZKY, was questioned regarding his use of the whip prior to the 100 metres. S. Westover pleaded guilty to a charge under ARR.137A(5)(a)(ii) in that he used his whip in a forehand manner on more than five occasions prior to the 100 metres and was fined \$200.

RACE 8: ATLAS EVENT & PARTY HIRE RATING 0-62 HANDICAP - 1400 metres

LOTTALAGO (C. Lindop) and MUSTANG SCHILLER (D. Tourneur) were slow to begin.

On return to Scale S. Westover, the rider of SHADOW NINJA, reported he believed the gelding may have choked down. SHADOW NINJA was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

LOTTALAGO was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 5: LEXUS HANDICAP - 1400 metres

On Monday, 29 October 2012 Mr. L. Macdonald, the Co-Trainer of COMIC COMPOSER (NZ), which was found to be lame following this race, advised the gelding had been examined by the stable's Veterinary Surgeon who reported COMIC COMPOSER (NZ) had a fractured pelvis. Mr. Macdonald advised Stewards the gelding would now be retired.

RACE 8: TOYOTA MATERIAL HANDLING HANDICAP - 1250 metres

Mr. P. Stokes, the Trainer of ECLAIR RALLY (NZ), pleaded guilty to a charge under ARR.140A for failing to effect a gear change in respect of the gelding and was fined \$200.

RACE 7 : KINCRAIG HOTEL CLASS 2 HANDICAP - 1430 metres

Mr. B. Jones, the Trainer of PERFECT BEAU, advised that on return to stable the gelding was found to have fractured its near fore pedal bone and would now be retired.
