**RACE 1 : COMMERCIAL AIR THREE-YEAR-OLD COLTS AND GELDINGS MAIDEN**  
**PLATE - 1050 metres**

The start of this race was delayed approximately four minutes initially owing to SPOILSPOT, which made contact with the gate on leaving the mounting enclosure, having to be examined by the Club's Veterinary Surgeon who ruled the gelding fit to race and then owing to BRING DE BEERS becoming fractious and cast in its barrier stall. BRING DE BEERS was examined by the Club's Veterinary Surgeon who ruled the gelding fit to start. The start was also delayed when MR PURRFECT, which lost its near fore plate en route to the start, required Farrier attention and the tongue tie on SPOILSPOT having to be refitted. MR PURRFECT was examined by the Club's Veterinary Surgeon who ruled the gelding fit to race.

NIGHT BREEZE (M. Neilson) jumped away awkwardly, shifted out and was obliged to steady off the heels of KING VALENTINE (T. Baker).

BRING DE BEERS (S. Price) jumped away awkwardly, shifted out and brushed BERT DA FLYER (C. Lever).

MR PURRFECT (J. Holder) over-raced for some distance in the early stages of the event.

In the vicinity of the 200 metres MR PURRFECT (J. Holder) shifted in abruptly of its own accord resulting in J. Holder having to stop riding and straighten the gelding.

Inside the 100 metres MR PURRFECT (J. Holder) and BERT DA FLYER (C. Lever) both shifted ground and brushed for a short distance.

BRING DE BEERS was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

## **RACE 2 : PORT ADELAIDE FC MAIDEN PLATE - 1600 metres**

SURPRISE US (C. Lindop) jumped away awkwardly and shifted out, taking ROLLING STONES (J. Kah) wider.

MUGHAREEGA (K. Bishop) jumped away awkwardly, shifted out and brushed GONE WITHOUT (M. Neilson).

Shortly after the start RANDOM VALUE (J. Holder) shifted out and contacted PIERREMONT ROCKS (J. Maund), which was inconvenienced.

SMOKY DUBAI (A. Herrmann) raced keenly in the early stages of the event.

TREASURE SON (S. Westover) over-raced in the early and middle stages of the event.

GONE WITHOUT (M. Neilson) raced wide without cover from approximately the 700 metres.

In the vicinity of the 400 metres MUGHAREEGA (K. Bishop) raced in restricted room between GONE WITHOUT (M. Neilson) and ROLLING STONES (J. Kah) for a number of strides.

In the vicinity of the 350 metres TREASURE SON (S. Westover) rolled in and inconvenienced SUMMER WITH ROSIE (NZ) (T. Zanker).

J. Holder, the rider of RANDOM VALUE, was questioned regarding his use of the whip prior to the 100 metres. J. Holder pleaded guilty to a charge under ARR.137A(5)(a)(ii) in that he used his whip in a forehand manner on more than five occasions prior to the 100 metres and was reprimanded.

ROLLING STONES was examined by the Club's Veterinary Surgeon who reported the gelding to be ataxic and showing signs of heat stress. First Aid was administered.

## **RACE 3 : ANGELAKIS BROTHERS SEAFOOD 3YO FILLIES MAIDEN PLATE - 1050 metres**

The start of this race was delayed approximately four minutes owing to LIFE IN A METRO proving very difficult to load and AUGÉ, which became cast in the barriers after being loaded, being examined by the Club's Veterinary Surgeon who reported the filly to be lame in the near hind leg. Acting on that advice, Stewards withdrew AUGÉ at 12.55 pm. First Aid was administered.

LIFE IN A METRO (M. Pegus) jumped away awkwardly, shifted in and contacted BLACK POINT (A. Herrmann), which was tightened onto BRIMARVI DUE FACE (J. Maund), resulting in both horses being inconvenienced.

In the vicinity of the 800 metres LIFE IN A METRO (M. Pegus) shifted in taking OKAY OH YAY (S. Westover) in, which was inconvenienced. As a consequence GENIALITY (S. Price), which was following, was hampered.

Inside the 800 metres MOLLIE MAE (L. Stojakovic) rolled out and inconvenienced JEST A JILLY (C. Lever), which was inclined to lay in.

Approaching the 200 metres LAST PARDEE (J. Holder) shifted in under riding tightening LIFE IN A METRO (M. Pegus) onto BLACK POINT (A. Herrmann), resulting in LIFE IN A METRO racing in restricted room for a number of strides.

**RACE 3 : ANGELAKIS BROTHERS SEAFOOD 3YO FILLIES MAIDEN PLATE - 1050 metres (Cont'd)**

JEST A JILLY (C. Lever) laid in severely in the straight. JEST A JILLY was examined by the Club's Veterinary Surgeon who reported an abrasion to the near side of the filly's mouth.

S. Westover, the rider of OKAY OH YAY, reported the filly felt short in its action over the concluding stages of the race. OKAY OH YAY was examined by the Club's Veterinary Surgeon who reported lacerations to the off hind cannon and the near hind coronet. First Aid was administered.

**RACE 4 : ADELAIDE BMW MAIDEN PLATE - 1200 metres**

RED PEPPER, which hit its head in the race day stalls and had blood in both nostrils, was examined by the Club's Veterinary Surgeon who ruled the filly unfit. Acting on that advice, Stewards withdrew RED PEPPER at 12.25 pm.

REACHFAR (A. Herrmann) jumped away awkwardly.

Approaching the 200 metres SET TO EXCITE (S. Price), which was weakening, rolled in and inconvenienced SECURITY INDEX (T. Baker).

Inside the 200 metres SECURITY INDEX (T. Baker) shifted out to gain clear running and inconvenienced SET TO EXCITE (S. Price), which was weakening, resulting in SET TO EXCITE having to be steadied. Shortly thereafter, approaching the 100 metres, SECURITY INDEX continued to shift out, brushing with GUN RULE (J. Potter), taking that colt out onto POWER BUTTON (C. Lever), resulting in both horses being taken off their course for a number of strides and being inconvenienced. T. Baker was severely reprimanded and advised to take greater care when shifting ground in future.

M. Neilson, the rider of SOOKIE STACKHOUSE, explained the mare had every opportunity on straightening but failed to respond in the manner he expected and was disappointing. SOOKIE STACKHOUSE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

SET TO EXCITE lost its off fore plate during the race.

**RACE 5 : GEORGIU FINANCIAL SERVICES TROPHY - 2500 metres**

The start of this race was delayed approximately one minute owing to HOLD THAT CONQUEST, which was fractious in the barriers and hit its head, being examined by the Club's Veterinary Surgeon and ruled fit to race.

TSARINA WONDER (C. Lindop) jumped away awkwardly.

HONG KONG MISSY (J. Holder) was unable to gain clear ground when racing behind HOLD THAT CONQUEST (L. Stojakovic) and inside the heels of UMALUKA (C. Lever) from approximately the 500 metres to the 300 metres and thereafter, inside the 100 metres, was again unable to obtain clear running when racing between the heels of SPARKLING VICTORY (S. Price) and HOLD THAT CONQUEST and was untested to the line.

UMALUKA (C. Lever) laid in from the 300 metres.

L. Stojakovic, the rider of HOLD THAT CONQUEST, reported the gelding felt short in its action on return to Scale. HOLD THAT CONQUEST was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the off foreleg. Mrs. M. Ruberry, the Trainer of HOLD THAT CONQUEST, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

## **RACE 5 : GEORGIU FINANCIAL SERVICES TROPHY - 2500 metres (Cont'd)**

STURGIS (NZ) was examined by the Club's Veterinary Surgeon who reported a lower than expected heart rate.

FAINEANT and HONG KONG MISSY were examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

## **RACE 6 : GAUCHO'S RESTAURANT HANDICAP - 1200 metres**

On arrival at the barriers, T. Baker, the rider of AMBITIOUS BRIDE, reported he was concerned with the mare's action. AMBITIOUS BRIDE was examined by the Club's Veterinary Surgeon who ruled the mare fit to race.

TABULATED (S. Westover) jumped away awkwardly and shifted in, tightening BOWERBIRD (S. Price) onto GLENARIFF (A. Herrmann).

BOWERBIRD (S. Price) over-raced in the early stages of the event.

In the vicinity of the 900 metres LADY LIGHTFOOT (J. Holder) shifted in onto BOWERBIRD (S. Price), which was obliged to be steadied off the heels of LADY LIGHTFOOT and then became awkward on the heels of GLENARIFF (A. Herrmann) as that mare shifted out to improve to the outside of VISUAL IMPACT (J. Maund). J. Holder was reprimanded and advised to take greater care when shifting ground in future.

In the vicinity of the 700 metres LADY LIGHTFOOT (J. Holder) shifted out and inconvenienced CUTE TO BOOT (J. Potter).

Inside the 100 metres ILSEDE (J. Kah) shifted in and away from LADY LIGHTFOOT (J. Holder), which rolled in slightly, resulting in TABULATED (S. Westover), which had improved to the inside of ILSEDE, being inconvenienced.

A. Herrmann, the rider of GLENARIFF, was questioned regarding the use of her whip in the straight. A. Herrmann pleaded guilty to a charge under ARR.137A(3) in that she used her whip in an excessive manner and was reprimanded.

AMBITIOUS BRIDE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

## **RACE 7 : THE WASH CAFE HANDICAP - 1050 metres**

THREE STAR GENERAL (S. Price) jumped away awkwardly, shifted out and inconvenienced ZAEIMUS (S. Westover).

REAL SHARP (J. Potter) was inclined to lay out throughout the event, made the home turn awkwardly and shifted wider on the track.

In the vicinity of the 150 metres READY TO REEL (M. Pegasus) was disappointed for clear running when racing inside the heels of FIRE INTO ACTION (K. Bishop) and behind TESTANOVA (J. Holder) and approaching the 100 metres shifted in to obtain clear ground and contacted COLLA VOCE (L. Hopwood), which was forced to race in restricted room between READY TO REEL and on the heels of BELLE'S REWARD (J. Kah). As a consequence, these horses came together, became unbalanced and thereafter, over the concluding stages, COLLA VOCE rolled out and brushed READY TO REEL.

**RACE 7 : THE WASH CAFE HANDICAP - 1050 metres (Cont'd)**

ZAEIMUS lost its off fore plate and TESTANOVA lost its near hind plate during the event.

READY TO REEL was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

**RACE 8 : GFRESH SEASONINGS HANDICAP - 1200 metres**

Ms. P. Trenwith, the Trainer of DEFONET, advised Stewards she would instruct Jockey C. Lindop to attempt to ride the gelding from a position back in the field, if possible, to allow it to finish the race off strongly.

RISKY BLONDE (J. Kah) knuckled on jumping away.

RIVIERA QUEEN (J. Holder) shifted in shortly after the start tightening HEURIGER (T. Baker) onto UNDER THE RADAR (A. Herrmann).

UNDER THE RADAR (A. Herrmann), DEFONET (C. Lindop) and HEURIGER (T. Baker) raced keenly in the early stages of the event.

S. Westover, the rider of GRAND GROUP, was questioned regarding his use of the whip prior to the 100 metres. It was noted that S. Westover used his whip on two occasions in excess of the number of times permitted. After considering his explanation and taking into account he was accidentally struck on several occasions by the whip of A. Herrmann, the rider of UNDER THE RADAR, between the 300 metres and 100 metres, Stewards took no further action.

Correct Weight for this event was initially delayed to permit H. McKechnie, the rider of the third placegetter MOUNT MEE UP, to view the official photo for second and further delayed to allow the Stewards to view the image. After conferring with the Judges and considering their reasoning in determining the margin between the second and third placegetters, Stewards declared Correct Weight.

THE PRINCESS was examined by the Club's Veterinary Surgeon who reported a superficial laceration to the off foreleg. First Aid was administered.

**RACE 9 : PRO PAINT 'N PANEL HANDICAP - 1800 metres**

BELLA DOLCE (J. Potter) jumped away awkwardly and shifted out abruptly.

On jumping away LITTLE ADAM (L. Stojakovic) became tightened between CLANGIN' ABOUT (S. Cahill) and TRISTACAT (J. Holder), which both shifted ground and thereafter CATON (K. Bishop) shifted out and contacted CLANGIN' ABOUT, which was tightened onto LITTLE ADAM, which was taken out onto TRISTACAT, resulting in LITTLE ADAM and TRISTACAT becoming severely unbalanced.

ST GABRIEL (C. Lever) raced wide without cover in the early stages of the event.

Racing to the 400 metres LITTLE ADAM (L. Stojakovic) shifted out and brushed KISACHI (C. Lindop), which was obliged to steady.

For some distance in the vicinity of the 400 metres CATON (K. Bishop) was inconvenienced when racing on the heels of CLANGIN' ABOUT (S. Cahill), which was weakening.
