Report on Race Meeting held at the Port Lincoln Racecourse

RACE 1 : ROWETT ENGINEERING & STEEL FABRICATION PTY LTD - 1000 metres

ZIADIE (L. Hopwood) was inclined to race keenly in the early and middle stages of the race.

Rounding the home turn OUR DESTINATION (K. Bishop) was held up for clear ground when racing on the heels of ZIADIE (L. Hopwood) and LYNSHEE (T. Zanker).

Approaching the 150 metres OUR DESTINATION (K. Bishop), when attempting to improve to the outside of LYNSHEE (T. Zanker), brushed EXCEL WITH PRIDE (P. Roff).

Racing at the 50 metres OUR DESTINATION (K. Bishop) was momentarily inconvenienced when racing tight between LYNSHEE (T. Zanker), which rolled out marginally under pressure, and EXCEL WITH PRIDE (P. Roff), which rolled in marginally under pressure.

RACE 2 : PURCELL RATING 0-64 HANDICAP 1750 metres

SILKEN THREAD (A. Patterson) and LOW CUT (W. Kerford) were slow to begin.

SAREM (L. Hopwood) jumped away awkwardly.

MONTALTO (P. Roff) was inclined to hang out throughout the event.

Racing to the 1400 metres SAREM (L. Hopwood), which was inclined to lay out, shifted out, brushing IMAGINARIUM (K. Bishop), which, as a result, shifted wider on the track, making heavy contact with MONTALTO (P. Roff).

At the 1300 metres SILKEN THREAD (A. Patterson) was inclined to race ungenerously.

Racing to the 1250 metres LOW CUT (W. Kerford), which was racing keenly, had to steady away from the heels of MONTALTO (P. Roff).

From the 400 metres to the 300 metres SAREM (L. Hopwood) was held up for clear ground on the heels of IMAGINARIUM (K. Bishop).

MONTALTO was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 3 : NATIONAL JOCKEYS TRUST RATING 60+ HANDICAP - 1350 metres

SHIMANO MISS (NZ) (C. Lever) was slow to begin.

DIRE WARNING (E. Brooks) was inclined to race ungenerously in the early and middle stages of the event.

Racing from the 400 meters DIRE WARNING (E. Brooks) was inclined to lay in under pressure.

BLACK BARRA was examined by the Club's Veterinary Surgeon who reported the gelding had suffered a bi-lateral bleeding attack. Ms. A. Morrison, the Trainer of BLACK BARRA, was advised the gelding was suspended from racing for a period of three months in accordance with ARR.53A.

RACE 4 : GEORGE DAWSON MEMORIAL / SABOIS MAIDEN PLATE - 1350 metres

CENTRE RIPPLE (L. Stojakovic) was slow into stride.

CORONA GIRL (P. Roff) was inclined to race ungenerously in the early and middle stages of the event.

RACE 5 : PORT LINCOLN HOTEL / SABOIS 3YO RATING 0-64 HANDICAP - 1200 metres

MASTERDOM (K. Bishop) was slow to begin.

RIFF RAFF (P. Roff) and DANCES WITH SPURS (L. Hopwood) brushed on jumping away.

Racing to the 600 metres PROPSHAFT (J. Potter), when racing keenly, had to momentarily steady away from the heels of FORESHORE MAK (W. Kerford).

Racing from the 400 metres to the 300 metres DANCES WITH SPURS (L. Hopwood) made contact with the running rail on two occasions.

Approaching the 100 metres HANK'S NEPHEW (E. Boyd) and DEBEERSONUS (S. Cahill) brushed.

DANCES WITH SPURS and MASTERDOM were examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

Mr. R. Atkinson, the Trainer of MASTERDOM, was questioned regarding the gelding's poor performance. A warning was issued on this occasion.

RACE 6 : INDEPENDENT DISTILLERS / SABOIS MAIDEN PLATE - 1000 metres

On arrival on course MUMAJET, which had caught its rug strap around the near hind leg in its stable was examined by the Club's Veterinary Surgeon and ruled fit to race.

The start of this race was delayed approximately two minutes owing to BAVARIAN PLUME proving reluctant to proceed to the barriers and after arriving at the start having to have its tongue tie adjusted. BAVARIAN PLUME then proved difficult to load.

BAVARIAN PLUME (S. Cahill) stood flat-footed and as a result was very slow to begin.

MUMAJET (A. Patterson) knuckled on jumping away.

RACE 6 : INDEPENDENT DISTILLERS / SABOIS MAIDEN PLATE - 1000 metres (Cont'd)

TAJA MISS (E. Brooks) jumped away awkwardly and shifted in, brushing MUMAJET (A. Patterson).

BAVARIAN PLUME was examined by the Club's Veterinary Surgeon who reported a small bleeding wound on the top of the tongue. Ms. A. Cornell, the Trainer of BAVARIAN PLUME, was questioned regarding the mare's pre-race manners and performance in today's event. Ms. Cornell was advised the mare must complete a satisfactory Barrier Trial prior to accepting for a future race.

ANGEL'S SONG, which appeared uncoordinated on return to the mounting yard, reared and fell over and was examined by the Club's Veterinary Surgeon who reported the filly displayed signs of being ataxic. Ms. S. Williams, the Trainer of ANGEL'S SONG, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

RACE 7 : E P ASBESTOS RATING 0-68 HANDICAP - 1200 metres

PRIMAL INSTINCT (P. Roff) reared on jumping away and as a result was slow to begin.

MASTER PICKLES (C. Lever) raced ungenerously in the early and middle stages of the event.

FRENCH ACADEMY (E. Boyd) raced wide without cover throughout the event.

RACE 8 : PURE BLONDE RATING 0-61 HANDICAP - 1350 metres

ARTECHS, which took charge of its rider en route to the start, was examined by the Club's Veterinary Surgeon and ruled fit to race.

E. Boyd, the rider of DESTONY HAWK, was dislodged from the mare en route to the barriers when the mare proved fractious. DESTONY HAWK galloped a distance before being recaptured. DESTONY HAWK was examined by the Club's Veterinary Surgeon and ruled fit to race. E. Boyd was uninjured in the incident. Ms. J. Branford, the Trainer of DESTONY HAWK, was advised a warning has been placed on the mare.

DESTONY HAWK (E. Boyd) and MEADOWS MAGIC (W. Kerford) brushed on jumping away.

Racing at the 1100 metres WAIKIKI GIRL (L. Stojakovic) and HUNTED ANGEL (E. Brooks) bumped on several occasions.

Racing at the 300 metres VOLATION (S. Cahill) shifted in under pressure and as a result DANZEROUND THE SUN (K. Bishop), which was racing to the inside, was momentarily inconvenienced, resulting in DESTONY HAWK (E. Boyd), which was racing on the fence, having to momentarily steady.

ARTECHS was examined by the Club's Veterinary Surgeon who reported a probable soft palate displacement. Ms. J. Branford, the Trainer of ARTECHS, was advised a Veterinary Certificate of Fitness including the results of an endoscopic examination would be required prior to presenting for a trial or race.
