RACE 1 : SAFRIES PTY LTD / S & S LOGISTICS / SABOIS MAIDEN PLATE - 1400 metres

JOHNITA (L. Stojakovic) jumped away awkwardly and shifted out, contacting MOST AWESOME (A. Patterson), resulting in JOHNITA becoming unbalanced.

MOST AWESOME (A. Patterson) raced three wide without cover throughout the event.

ACQUIDINI, which performed poorly, was examined by the Club's Veterinary Surgeon who reported the filly to be lame in the near foreleg. Co-Trainers Mr. L. Macdonald and Mr. A. Gluyas were advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

RACE 2 : COOPERS BREWERY KALANGADOO CUP - 1700 metres

MISS BALL (L. Stojakovic) stood flat-footed and was slow to begin.

RACE 3 : GAMBIER EARTH MOVERS RATING 0-59 HANDICAP - 1300 metres

HIGHLY EXPLOSIVE (T. Pannell) shifted in on jumping away, inconveniencing MIAMI INK (J. Potter), which was tightened onto ARAZI SEA (C. Ellis).

COSTLY ARGUMENT (D. Tourneur) raced keenly in the early stages of the event whilst being restrained.

BROMS EXPRESS (A. Patterson) was held up from the vicinity of the 500 metres until the entrance to the straight when awkwardly placed between the heels of ON THE TRAIL (J. Matthews) and HIGHLY EXPLOSIVE (T. Pannell).

BROMS EXPRESS (A. Patterson) was inclined to lay in under pressure in the straight at the same time as MIAMI INK (J. Potter) rolled out, resulting in BROMS EXPRESS having to be momentarily steadied on a couple of occasions.

PRACTICE BID, which performed poorly, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 4 : JOANNE'S EXPRESSO EXPRESS / SABOIS MAIDEN PLATE – 1100 metres

ELINES (A. Patterson) was slow to begin.

MR DOUGHBOY (D. Tourneur) made the home turn awkwardly and shifted out inconveniencing WHATWASITHINKING (J. Potter), which was taken wider on the track.

MR DOUGHBOY (D. Tourneur) laid out under pressure in the straight, inconveniencing WHATWASITHINKING, which was taken wider.

RACE 5 : PINKERTON, PALM, HAMLYN & STEEN RATING 0-65 HANDICAP – 1700 metres

WAIT FORETTE (A. Patterson) jumped away awkwardly and shifted out making heavy contact with MUSEE D'MODEL (D. Tourneur).

BELMONT PARK (J. Kah) was slow to begin.

TONTO'S PRIDE (B. Claridge) was slow into stride.

MUSEE D'MODEL (D. Tourneur) was momentarily held up rounding the home turn when racing on the heels of VICSON (K. Walters) and inside TONTO'S PRIDE (B. Claridge).

MY WAY and LIMBO QUEEN, which both performed below expectations, were examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 6 : BARRY MANEY FORD RATING 60 & OVER HANDICAP - 1300 metres

Acting on confirmed advice from Mr. C. Oxlade, the Trainer of TANQUERAY LADY, that the mare had scrambled in the float en route to the course and would be unfit to race, Stewards withdrew TANQUERAY LADY at 3.05 pm.

OLYMPIC JOY (S. Harrison) jumped away awkwardly.

HAVANOTHERONE (B. Claridge) raced wide without cover throughout the event.

SEASON OF FORTUNE (A. Patterson) laid in under pressure in the straight.

D. Tourneur, the rider of IN THE CHAIR, which performed below expectations, reported the gelding was inclined to change legs throughout the event and had not felt comfortable in its action. IN THE CHAIR was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 7 : THOMAS, DEGARIS & CLARKSON RATING 0-65 HANDICAP – 1100 metres

MOON AURA scrambled in its race day stall after arriving on course. MOON AURA was examined by the Club's Veterinary Surgeon who reported multiple skin abrasions and ruled the mare unfit to race. Acting on that advice, Stewards withdrew MOON AURA at 3.15 pm.

HASTA LA SHAMER (P. Marks) jumped away awkwardly and was slow to begin.

EARS HENERY (J. Kah) raced wide without cover throughout the event.

At the entrance to the straight SANDHILL JETT (D. Tourneur) was held up for a short distance when racing on the heels of NAUGHTY MOMENTS (A. Patterson) and inside HASTA LA SHAMER (P. Marks) and had to alter course to the outside of HASTA LA SHAMER to obtain clear ground.

HASTA LA SHAMER (P. Marks) rolled in and brushed NAUGHTY MOMENTS (A. Patterson) in the vicinity of the 200 metres.
