## RACE 1 : PHILMAC / SABOIS 3YO MAIDEN PLATE - 1200 metres

SECRETMENSBUSINESS (S. Price) jumped away awkwardly and shifted out, inconveniencing FAMOUS FIGHTER (S. Cahill).

LASTING IMAGE (M. Pegus) jumped away awkwardly.

APALA (K. Bishop) jumped away awkwardly and shifted out at the same time as MAGIC NIELLO (C. Lindop) jumped away awkwardly and shifted in, resulting in BRIDGE WORKER (J. Bowditch) being inconvenienced.

Shortly after the start MAGIC NIELLO (C. Lindop) was inconvenienced when racing in tight room between GOD'S CHILD (J. Maund) and BRIDGE WORKER (J. Bowditch).

MAGIC NIELLO (C. Lindop) was inclined to race ungenerously in the early and middle stages.

Inside the 600 metres SECRETMENSBUSINESS (S. Price), when racing ungenerously on the heels of LASTING IMAGE (M. Pegus), shifted out making contact with GOD'S CHILD (J. Maund). As a result FAMOUS FIGHTER (S. Cahill) and APALA (K. Bishop), which were trailing, had to steady and lose their positions.

Racing to the 300 metres FAMOUS FIGHTER (S. Cahill) shifted out to improve to the outside of GOD'S CHILD (J. Maund), resulting in FAMOUS FIGHTER and MAGIC NIELLO (C. Lindop) making heavy contact.

BRIDGE WORKER was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

GOD'S CHILD lost its near fore and off hind plates during the event.

#### RACE 2 : ORANGE PUMPS MAIDEN PLATE - 1400 metres

CUT TO THE CACHE was withdrawn by Stewards at 11.41 am when it was established that the filly had not been presented on course.

### RACE 2: ORANGE PUMPS MAIDEN PLATE - 1400 metres (Cont'd)

QUICK SINGLE (D. Tourneur) jumped away awkwardly.

CLONMEL MAGIC (S. Cahill) and MADAM KAFOOPS (L. Stojakovic) were both slow to begin.

MEADOWS MACKS (J. Bowditch) was inclined to race keenly in the early and middle stages.

MADAM KAFOOPS (L. Stojakovic) laid out under pressure in the straight. MADAM KAFOOPS was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

CLONMEL MAGIC was examined by the Club's Veterinary Surgeon who reported atrial fibrillation. Mr. J. Smith, the Trainer of CLONMEL MAGIC, was advised the results of an ECG are to be forwarded to the Club's Veterinary Surgeon prior to the gelding performing to the satisfaction of the Stewards in an Official Barrier Trial and a Certificate of Fitness would be required prior to presenting for a future trial.

#### RACE 3: NETA / SABOIS MAIDEN PLATE - 900 metres

JUST A SPARK (J. Maund) jumped away awkwardly and shifted in, brushing FINLEY PIG (M. Neilson).

SUNRISE (T. Baker) jumped away awkwardly.

FINLEY PIG (M. Neilson) hung out rounding the home turn and was inclined to race greenly in the straight.

VIBKA was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

#### RACE 4: MITAVITE / SABOIS MAIDEN PLATE - 1600 metres

The start of this race was delayed approximately six minutes when SWISS CHALET reared and became cast in the barriers. SWISS CHALET was examined by the Club's Veterinary Surgeon who ruled the gelding unfit to race. Acting on that advice, Stewards withdrew SWISS CHALET at 2.26 pm. Ms. K. Byrnes, the Trainer of SWISS CHALET, was advised the gelding would be required to perform to the Stewards' satisfaction in an Official Barrier Trial prior to accepting for a future race.

The start of this race was also delayed owing to BORDEAUX MOMENTO proving difficult to load. Stewards withdrew BORDEAUX MOMENTO at 2.28 pm. Mr. T. McEvoy, the Trainer of BORDEAUX MOMENTO, was advised the filly would have to present at either an Official Barrier Trial or an Official Jump Out to gain approval to race.

Racing to the 1200 metres ROSCREA ROSE (S. Cahill) had to momentarily steady when MR DODD (A. Herrmann) shifted in. Shortly after MR DODD, which was continuing to shift in, momentarily inconvenienced ROLLING STONES (J. Kah). A. Herrmann was reminded of her obligations when shifting ground.

From the 300 metres to the 200 metres PAINTED CLOUD (K. Walters) was held up when racing on the heels of GARNESH (M. Pegus) and when tight to the inside of MR DODD (A. Herrmann).

SAKS ADDICT lost its near hind plate during the event.

### RACE 5: MAGILL GRAIN CLASS 1 HANDICAP - 1400 metres

The start of this race was delayed approximately two minutes when SCRAMOGUE was presented to race without blinkers. Mr. S. Casey, the Trainer of SCRAMOGUE, was fined \$100 under ARR.140A in that he presented the mare without the approved gear. On arrival at the barriers SCRAMOGUE was fitted with blinkers.

Shortly after the start BESA BOLA (M. Neilson) shifted out and bumped QUICK THOUGHTS (J. Kah), which, as a result, rolled out and made heavy contact with LOTTALAGO (D. Tourneur).

Approaching the 1000 metres SCRAMOGUE (S. Price) appeared to knuckle for no apparent reason.

PRESTIGE GLEN (J. Maund) laid in under pressure in the straight. PRESTIGE GLEN was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

SHADOW NINJA (M. Pegus) was inclined to race greenly in the straight.

SCRAMOGUE was examined by the Club's Veterinary Surgeon who reported the mare had sprung the toe clip from its off fore plate otherwise no visible abnormalities.

## RACE 6: AIRR RATING 0-68 HANDICAP - 2200 metres

FASTIZIO (D. Tourneur) and AFRISKY BUSINESS (T. Zanker) jumped away awkwardly.

UMALUKA (C. Lever) was inclined to race greenly throughout the event.

UMALUKA was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

ANDRONICA, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

## RACE 7 : DAISH IRRIGATION & FODDER RATING 0-71 HANDICAP - 900 metres

The start of this race was delayed approximately four minutes when PIGALLE, which was fractious in the barriers, being examined by the Club's Veterinary Surgeon who ruled the gelding unfit to race. PIGALLE was withdrawn by Stewards at 4.20 pm. Jockey G. Davis, who was dislodged in the incident, was examined by the on-course Ambulance personnel. G. Davis was advised he is to produce a Medical Certificate of Fitness before riding again.

AL'S AWAY (T. Pannell) jumped away awkwardly.

REAL FANTASY (C. Lindop) jumped away awkwardly and shifted out, bumping BLUZAR (S. Cahill).

STRIDING SUCCESS (D. Stra) laid in, in the straight resulting in D. Stra being unable to fully test her mount. STRIDING SUCCESS which laid in, in the straight, left the course prior to being examined by the Club's Veterinary Surgeon. Mr. T. Dansie, the Trainer of STRIDING SUCCESS, was advised to report any condition that may become apparent to Stewards as soon as practicable in accordance with ARR.140(c).

Inside the 50 metres AL'S AWAY (T. Pannell) rolled out under pressure resulting in STELLA JEUNE (J. Toeroek) having to momentarily steady.

LET GO JOHNNY and BLUZAR were examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

## RACE 7: DAISH IRRIGATION & FODDER RATING 0-71 HANDICAP - 900 metres (Cont'd)

RAKS MCLAREN, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported a slow recovery.

#### RACE 8: GRUNDFOS RATING 0-62 HANDICAP - 1200 metres

CABERNET NOW (D. Tootell) jumped away awkwardly and as a result was very slow to begin.

TWILIGHT DANCER (D. Tourneur) jumped away awkwardly.

At the 1100 metres TWILIGHT DANCER (D. Tourneur) knuckled on two occasions.

Inside the 600 metres SNAPERTUDE (E. Boyd) appeared to knuckle for no apparent reason.

Racing inside the 300 metres TWILIGHT DANCER (D. Tourneur) was held up for clear running when racing on the heels of WUTHERING HEIGHTS (J. Bowditch) and when racing in tight room to the inside of UNDER THE RADAR (A. Herrmann).

Approaching the 200 metres TWILIGHT DANCER (D. Tourneur), when shifting wider on the track to improve around WUTHERING HEIGHTS (J. Bowditch), bumped and inconvenienced UNDER THE RADAR (A. Herrmann). D. Tourneur was reminded of his obligations when shifting ground.

CABERNET NOW was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

#### RACE 2: ORANGE PUMPS MAIDEN PLATE - 1400 metres

Stewards questioned Mr. S. Gower, the Trainer of CUT TO THE CACHE, with regard to the reason the filly was not presented to race at today's meeting. Stewards charged Mr. Gower under ARR.59A(3) in that he presented the filly EXCELL SHOES to race instead of CUT TO THE CACHE. Mr. Gower pleaded guilty and was fined \$1500.

#### RACE 7: DAISH IRRIGATION & FODDER RATING 0-71 HANDICAP - 900 metres

On Thursday, 15 November 2012 Mr. M. Croucher, the Trainer of AL'S AWAY, reported to Stewards that on return to stable the mare was exhibiting signs of being sore and would now be freshened up.
