THOROUGHBRED RACING S.A. LIMITED STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at the Port Lincoln Racecourse by the Port Lincoln Racing Club on Thursday, 22 November 2012

Stewards: A. Hayles (A/Chairman) & M. Santoro (HT) (Stewards), P. Dearman, R. Evans (F),

RACE 1: LEADER DISTRIBUTORS RATING 0-68 HANDICAP - 1750 metres

The start of this race was delayed approximately two minutes owing to an interstate delay.

MEADOWS MAGIC (W. Kerford) was slow to begin.

FACING (A. Herrmann) jumped away awkwardly and shifted in, at the same time MONTALTO (P. Roff) jumped awkwardly and shifted out, resulting in AMBUSH AL (A. Patterson) being inconvenienced when tightened.

DASHAGH (E. Boyd) was inclined to race ungenerously in the early and middle stages.

Inside the 200 metres AMBUSH AL (A. Patterson) rolled out marginally, momentarily inconveniencing FACING (A. Herrmann).

A. Herrmann, the rider of FACING, reported that in the vicinity of the 1300 metres the gelding lost its action when its hindquarters were turned.

AMBUSH AL, GOING STRONG and DASHAGH, which performed below expectations, were examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 2: YALUMBA RATING 60 & OVER HANDICAP - 1350 metres

PRIMAL INSTINCT (P. Roff) was slow to begin.

GENEROUS HUKA (NZ) (J. Potter) and SUPER HIT (K. Bishop) brushed on jumping.

When being restrained PRIMAL INSTINCT (P. Roff) raced keenly in the early and middle stages.

RACE 3: PURCELL / SABOIS MAIDEN PLATE - 1200 metres

KONOWALCHUK (L. Hopwood) raced keenly in the early and middle stages.

Inside the 900 metres SON OF NALA (B. Claridge), which was racing in restricted room inside JENNA BELLA (C. Lever), had to momentarily steady and lost its position.

RACE 3: PURCELL / SABOIS MAIDEN PLATE - 1200 metres (Cont'd)

Racing to the 200 metres SOLITARY EAGLE (W. Kerford), which shifted out abruptly, resulting in W. Kerford becoming unbalanced dislodging W. Kerford from the gelding. Mr. P. Cole, the Trainer of SOLITARY EAGLE, was advised a warning has been placed on the gelding's racing manners. SOLITARY EAGLE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities. W. Kerford was examined by the on-course Ambulance personnel who ruled him fit to fulfill his remaining engagements.

RACE 4: PORT LINCOLN HOTEL RATING 60 & OVER HANDICAP - 1000 metres

TESTAGOLD (P. Roff) jumped away very awkwardly resulting in P. Roff being severely unbalanced and as a result was very slow to begin.

KOODA WONDER (K. Bishop) and ZIADIE (L. Hopwood) brushed on jumping.

KOODA WONDER (K. Bishop) was inclined to lay in rounding the home turn.

MUMSLAD (C. Lever) was inclined to lay out rounding the home turn.

Racing to the 100 metres KOODA WONDER (K. Bishop) rolled in under riding resulting in MUMSLAD (C. Lever) having to steady and lose its position. K. Bishop was severely reprimanded under ARR.137(a) for careless riding.

Correct Weight was delayed for this event to allow the Stewards to view the official vision of the start.

Following this race, Jockey W. Kerford stood himself down for the remainder of the day. W. Kerford was advised he would require a Medical Clearance prior to presenting to ride again.

RACE 5: MIKE RALEIGH MOTORS PTY LTD RATING 0-61 HANDICAP - 1000 metres

Mr. T. Trenowden, the Trainer of BELLBOOKANDCANDLE, advised Stewards he would instruct Jockey L. Hopwood if possible to ride the gelding in a mid-field position with cover which is not as per its normal racing in which it leads in the hope that the gelding will finish the race off stronger.

STAR LEGION (C. Lever) jumped away awkwardly.

FINAL DYNASTY (S. Cahill) jumped away awkwardly and as a result was slow to begin.

NABALI (E. Boyd) knuckled on jumping away.

MOTZART (A. Patterson) jumped away awkwardly and shifted out, brushing FINAL DYNASTY (S. Cahill).

Racing to the 600 metres FINAL DYNASTY (S. Cahill), which was racing keenly, had to steady away from the heels of EXCEL WITH PRIDE (P. Roff).

GOLD MOSS (K. Bishop) was inclined to lay in under pressure in the straight.

GOLD MOSS and FINAL DYNASTY, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 5 : MIKE RALEIGH MOTORS PTY LTD RATING 0-61 HANDICAP - 1000 metres (Cont'd)

Mr. Trenowden, the trainer of BELLBOOKANDCANDLE was advised a warning has been placed on the gelding regarding competitiveness. BELLBOOKANDCANDLE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 6: SHARPSHOOTING PHOTOGRAPHY RATING 0-64 HANDICAP - 1200 metres

SON OF A GUN (J. Potter) and CORDUROY (T. Baker) were slow to begin.

MIGHTY MOMENT (S. Cahill) jumped away awkwardly and shifted out bumping DANZEROUND THE SUN (B. Claridge).

HANK'S NEPHEW (E. Boyd) jumped away awkwardly.

Approaching the 200 metres NO VACANCY (L. Hopwood) shifted out to improve to the outside of the heels of HANK'S NEPHEW (E. Boyd) and in doing so made contact with SEEARDI BLUE (P. Roff) on a number of occasions.

On return to Scale A. Herrmann, the rider of PICTORELLA, reported to Stewards that in her opinion the mare felt sore behind. PICTORELLA was examined by the Club's Veterinary Surgeon who reported the mare to be lame in both hind legs. Mr. D. Courtney, the Trainer of PICTORELLA, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

SON OF A GUN which performed below expectations, left the course prior to being examined by the Club's Veterinary Surgeon. Mr. R. King, the Trainer of SON OF A GUN, was advised to report any condition that may become apparent to Stewards as soon as practicable in accordance with ARR.140(c). Mr. R. Kin, was also issued a reprimand under ARR.117(3) in that he left the course prior to the prescribed time.

RACE 7:89.9 MAGIC FM RATING 0-59 HANDICAP - 1350 metres

SILKEN THREAD (B. Claridge) stood flat-footed and as a result was very slow to begin. Mr. J. Dunn, the Trainer of SILKEN THREAD was advised the mare would have to present at either an Official Barrier Trial or an Official Jump Out to gain approval to race.

From the 400 metres to the entrance to the straight JACKIE'S PAPER (K. Bishop) was held up for clear ground when racing tight to the inside of CORONA GIRL (P. Roff) and when on the heels of CANNY PREVAIL (S. Westover).

HUNTED ANGEL (D. Tourneur) had difficulty obtaining clear ground in the straight when racing in restricted room inside of JACKIE'S PAPER (K. Bishop) and behind VOLATION (S. Cahill).

ARTECHS was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.
