Report on Race Meeting held at Clare Racecourse by the Clare Valley Racing Club on Sunday, 25 November 2012

RACE 1: MAGIC FM / 5CS / SABOIS FILLIES AND MARES MAIDEN PLATE - 1100 metres

CAMPASPE COUP (D. Stra) reared as the gates were released.

Inside the 200 metres JANICE MAY (J. Potter) rolled out taking CAMPASPE COUP (D. Stra) wider on the track.

MAGISUE, which returned to Scale with blood in its mouth, was examined by the Club's Veterinary Surgeon who reported a fractured tooth.

RACE 2: TAYLORS WINES / SABOIS MAIDEN PLATE - 1200 metres

The start of this race was delayed approximately two minutes owing to FLYTASTIC having its gear adjusted on arrival at the barriers.

On jumping away AKERBOY (D. Tourneur) shifted out wider on the track.

On jumping away SUREFIRE (T. Pannell) became tightened between CRYING TIME (C. Lever), which shifted in at the same time as ANGEL EYES (L. Hopwood) shifted out.

AKERBOY (D. Tourneur) raced keenly in the middle stages of the event.

In the vicinity of the 700 metres AKERBOY (D. Tourneur) hung out while rounding the turn taking PELL MELL (L. Stojakovic) and CRYING TIME (C. Lever) wider on the track.

Rounding the home turn PELL MELL (L. Stojakovic) was inclined to hang out. PELL MELL was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

D. Tourneur, the rider of AKERBOY, reported in his opinion the gelding had resented the cross over noseband. AKERBOY was examined by the Club's Veterinary Surgeon who reported no visible abnormalities. Mr. J. Searle, the Trainer of AKERBOY, was advised a warning had been placed on the gelding in relation to it hanging out and should it perform in a similar manner in future, further action may be taken against it.

RACE 3: WEST END MAIDEN PLATE - 1700 metres

GARNESH was a late scratching at 8.15 am. Stewards questioned Mr M. Hickmott, the Trainer of GARNESH, as to the reasons he had failed to scratch the gelding by the required time. After considering Mr. Hickmott's explanation, he was found guilty of a charge under LR19.1 and fined \$200.

On jumping away FLYING CLUB (J. Toeroek) and JUST PURE FUN (J. Potter) brushed. As a consequence JUST PURE FUN was taken in, brushing CENTRE RIPPLE (L. Hopwood).

In the early stages PAGANINI'S BROTHER (C. Lever) raced ungenerously and was inclined to get its head up when being restrained.

In the vicinity of the 700 metres FLYING CLUB (J. Toeroek) shifted out taking PACK SADDLE (M. Kelly) out momentarily. Shortly after PACK SADDLE rolled back in onto FLYING CLUB and as a result J. Toeroek had to be aware of the heels of STEAL THE JEWELS (J. Frew) momentarily.

CHARTREUSE DAISY, which returned to Scale with blood in its mouth, was examined by the Club's Veterinary Surgeon who reported a minor laceration to the lip.

- J. Frew, the rider of STEAL THE JEWELS, reported he was concerned with the gelding's action. STEAL THE JEWELS was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in both hind legs. Ms. J. Taylor, the Trainer of STEAL THE JEWELS, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.
- J. Potter, the rider of JUST PURE FUN, was questioned regarding a celebratory gesture prior to the winning post. J. Potter was reprimanded and advised in future to respond to his obligations under ARR137(c).

RACE 4: ARMAGH FINANCIAL SERVICES RATING 0-59 HANDICAP - 1800 metres

JEWEL OF CADENCE (L. Hopwood) reared on jumping away.

HARRY HIGH PANTS (L. Stojakovic) jumped away awkwardly, shifted out and made contact with PINT MUG (D. Tourneur), which was taken wider.

BRING THEM ON (T. O'Donnell) and BRUNO (J. Maund) brushed on jumping away.

From the 600 metres BRING THEM ON (T. O'Donnell) commenced to weaken. T. O'Donnell reported the mare had hung out throughout the event. BRING THEM ON was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

Inside the 500 metres CURACA HILL (B. Claridge), when improving, was obliged to steady when momentarily tightened between PINT MUG (D. Tourneur), which rolled out marginally, and FRESH TELL (E. Boyd).

L. Stojakovic, the rider of HARRY HIGH PANTS, reported she was disappointed with the gelding's effort today. HARRY HIGH PANTS was examined by the Club's Veterinary Surgeon who reported the gelding exhibited a slow recovery and mild heat stress.

MEDICEAN PLANET was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in both forelegs. Mr. J. MacMillan, the Trainer of MEDICEAN PLANET, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

RACE 5 : JIM BARRY WINES RATING 0-72 HANDICAP - 1200 metres

On arrival on course MR CRANE was examined by the Club's Veterinary Surgeon who ruled the gelding fit to race.

The start of this race was delayed approximately three minutes owing to MR CRANE requiring to be resaddled on arrival at the barriers and LOGICALLY requiring new blinkers to be fitted.

LOGICALLY (T. O'Donnell) jumped away awkwardly and shifted out onto MISS REMARKABLE (J. Frew), which was taken out onto SHAKETHEGROUND (T. Zanker), which was tightened onto SHIMANO MISS (NZ) (J. Kah).

TEST CENTURY (S. Cahill) raced very wide without cover throughout the event.

Approaching the 300 metres MR CRANE (S. Westover) was obliged to ease away from the heels of TEST CENTURY (S. Cahill), which rolled in.

Approaching the 100 metres TEST CENTURY (S. Cahill) rolled in and brushed FRANKIE SEA (S. Price).

J. Frew, the rider of MISS REMARKABLE, reported he did not ride the mare out as he was concerned with its breathing. MISS REMARKABLE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

UNDER THE RADAR, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 6: TAMINGA HOTEL CLARE VALLEY CUP - 1800 metres

Mr. W. Bencic, the Trainer of AL CHICAGO, reported the gelding had knocked an old abrasion on its near hip in the float en route to the course. AL CHICAGO was examined by the Club's Veterinary Surgeon who ruled the gelding fit to race.

On arrival at the barriers OWDATAY, which had brushed the gate when leaving the mounting enclosure, was examined by the Club's Veterinary Surgeon who ruled the gelding fit to race.

THE SHAMAN (L. Hopwood) was slow to begin.

In the vicinity of the 500 metres THE SHAMAN (L. Hopwood) dipped.

In the vicinity of the 300 metres THE SHAMAN (L. Hopwood) dipped for no apparent reason. As a result, THE SHAMAN became unbalanced for a number of strides. THE SHAMAN was examined by the Club's Veterinary Surgeon who reported the gelding to be slightly lame in the near foreleg as a result of pulling its off fore plate during the event.

J. Toeroek, the rider of BELLA DOLCE, reported the mare had dipped in the going. BELLA DOLCE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

Subsequent to this race the Stewards inspected the track in the vicinity of the 600 metres. The Stewards, concerned at the going immediately prior to the 600 metres and inside the 600 metres, directed the Club roll the track.

RACE 7: KIRRIHILL WINES RATING 0-59 HANDICAP - 1100 metres

The start of this race was rescheduled until 5.25 pm to allow a section of the track in the vicinity of the 600 metres to be rolled. The delay was longer than planned due to the tractor not being able to be used requiring a second tractor to be brought from the 1100 metre starting point.

BIT O' ME (T. O'Donnell) jumped away awkwardly, shifted out and brushed ACT OF FAITH (S. Price).

LYNSHEE, which performed poorly, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.
