THOROUGHBRED RACING S.A. LIMITED STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Morphettville Parks Racecourse by the South Australian Jockey Club on Saturday, 15 December 2012

<u>Stewards</u>: G. Loch (Chairman), M. Santoro (HT), A. Hayles (M) & S. Callanan (F) (Stewards), D. Southgate, N. Castle, I. Dally & A. Hamilton (Deputy Stewards), Dr. P. Horridge & Dr. B. Agnew (Veterinary Surgeons).

TRACKS: Dead 4 (Reclassified to Good 3 at 1.50 pm)

WEATHER: Overcast

<u>RAIL</u>: Out 7 metres 1000m to Winning Post and Chute, 4 metres remainder.

RACE 1 : DOMINANT HANDICAP - 1250 metres

HOT DIAMOND (J. Toeroek) was inclined to lay out throughout the event.

J. Frew, the rider of MISS DEBRA, which dead-heated for fourth, was questioned regarding his riding over the concluding stages of the event. After considering the evidence, J. Frew was charged with a breach of ARR.137(b) in that he ceased riding his mount prior to the finish of the race. He pleaded guilty and was fined \$250.

J. Toeroek, the rider of HOT DIAMOND, which dead-heated for fourth, was questioned regarding his riding over the concluding stages of the event. After considering the evidence, J. Toeroek was charged with a breach of ARR.137(b) in that he ceased riding his mount prior to the finish of the race. He pleaded guilty and was fined \$250.

J. Toeroek, the rider of HOT DIAMOND, reported the mare laid out throughout the event. HOT DIAMOND was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 2 : SPORTINGBET HANDICAP - 1000 metres

BLACK POINT (A. Herrmann) reared as the gates opened.

Near the 700 metres EXALTED WILLIAM (J. Bowditch) rolled in onto SPOILSPOT (K. Bishop), which was inconvenienced.

Inside the 600 metres SPOILSPOT (K. Bishop) rolled out and brushed EXALTED WILLIAM (J. Bowditch) as that gelding rolled in marginally.

In the vicinity of the 500 metres BLACK POINT (A. Herrmann) and WRITE NO MORE (S. Price) brushed on several occasions whilst racing tight inside SPOILSPOT (K. Bishop), as that gelding was inclined to lay in. As a consequence BLACK POINT was inconvenienced.

K. Bishop, the rider of SPOILSPOT, explained the gelding had over-raced and continued to fight her for a good part of the race and in hindsight, from the vicinity of the 700 metres, she may have been better suited to allowing the horse to stride forward. SPOILSPOT was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 3 : DISTINCTIVE HOMES HANDICAP - 1950 metres

On arrival at the barriers OUI SI ATTITUDE had to be resaddled.

OCSMEPOP (J. Bowditch) was slow to begin.

Inside the 300 metres ABOVE AVERAGE (IRE) (S. Cahill) was disappointed when attempting to improve between BREDLIGN (NZ) (J. Toeroek), which shifted in, and DUMOSA (A. Herrmann), which rolled out.

Inside the 200 metres, when attempting to improve, ABOVE AVERAGE (IRE) (S. Cahill) shifted out and brushed BREDLIGN (NZ) (J. Toeroek).

Correct Weight for this event was delayed to allow S. Cahill, the rider of the fourth placegetter ABOVE AVERAGE (IRE), to view the official footage from the entrance to the straight.

EVENMOREACTION was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 4 : HOLDFAST INSURANCE BROKERS HANDICAP - 1000 metres

BELFAST BOY (A. Herrmann) was slow to begin.

Inside the 200 metres VATICAN (W. Egan) rolled in marginally onto PERIDUKI (S. Westover) as that gelding rolled out marginally, resulting in it being inconvenienced.

BELFAST BOY was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 5 : ADELAIDE GALVANISING HANDICAP - 1400 metres

QUICK LOVER (J. Holder) was slow to begin

AKAHADOO (A. Herrmann) jumped away awkwardly.

Near the 900 metres MONSOON POON (S. Cahill), which had commenced to lay out, shifted out onto SATURDAY AFFAIR (C. Lindop) taking that gelding out onto MONICA KATE (K. Bishop), which was hampered when taken wider.

In the vicinity of the 900 metres WOAKWINE (J. Potter) rolled in marginally resulting in QUICK LOVER (J. Holder) clipping the heels of that gelding and as a result, brushed the inside rail, losing its action. As a consequence REWIND TIME (B. Claridge) shifted wider to avoid QUICK LOVER and WOAKWINE (J. Potter) and AKAHADOO (A. Herrmann) shifted wider on the track. QUICK LOVER was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

SATURDAY AFFAIR was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 6 : EXPRESS COLOUR PRINTING HANDICAP - 1250 metres

PUERTO BANUS (J. Frew) missed the start.

TEHUTI (A. Patterson) and ROCK STATION (J. Bowditch) were slow to begin.

RACE 6 : EXPRESS COLOUR PRINTING HANDICAP - 1250 metres (Cont'd)

VENTIC (T. Pannell) raced wide without cover throughout the event.

In the vicinity of the 1000 metres ROCK STATION (J. Bowditch), when racing keenly, rolled in onto TEST CENTURY (S. Cahill) taking that gelding in onto EMMOOKI'S DASH (D. Tourneur), which became awkward and, in being eased away from the heels of FINAL COMMAND (J. Kah), shifted in and struck the running rail.

At the entrance to the straight ROCK STATION (J. Bowditch), was disappointed when attempting to improve between BERMONDSEY (S. Westover), which shifted out and VENTIC (T. Pannell), which held its line. S. Westover was severely reprimanded and advised in future to take greater care when shifting ground.

L. Stojakovic, the rider of VALOROSO, reported her mount hung out rounding the home turn.

BACK ON TRACK was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 7 : CAPITAL TRANSPORT HANDICAP - 1400 metres

Ms. D. Klingenboeck, the Trainer of ADOPTME TWO, which had led at its most recent start, advised Stewards she would instruct Jockey M. Neilson, if possible, not to lead today in order to permit the gelding to finish its race off in a stronger manner.

INVINCIBLE GOLD (J. Kah) jumped away awkwardly.

INVINCIBLE GOLD (J. Kah) and DAYDREAM CHARLIE (J. Potter) raced keenly in the early stages of the event.

Approaching the 1000 metres INVINCIBLE GOLD (J. Kah), which continued to race keenly, was obliged to steady off the heels of CONDUCTION (J. Holder).

SEASON OF FORTUNE (C. Lindop), which raced wide at most stages of the race, was inclined to lay in.

At the entrance to the straight SEASON OF FORTUNE (C. Lindop) rolled in onto the heels of HASTEIN (NZ) (J. Bowditch)

Correct Weight for this event was delayed to permit D. Tourneur, the rider of the second placegetter AWE AND WONDER, to view the official image for first.

SEASON OF FORTUNE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

I AM MAGIC was examined by the Club's Veterinary Surgeon who reported an unusual hind gait but otherwise no visible abnormalities.

EXALTED BROTHER was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in both fore feet. Mr. J. Cornell, the Trainer of EXALTED BROTHER, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

RACE 8 : PAUL'S MILK HANDICAP - 1400 metres

LITTLE AKIE (K. Bishop) was slow to begin.

RACE 8 : PAUL'S MILK HANDICAP - 1400 metres (Cont'd)

On jumping away WILLEGO (L. Stojakovic) shifted out onto TARA MAN (M. Neilson) taking that gelding out onto KELLEMAN (J. Holder), which was inconvenienced.

SARCASM (J. Frew) raced wide without cover throughout the event.

At the entrance to the straight, for some distance, SHAKETHEGROUND (T. Zanker) had difficulty obtaining clear ground when racing behind GLARE (C. Lever) and inside SARCASM (J. Frew).

S. Westover, the rider of WINE LOVER, was cautioned in in future ride his mount to the finish as required by the Rules.

T. Pannell, the rider of ZAEIMUS, explained he settled where he anticipated and his mount had travelled well. He stated that when asked to improve in the vicinity of the 500 metres, ZAEIMUS had made some ground but thereafter did not respond to his riding. He added that ZAEIMUS otherwise felt okay. Mr. R. Balfour, representing Mr. D. Balfour, the Trainer of ZAEIMUS, stated the stable were disappointed with the effort, despite the loss of the plate, and undertook to report to Stewards any abnormalities which become apparent post-race. ZAEIMUS was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the off hind leg. Mr. R. Balfour was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

ZAEIMUS lost its off hind plate and SHADOW NINJA lost its near fore plate during the event.

GENERAL:

MORPHETTVILLE – FRIDAY, 14 DECEMBER 2012 RACE 8 : BOAG'S DRAUGHT HANDICAP - 1200 metres

An inquiry was conducted into an incident approaching the 700 metres in which READY TO REEL (J. Bowditch) was obliged to race in restricted room and SEE SPARKY (A. Herrmann) was tightened for room when racing inside MOSQUE (J. Kah), which shifted in. After taking evidence from the riders and reviewing the official footage in the vicinity of the 700 metres it was established MOSQUE had shifted ground when insufficiently clear, inconveniencing READY TO REEL. J. Kah was severely reprimanded and advised to only shift ground when entitled to do so in future. She was also advised she would be required to attend a meeting with the Rider's Skills Panel to review her ride.
