STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Morphettville Parks Racecourse
by the South Australian Jockey Club on Tuesday, 1 January 2013

RACE 1 : HOLDFAST INSURANCE BROKERS MAIDEN PLATE - 1100 metres

CHOISELLE, which refused to load, was withdrawn by Stewards at 1.02 pm. Mr. D. Jolly, the Trainer of CHOISELLE, was advised the filly was suspended until it demonstrated in an Official Barrier Trial it could load without delay.

On jumping away VIBKA (J. Kah) reared, losing ground.

BUXOM (A. Patterson) jumped away awkwardly.

Near the 800 metres BUXOM (A. Patterson), which was initially taken in marginally by FINNISS MOMENT (L. Hopwood), rolled in onto ZALLOVA (J. Bowditch), which was eased. In consequence VIBKA (J. Kah) reacted away from ZALLOVA.

J. Kah, the rider of VIBKA, which improved wide around the field from the vicinity of the 700 metres, explained that near the 800 metres FINNISS MOMENT (L. Hopwood) shifted out and away from cover and as a result got keen and improved. She added that after being exposed VIBKA continued to lay out away from other runners to its inside.

RACE 2 : DARLEY MAIDEN PLATE - 1000 metres

As the Stewards were able to confirm the identity of ALAKAZOO, it was permitted to start. Mr. P. Macdonald, the Trainer of ALAKAZOO, was found guilty of a breach of ARR.59A in that the Thoroughbred Identification Card (TIC) was not available and fined \$100.

On jumping away EXALTED WILLIAM (J. Kah) knuckled severely.

On jumping away WAPPING (J. Potter) slipped behind.

STRIKING EAGLE (T. Zanker) raced wide without cover throughout the event.

Near the 800 metres EXALTED WILLIAM (J. Kah) was obliged to steady off the heels of CHRISTMAS LILY (S. Price), which shifted in. S. Price was reprimanded and advised to in future shift ground only when entitled to do so.

RACE 2 : DARLEY MAIDEN PLATE - 1000 metres (Cont'd)

Inside the 800 metres WAPPING (J. Potter), which was inclined to race greenly, was taken in marginally by CANNES DESTINATION (S. Cahill), which rolled in. In consequence WAPPING continued in and tightened DANZING (J. Holder), which was checked, losing its position. Thereafter WAPPING improved onto the heels of CANNES DESTINATION and in being restrained, became ungenerous and shifted out, hampering STRIKING EAGLE (T. Zanker). Mr. G. Lesnikowski, the Trainer of WAPPING, was advised a repetition of the gelding's behaviour may lead to action being taken against it.

From the entrance to the straight until the vicinity of the 100 metres EXALTED WILLIAM (J. Kah) was unable to obtain clear ground when racing behind CANNES DESTINATION (S. Cahill) and inside WAPPING (J. Potter).

Approaching the 100 metres EXALTED WILLIAM (J. Kah) shifted out and brushed WAPPING (J. Potter), which was momentarily inconvenienced.

EXALTED WILLIAM and WAPPING were examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 3 : BOAG'S DRAUGHT MAIDEN PLATE - 1200 metres

On arrival at the barriers REGAL JASMINE (NZ) was examined by the Club's Veterinary Surgeon and ruled fit to start.

FOUR FEATHER FALLS (C. Lever) and REGAL JASMINE (NZ) (S. Westover) were slow to jump.

BARABBA MOMENT (L. Hopwood) jumped away awkwardly and shifted in, brushing BARJAS (A. Herrmann).

From the entrance to the straight, for a short distance, BARABBA MOMENT (L. Hopwood) was unable to obtain clear ground when racing inside the heels of RULESOFENGAGEMENT (P. Gatt).

When questioned regarding his riding of REGAL JASMINE (NZ) from the vicinity of the 500 metres, S. Westover explained the mare had not travelled at any stage prior to that point and he had considered easing it from the event. He stated that inside the 300 metres when given a slap, REGAL JASMINE (NZ) showed some response but only briefly. He added from the 100 metres he considered it not in the mare's best interest to continue to pressure it. After considering this explanation and viewing the official vision Stewards advised S. Westover his explanation would be reported. REGAL JASMINE (NZ) was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

P. Gatt, the rider of RULESOFENGAGEMENT, reported the mare appeared sore in the off foreleg. RULESOFENGAGEMENT was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

WICKED ROMEO, BARJAS, MYLADY CAROL and SILENT SAVANNAH were examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 4 : DISTINCTIVE HOMES MAIDEN PLATE - 1600 metres

In the vicinity of the 400 metres CHECOTE (J. Holder) was held up between runners for some distance.

SENSATIONAL CARD was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 5 : ADELAIDE GALVANISING HANDICAP - 1050 metres

DE VILAINE (K. Bishop) was slow to jump.

On jumping away REAL FANTASY (C. Lindop) shifted out and brushed MOSQUE (J. Kah).

In the vicinity of the 100 metres S. Westover, the rider of EL PRADO GOLD, accidentally dropped his whip. S. Westover was fined \$50 for carelessness under ARR.137(a).

ANY DESTINATION was examined by the Club's Veterinary Surgeon who reported the gelding to be foot sore in both forelegs and suffering from colic. First Aid was administered. Mr. L. Kavanagh, representing Mr. M.A.T. Kavanagh, the Trainer of ANY DESTINATION, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

RACE 6 : CENTREBET HANDICAP - 2006 metres

Mr. J. Croucher, the Trainer of SUREFIRE, advised Stewards that when ridden back in three starts this preparation, SUREFIRE had appeared to have little interest in its races and was one paced at the finish. In an attempt to improve its performance, he said he had added blinkers and changed the gelding's work. The Trainer said he would instruct jockey T. Pannell, if possible, to attempt to ride the gelding more forward in this race.

Mr. S. Gower, the Trainer of ANYTHINGTHATMOVES, which proved difficult to load, was advise the gelding was suspended until it could demonstrate in an Official Barrier Trial it could load without delay. Mr. Gower confirmed ANYTHINGTHATMOVES would be spelled.

DAYLIGHT'S DAUPHIN (S. Price) was slow to jump.

On jumping away ANYTHINGTHATMOVES (M. Neilson) shifted out onto NISHIAZABU (J. Frew) taking that gelding out onto BEATBOY (NZ) (J. Maund), resulting in both runners being inconvenienced.

MAPLE LANE (T. Zanker) raced wide without cover throughout the event.

Inside the 600 metres ST GABRIEL (C. Lever) shifted out onto NISHIAZABU (J. Frew), which was obliged to ease when tightened onto FANTAUZZO (M. Pegasus). C. Lever was reprimanded and advised to in future shift ground only when entitled to do so.

BAKLAVA BOY (NZ) lost its near hind plate during the race.

GOLDSTINGER and BEATBOY (NZ) were examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

ST GABRIEL was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the off hind leg. Mr. R. Balfour, the Co-Trainer of ST GABRIEL, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

RACE 7 : ADELAIDE CASINO HANDICAP - 1200 metres

On jumping away BUSH GEM (S. Westover) and SOPHISTICATED LASS (S. Price) brushed.

SOPHISTICATED LASS (S. Price) and ULI URS UTZ (C. Lever) raced wide without cover throughout the event.

In the early stages of the event BUSH GEM (S. Westover) was inclined to race greenly and shift about.

RACE 7 : ADELAIDE CASINO HANDICAP - 1200 metres (Cont'd)

Approaching the 1100 metres ROAD TO FINNISS (L. Hopwood) was obliged to steady off the heels of BUSH GEM (S. Westover), which shifted in.

Near the 400 metres DAKADAN PRINCESS (S. Cahill), which had commenced to improve, was obliged to steady when tightened for room by AGED IN OAK (J. Toeroek), which shifted out.

In the vicinity of the 300 metres J. Frew, the rider of SISTER SWIFT, accidentally dropped his whip. J. Frew was fined \$50 for carelessness under ARR.137(a).

From the entrance to the straight until approaching the 200 metres, DAKADAN PRINCESS (S. Cahill) was unable to obtain clear ground when racing inside the heels of ULI URS UTZ (C. Lever).

In the vicinity of the 200 metres ULI URS UTZ (C. Lever), which was inclined to lay in, and ROAD TO FINNISS (L. Hopwood), brushed.

Approaching the 100 metres ROAD TO FINNISS (L. Hopwood), when attempting to improve into a tight run outside BUSH GEM (S. Westover), was disappointed as that mare shifted out. S. Westover was reprimanded and advised to take greater care when shifting ground in future.

When questioned regarding the circumstances in which SOPHISTICATED LASS raced wide without cover throughout the event, S. Price explained that in the early stages, although the race tempo was moderate, he had considered if he had attempted to settle forward, SOPHISTICATED LASS would continue to be forced to race four wide. He stated that he had instead elected to obtain cover on the back of ULI URS UTZ (C. Lever) but had been thwarted as that gelding at the same time had continued to come back. Stewards advised S. Price this explanation would be reported. SOPHISTICATED LASS was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 8 : CITY OF MARION HANDICAP - 1600 metres

Mr. T. Double, the Trainer of CORDUROY, which had settled back in recent starts, advised Stewards that after discussing the race with Jockey T. Pannell and in view of an apparent lack of pace on paper, he would instruct the rider, if possible, to be positive from the barrier in an attempt to settle on pace.

WALTZING TO WIN (B. Claridge) was slow to jump.

MEADOWS POWER (A. Herrmann) reared as the gates opened.

B. Claridge, the rider of WALTZING TO WIN, explained that after being slow away the mare had settled further back than in previous starts due to the quicker tempo of the race. He stated WALTZING TO WIN travelled only fairly during the race, was never travelling well enough to attempt to shift other runners on entering the straight and had disappointed in the manner it responded to his riding from the 500 metres. He added that WALTZING TO WIN was indicating it had come to the end of its preparation. WALTZING TO WIN was examined by the Club's Veterinary Surgeon who reported the mare to be lame in the off foreleg. Mr. D. Huxtable, the Trainer of WALTZING TO WIN, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

THE CATCHER was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.
