Report on Race Meeting held at the Penola Racecourse

RACE 1 : MAJELLA WINES / SABOIS MAIDEN PLATE - 1100 metres

KILL BILL (K. Post) raced keenly in the early stages while attempting to obtain cover behind FIXED INTEREST (D. Tourneur).

WELCOME NED (M. Neilson), which raced greenly in the straight, shifted in, in the vicinity of the 100 metres, and inconvenienced BANGLES (A. Patterson).

KILL BILL (K. Post) was inclined to lay out in the straight and was untested to the line.

J. Maund, the rider of IMAGALILEO, reported to Stewards in his opinion the gelding felt sort. IMAGALILEO was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

When questioned regarding his riding in the straight, K. Post, the rider of KILL BILL, explained the mare had commenced to hang out from the vicinity of the 800 metres and he had difficulty controlling it on entering the straight. He stated that near the 200 metres he had taken a different grip on the reins and the mare responded and shifted in behind DUBAILATION (H. McKechnie). He added that in his opinion KILL BILL felt sore. After considering his explanation, K. Post was advised he should ride in a manner that did not invite question and was advised of his obligations under ARR.140(b) in reporting to Stewards as soon as practicable anything which may have affected the running of his horse. KILL BILL was examined by the Club's Veterinary Surgeon who reported the mare to be shin sore. Mr. L. Creek, the Trainer of KILL BILL, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

RACE 2 : PATRICK OF COONAWARRA / SABOIS MAIDEN PLATE - 1700 metres

On arrival at the barriers H. McKechnie, the rider of WORK BEFORE PLAY, reported she was concerned with the mare's action. WORK BEFORE PLAY was examined by the Club's Veterinary Surgeon who reported the mare to be lame in the off foreleg. Acting on that advice, Stewards withdrew WORK BEFORE PLAY at 1.15 pm. Mr. L. Creek, the Trainer of WORK BEFORE PLAY, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

VILIFY (K. Post) and TYPO (M. Walters) came together and bumped on jumping away.

RACE 2 : PATRICK OF COONAWARRA / SABOIS MAIDEN PLATE - 1700 metres
(Cont'd)

CAITLONAYA (D. Tourneur) raced three wide without cover throughout the event.

TYPO (M. Walters) raced four wide without cover throughout the event.

Inside the 1600 metres LORD REB (J. Frew) shifted in onto TOWER OF HOMAGE (S. Cahill), which was inconvenienced and had to be steadied when tightened onto SUN CENTS (J. Kah), which shifted out slightly.

Approaching the finish LORD REB (J. Frew) shifted out under riding onto GRAND PRINTIVE (K. Walters), which was tightened onto BIG CITY DREAMS (J. Potter), which shifted in and away from CAITLONAYA (D. Tourneur), which shifted in slightly, resulting in GRAND PRINTIVE having to be checked to avoid the heels of LORD REB. J. Frew was severely reprimanded and advised in future to ensure he was sufficiently clear prior to shifting ground.

T. O'Donnell, the rider of HE'S NO MUG, reported to Stewards the gelding hung out throughout the event. HE'S NO MUG was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 3 : ZEMA ESTATE HANDICAP - 1100 metres

SCOUSE (D. Tourneur) reared on jumping away and was slow to begin.

In the vicinity of the 400 metres BROOKLYN ROADS (NZ) (K. Walters) shifted in of its own accord and brushed the running rail.

RACE 4 : WYNNS COONAWARRA ESTATE RATING 0-68 HANDICAP - 1100 metres

CONIDEL (K. Post) was slow to begin.

In the middle stages CONIDEL (K. Post) and GUMNUTS (J. Kah) came together and brushed on a number of occasions.

Inside the 400 metres CONIDEL (K. Post) had to steady momentarily off the heels of DELTA RHO SAM (J. Potter), which shifted in. J. Potter was reminded of his obligations when shifting ground in future.

RACE 5 : BOWEN ESTATE / SABOIS MAIDEN PLATE - 1400 metres

The start of this race was delayed approximately three minutes owing to M. Neilson, the rider of CLANGAWAY, being concerned with the gelding's action en route to the barriers. CLANGAWAY was examined by the Club's Veterinary Surgeon and ruled fit to start.

The start was also delayed owing to the barrier gates failing to open mechanically, resulting in a manual start having to be effected.

MADAM EVIE (J. Toeroek) was slow to begin.

STELLASTROEM (S. Harrison) reared on jumping away and was slow into stride.

FOWLER'S DREAM (J. Kah) raced greenly in the middle stages of the event and was inclined to shift about, resulting in SUNLIST (J. Frew) having to steady off that filly's heels in the vicinity of the 1000 metres.

RACE 5 : BOWEN ESTATE / SABOIS MAIDEN PLATE - 1400 metres (Cont'd)

CLANGAWAY (M. Neilson) was eased out of the event in the vicinity of the 600 metres due to M. Neilson becoming extremely concerned with the gelding's action. CLANGAWAY was examined by the Club's Veterinary Surgeon who reported the gelding had jarred up and was slightly shin sore.

PRESTIGE PEARL, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported the mare had jarred up and was slightly shin sore.

RACE 6 : KATNOOK ESTATE RATING 0-68 HANDICAP - 1700 metres

MONSTARHIT (T. O'Donnell) dipped on jumping away.

FRADEMA (J. Potter) raced keenly in the early and middle stages whilst being restrained.

GARNESH (S. Cahill) raced wide without cover throughout the event.

M. Neilson, the rider of SUPA COOL DUDE, reported his saddle shifted back in the vicinity of the 600 metres, placing him at a disadvantage for the remainder of the event.

S. Cahill, the rider of GARNESH, reported he was concerned with the gelding's action in the straight. GARNESH was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 7 : COONAWARRA VIGNERONS CUP - 1700 metres

Mr. W. Walters, the Trainer of BABAZAAR (NZ), advised Stewards he would instruct Jockey M. Walters to attempt to have the gelding settle behind the speed with cover if possible rather than race on pace as it had at its recent starts, due to the apparent pace in the race and to allow BABAZAAR (NZ) to finish its race off stronger.

CLUB ROYALE (H. McKechnie) was slow to begin.

OOMOO CHANCE (B. Carlile) raced wide without cover throughout the event.

At the entrance to the straight INNOCENT MUG (D. Tourneur) shifted out to improve and in doing so tightened SACRED SNAADEE (J. Maund) onto SANDHILL PRINCE (J. Toeroek), which was taken out onto OOMOO CHANCE (B. Carlile).

RACE 8 : PETALUMA RATING 0-65 HANDICAP - 1300 metres

FINISTAR (J. Toeroek) and OLYMPIC JOY (D. Tourneur) were slow to begin.

TRIG (M. Walters) shifted in on jumping away contacting PUZZLEMAN (P. Marks), which was taken out, brushing SEULAMONT (K. Post).

CASH AT DAWN (S. Harrison) jumped away awkwardly.

FINISTAR (J. Toeroek) raced keenly in the early and middle stages whilst being restrained.

On entering the straight OLYMPIC JOY (D. Tourneur) improved onto the heels of CASH AT DAWN (S. Harrison), which had commenced to give ground, and had to be steadied for a short distance.

S. Harrison, the rider of CASH AT DAWN advised Stewards he had injured his knee during the event. S. Harrison was examined by the on course Ambulance personnel and was advised a Medical Clearance would be required prior to riding again.
