RACE 1: CARLTON DRAUGHT / SABOIS TWO-YEAR-OLD HANDICAP - 1000 metres

PACIFIC JOURNEY (E. Boyd) stood flat-footed and was slow into stride.

BLACK DANCER (T. Pannell) and SNIP IN TIME (T. Baker) brushed on jumping.

BLACK DANCER (T. Pannell) was inclined to lay in, in the straight.

Correct Weight for this event was delayed to allow P. Roff, the rider of the third placegetter EXTREME VALUE, to view the official footage in the straight.

RACE 2: KEMP REAL ESTATE RATING 0-64 HANDICAP - 1000 metres

On arrival at the barriers LORD OF THE CASTLE was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the off foreleg. Acting on that advice, Stewards withdrew LORD OF THE CASTLE at 3.43 pm.

NATURAL HERO (D. Tourneur) and EXCEL WITH PRIDE (P. Roff) brushed shortly after the start.

Racing to the 200 metres MEMORY COVE (T. Baker) shifted in under pressure brushing ROADAKATWO (J. Potter).

Inside the 100 metres HOLD THE ACES (S. Westover) had to momentarily steady when GOLD MOSS (A. Patterson) shifted out. A. Patterson was advised of his obligations when shifting ground.

RACE 2: KEMP REAL ESTATE RATING 0-64 HANDICAP - 1000 metres (Cont'd)

P. Roff, the rider of EXCEL WITH PRIDE, which performed disappointingly, explained that from leaving the barriers the gelding was reluctant to race and could not provide any further explanation. EXCEL WITH PRIDE was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the off foreleg. Mr. S. Drewitt, the Trainer of EXCEL WITH PRIDE, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

KOODA SURPRISE, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported the mare to be lame in the near foreleg. Mr. J. Dunn, the Trainer of KOODA SURPRISE, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

Ms. A. Morrison, the Trainer of GOLD MOSS, was questioned regarding the improved performance of this gelding. Ms. Morrison explained she felt the gelding was feeling its legs in track work and decided to lighten off its work from its last start and was of the opinion that doing more swimming was beneficial to the gelding.

RACE 3: ANVERS WINE PTY LTD / SABOIS MAIDEN PLATE - 1250 metres

HIGH ROLLIN' LADY (E. Boyd) jumped away awkwardly.

HARAKA ZULU (S. Westover) jumped away awkwardly and shifted in, brushing DANCING MARY (J. Potter).

SARAPET (K. Bishop) jumped away awkwardly and shifted out, brushing MUMAJET (D. Tourneur).

Racing to the 600 metres HARAKA ZULU (S. Westover), which was racing ungenerously, had to momentarily steady when racing tight between SECURITY INDEX (S. Cahill) and BEAU RAJA (T. Pannell).

From the 400 metres DANCING MARY (J. Potter) was unable to obtain clear ground behind a number of runners until racing inside the 100 metres.

Racing to the 100 metres LAMU LAD (P. Roff), which rolled in under pressure, bumped CHARLOTTE'S JOY (T. Baker), which shifted in onto BEAU RAJA (T. Pannell), resulting in DANCING MARY (J. Potter) having to momentarily steady.

BEAU RAJA and HIGH ROLLIN' LADY were examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

Mr. A. Page, the Trainer of HIGH ROLLIN' LADY, was advised a repetition in the filly's being difficult to load may result in further action being taken.

Mr. B. Lear, representing Mr. M. Dunn, the Trainer of SARAPET, was advised a repetition in the mare's being difficult to load may result in further action being taken.

RACE 4 : BUTTERFIELD FARM DIRECT HORSE PELLETS RATING 0-83 HANDICAP – 1750 metres

The start of this race was delayed approximately three minutes when GENEROUS HUKA (NZ) had to be replated on arrival at the start.

RACE 4 : BUTTERFIELD FARM DIRECT HORSE PELLETS RATING 0-83 HANDICAP – 1750 metres (Cont'd)

TARONGA (T. O'Donnell) jumped away awkwardly and shifted out, bumping TRUTHS (T. Pannell).

Racing to the 1500 metres TRUTHS (T. Pannell) had to momentarily steady when VOLATION (E. Boyd) shifted in. E. Boyd was reminded of her obligations when shifting ground.

In the vicinity of the 1400 metres STREET RELATED (J. Potter) was inclined to get its head up and race ungenerously when being restrained.

In the vicinity of the 1300 metres STREET RELATED (J. Potter) shifted in and made contact with the running rail.

OCSMEPOP, which performed below expectations was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

TARONGA was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

FORESHORE MAK was examined by the Club's Veterinary Surgeon who reported a lower than expected heart rate.

RACE 5: MIKE RALEIGH MOTORS RATING 0-61 HANDICAP - 1200 metres

MISS HARREB (E. Boyd) raced ungenerously in the early and middle stages.

T. Baker, the rider of BUDDY FANTASTIC, explained the gelding was reluctant to race inside runners and never felt comfortable until gaining clear ground in the straight. BUDDY FANTASTIC, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

Stewards spoke to Mr. T. Doudle, the Trainer of THE CHAMPION, in relation to the gelding being reluctant to proceed to the barriers. Mr. Doudle was advised THE CHAMPION must perform satisfactorily in an Official Barrier Trial prior to accepting for a future race.

RACE 6 : STASSI ENGINEERING & DESIGN PTY LTD RATING 60 & OVER HANDICAP – 1200 metres

Jockey S. Cahill was granted permission to ride TESTATE half a kilogram overweight as there was no other rider available.

MUMSLAD (K. Bishop) jumped away awkwardly and shifted out, brushing SHAVILLE (E. Boyd).

Shortly after the start SHAVILLE (E. Boyd) had to momentarily steady and lose its position when MUMSLAD (K. Bishop) shifted out at the same time as PRIMAL INSTINCT (P. Roff) shifted in.

Inside the 400 metres TESTATE (S. Cahill) shifted out to improve around the heels of MISS ELIZA (B. Claridge), resulting in TRESETTE (A. Patterson) being taken wider on the track. PRIMAL INSTINCT (P. Roff), which was racing to the outside of TRESETTE, was inconvenienced. S. Cahill was reminded of his obligations when shifting ground.

PRIMAL INSTINCT was examined by the Club's Veterinary Surgeon who reported low grade typing up in the hindquarters.

RACE 6 : STASSI ENGINEERING & DESIGN PTY LTD RATING 60 & OVER HANDICAP – 1200 metres (Cont'd)

ROLL ON BAI and ZIADIE were examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 7: K & K COOLING SOLUTIONS PTY LTD RATING 0-68 HANDICAP - 1350 metres

SUPER HIT was withdrawn by Stewards at 3.30 pm as there was no rider available.

Inside the 200 metres PHOENIX MISS (B. Claridge) shifted out to improve around the heels of SEEARDI BLUE (P. Roff) and as a result SONO PICCOLO (E. Boyd), which was racing tight inside HANK'S NEPHEW (S. Cahill), was momentarily inconvenienced.
