STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at the Port Lincoln Racecourse
by the Port Lincoln Racing Club on Sunday, 27 January 2013

RACE 1 : COATES HIRE / SABOIS 3YO RATING 0-61 HANDICAP - 1200 metres

SECURITY INDEX (S. Cahill) jumped away awkwardly and shortly after brushed with KOODA DUCHESS (K. Bishop), which shifted out.

Near the 100 metres FLYING CLUB (D. Tourneur) rolled in onto SECURITY INDEX (S. Cahill), which was inconvenienced.

When questioned regarding his reasons for not attempting to maintain his position in the early stages, D. Tourneur, the rider of FLYING CLUB, explained that although FLYING CLUB began best, shortly after the start he considered his mount would not have sufficient speed to cross the inside three runners and rather than push FLYING CLUB out of its comfort zone, had permitted the filly to drift back in an attempt to obtain cover. Stewards informed D. Tourneur his explanation would be reported.

S. Cahill, the rider of SECURITY INDEX, explained that in contrast to its previous start the gelding had not travelled in running and was uneven in its action, dipping on a number of occasions. He stated that SECURITY INDEX had not given him the same feel as its previous start when successful. Mr. J. Hyam, the Trainer of SECURITY INDEX, was directed to provide the results of a post-race veterinary examination. SECURITY INDEX was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 2 : M & M GROUP OF COMPANIES / SABOIS MAIDEN PLATE - 1350 metres

SPOOKSTER (P. Roff) jumped away awkwardly.

PAGANINI'S BROTHER (C. Lever) jumped away awkwardly and shifted out, brushing GONE WITHOUT (S. Cahill).

On jumping away MYKONOS SUNSET (K. Bishop) and SHE'S MISUNDERSTOOD (B. Claridge) brushed.

CHARLOTTE'S JOY (T. Baker) raced wide without cover throughout the event.

At the entrance to the straight MYKONOS SUNSET (K. Bishop) and SPOOKSTER (P. Roff) made heavy contact, resulting in the hindquarters of SPOOKSTER being turned out.

RACE 2 : M & M GROUP OF COMPANIES / SABOIS MAIDEN PLATE - 1350 metres

Near the 200 metres, when attempting to improve, MYKONOS SUNSET (K. Bishop) shifted out onto SPOOKSTER (P. Roff), which was inconvenienced.

Inside the 200 metres FORESHORE MAK (T. Pannell) was disappointed when attempting to improve into a run between OUR BELIEF (A. Patterson), which rolled in, and CHARLOTTE'S JOY (T. Baker), which rolled out.

RACE 3 : WIBBERLEY'S CHARTERED ACCOUNTANTS / SABOIS MAIDEN PLATE - 1000 metres

After being loaded NORTHSIDE LAD and HIGH ROLLIN' LADY became fractious and reared in the gates. Both horses were removed and examined by the Club's Veterinary Surgeon. NORTHSIDE LAD was ruled fit to start. HIGH ROLLIN' LADY was ruled unfit. Acting on that advice, HIGH ROLLIN' LADY was withdrawn by Stewards at 2.22 pm. Ms. T. Krobej, THE Trainer of NORTHSIDE LAD, and Mr. A. Page, the Trainer of HIGH ROLLIN' LADY, were advised their respective runners were given an official warning and would be required to be approved to race prior to accepting for a future race.

At the entrance to the straight HARLEY'S MATE (A. Herrmann) was forced to check off the heels of MUNGO MERLOT (P. Roff), which shifted out. In being checked HARLEY'S MATE clipped the heels of MUNGO MERLOT. Shortly after, MUNGO MERLOT made contact with LAMU LAD (T. Pannell) as that gelding rolled in. P. Roff was charged with Careless Riding under ARR.137(a) in that he allowed MUNGO MERLOT to shift out when insufficiently clear. He was found guilty and suspended from riding in races for a period to commence at midnight on Wednesday, 30 January and to conclude at midnight on Saturday, 9 February 2013; a period of five (5) meetings.

In the straight IDATRICE (K. Bishop) raced greenly and laid in noticeably under pressure.

D. Tourneur, the rider of MUMAJET, was questioned regarding his gesture prior to the finish. After considering his explanation, D. Tourneur was charged under ARR.137(c) in that he made a celebratory gesture. He pleaded guilty and was fined \$150.

RACE 4 : EP TEMPERATURE CONTROL LTD RATING 0-68 HANDICAP - 1000 metres

In the vicinity of the 700 metres GOLD MOSS (A. Patterson) was obliged to steady off the heels of ZIADIE (S. Westover), which shifted in. S. Westover was reprimanded and advised to in future give riders to his inside the room to which they are entitled.

From the vicinity of the 200 metres, when attempting to improve, GOLD MOSS (A. Patterson) shifted out and made contact on a number of occasions with AFTONLAND (J. Potter), which held its line.

Approaching the finish KOODA SURPRISE (K. Bishop) was unable to obtain clear ground.

Correct Weight for this event was delayed to permit A. Herrmann, the rider of the fifth placegetter BLACK WHISKEY, to view the official image for fourth.

RACE 5 : FIRE AND EQUIPMENT MAINTENANCE GROUP RATING 0-68 HANDICAP - 1750 metres

MEADOWS BOB (K. Bishop) was obliged to race three wide without cover for the entire race.

RACE 6 : AIT SPECIALISTS PTY LTD RATING 60 & OVER HANDICAP – 1350 metres

TRESETTE (A. Patterson) knuckled on jumping away.

PHOENIX MISS (B. Claridge) was reluctant to stretch out during the event.

In the early and middle stages DIRE WARNING (D. Tourneur) raced wide without cover.

From the 400 metres TESTATE (S. Cahill) was forced to lost its position when attempting to avoid ACHENAR (E. Boyd), which gave ground quickly.

K. Bishop, the rider of OCSMEPOP, was questioned regarding her use of the whip in the straight. K. Bishop was reprimanded under ARR.137A(3) in that her use of the whip was excessive in the terms of a notice provided to riders and advised that in future penalties would result from such breaches.

W. Kerford, the rider of VENTIC, was cautioned that his use of the whip bordered on excessive in the terms of a notice provided to riders.

PHOENIX MISS was examined by the Club’s Veterinary Surgeon who reported the mare to be heavily in season.

RACE 7 : D.K. QUARRIES RATING 0-64 HANDICAP - 1250 metres

On arrival on course KUITPO DANCER was examined by the Club’s Veterinary Surgeon who reported the gelding exhibited swelling in its near foreleg. Acting on that advice, Stewards withdrew KUITPO DANCER at 2.03 pm. Ms. A. Morrison, the Trainer of KUITPO DANCER, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

PICTORELLA (A. Patterson) jumped away awkwardly.

RIPASON (K. Bishop) raced wide without cover for the majority of the race.

In the vicinity of the 200 metres CALIFORNIAN DEVIL (S. Cahill) was inclined to lay in under pressure and proved difficult to ride as it laid in onto the heels of MEMORY COVE (T. Baker).
