**RACE 1 : ALL SEASONS KANGAROO ISLAND LODGE / SABOIS MAIDEN PLATE -**  
**1008 metres**

HOST WITH THE MOST was permitted to race equipped with winkers following a submission made by Trainer Mr. M. Whittle after the filly's run on Friday, 15 February 2013.

ONTHEROAD FOR GOLD (K. Bishop) jumped away awkwardly, shifted in and contacted STRIKING EAGLE (J. Potter).

LIL' STORM QUEEN (W. Kerford) raced wide without cover in the early stages of the event.

Rounding the home turn YANKALILLA BAY (S. Cahill) shifted out to obtain clear running and brushed with HARLEY'S MATE (A. Herrmann), which was momentarily inconvenienced.

Correct Weight for this event was delayed to allow K. Bishop, the rider of the second placegetter, to view the photo for first.

J. Potter, the rider of STRIKING EAGLE, explained he had been instructed to lead in this event, which he was able to do, but from in the vicinity of the 600 metres the filly commenced to race greenly, was inclined to lay out and failed to respond to his riding as he had expected and was off the bridle. He added the filly continued to race greenly and laid out in the straight, placing him at a disadvantage.

**RACE 2 : DUNLOP / MILTON TURNER MEMORIAL RATING 0-64 HANDICAP -**  
**1360 metres**

CARESSA (E. Brooks) and PELL MELL (T. O'Donnell) were slow to begin.

**RACE 3 : ZEN HOME ENERGY / SABOIS MAIDEN PLATE - 1360 metres**

On arrival on course MISTY PALACE was examined by the Club's Veterinary Surgeon who reported the mare to be lame in the off foreleg. Acting on that advice, Stewards withdrew MISTY PALACE at 11.56 am.

### **RACE 3 : ZEN HOME ENERGY / SABOIS MAIDEN PLATE - 1360 metres (Cont'd)**

MS TWENTYONE (J. Toeroek) raced keenly in the early stages of the event.

Approaching the 100 metres IDATRICE (K. Bishop) shifted in abruptly of its own accord, unbalancing its rider, who was dislodged shortly thereafter, making contact with two uprights of the inside running rail. After dislodging its rider IDATRICE stumbled severely. As a consequence of this incident, DASHA CHILLI (T. O'Donnell), which was severely hampered, was obliged to check and shift away from the riderless horse and as a consequence of this shift, BUTTERFLY QUEEN (J. Potter) and DOUBLESIX (D. Tournour) were also inconvenienced. IDATRICE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities. Mr. J. Dunn, the Trainer of IDATRICE, was advise that in view of the gelding's behaviour it has been stood down to an Official Barrier Trial and must prove it can race in a tractable manner prior to accepting for a future race. K. Bishop was examined by the on course ambulance staff and the Club's Doctor and was stood down for the remainder of the meeting.

### **RACE 4 : SEALINK HANDICAP - 1215 metres**

OUTLOOK EXPRESS (J. Potter) raced wide without cover in the early stages of the event.

### **RACE 5 : UNIBET RATING 0-59 HANDICAP - 1215 metres**

The start of this race was delayed approximately two minutes owing to OUR DESTINATION having to be examined by the Club's Veterinary Surgeon on arrival at the barriers who reported the gelding to be lame in the off foreleg. Acting on that advice, Stewards withdrew OUR DESTINATION at 3.07 pm. Mr. J. Dunn, the Trainer of OUR DESTINATION, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

### **RACE 6 : PHIL HOFFMANN TRAVEL RATING 0-61 HANDICAP - 1008 metres**

SAKURABA (J. Toeroek) jumped away awkwardly and shortly thereafter was inconvenienced by MY GOOD FRIEND (A. Patterson), which shifted out.

SATISFIED CUSTOMER (T. O'Donnell) jumped away awkwardly.

In the vicinity of the 300 metres, for some distance, KANGAROO JACK (W. Kerford) was unable to obtain clear ground when racing behind RUBILAD (E. Boyd) and KOODA DAWN (A. Herrmann). As a consequence KANGAROO JACK was obliged to alter course to the outside of RUBILAD shortly after entering the straight to obtain clear running.

### **RACE 7 : COOPERS BREWERY KANGAROO ISLAND CUP - 1880 metres**

SCOUSE (E. Boyd) jumped away very awkwardly and shifted in abruptly shortly after the start. Thereafter this gelding pulled very hard in the early and middle stages of the event and was difficult to restrain and only settled in the vicinity of the 1000 metres.

OCSMEPOP (W. Kerford) stood flat-footed and lost many lengths at the start.

LOTTO BLUES (J. Potter), which became awkward in its action, was eased out of the event in the vicinity of the 150 metres. J. Potter explained, whilst he was obliged to race deep without cover in the early and middle stages, the gelding travelled well until in the vicinity of the 800 metres where, when asked for an effort it was under pressure and was off the bridle despite his continued efforts. He added that the gelding felt fine in its action until in the vicinity of the 150 metres where it became very awkward in its action, resulting in him taking hold of his mount and easing it out of the event. LOTTO BLUES was examined by the Club's Veterinary Surgeon who reported the gelding had ruptured its near fore suspensory ligament and a collapsed fetlock joint. LOTTO BLUES was humanely euthanased.

**RACE 8 : AURORA OZONE HOTEL RATING 0-59 HANDICAP - 1750 metres**

MOON CIRCLE (W. Kerford) jumped away awkwardly.

Shortly after passing the winning post on the first occasion ROYAL ENTITY (T. O'Donnell) dipped for no apparent reason. As a consequence ROCK STAR BABY (D. Tourneur), which was following, was inconvenienced and had to alter course to that horse's inside.

MOON CIRCLE (W. Kerford) raced wide without cover in the early and middle stages of the event.

MONSTARHIT (J. Potter) pulled hard in the early and middle stages of the event.
