Report on Race Meeting held at the Port Lincoln Racecourse

RACE 1 : MAGIC MILLIONS / SABOIS TWO-YEAR-OLD HANDICAP - 1000 metres

On jumping away EXTREME VALUE (P. Roff) and SNIP IN TIME (T. Baker) came together and brushed.

HARDERS (A. Patterson) and PAPAJET (D. Tourneur) were slow to begin and shortly after the start came together and brushed.

MISTAKEN VALUE (E. Boyd) lost its off side winker in the vicinity of the 900 metres.

In the vicinity of the 300 metres EXTREME VALUE (P. Roff) shifted in of its own accord towards the running rail and became unbalanced for several strides.

HARDERS, which return to the mounting enclosure with blood in its mouth, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 2 : RETRAVISION – PORT LINCOLN RATING 60 & OVER HANDICAP - 1750 metres

CRUZIERO (T. O'Donnell) dipped for no apparent reason in the vicinity of the 1300 metres.

Approaching the 200 metres YARTERBERY (T. Baker) rolled in slightly onto CRUZIERO (T. O'Donnell), which had to be momentarily steadied and alter course.

RACE 3 : PORT LINCOLN HOTEL / SABOIS MAIDEN PLATE - 1350 metres

CHARLOTTE'S JOY was examined by the Club's Veterinary Surgeon in the parade ring who reported the mare to be lame in the off foreleg. Acting on this advice, Stewards withdrew CHARLOTTE'S JOY at 1.50 pm.

MEADOWS STORM (P. Roff) jumped away awkwardly and shifted out contacting NOW YOU'RE FLYING (T. Baker), which was taken out onto GONE WITHOUT (S. Price), which was inconvenienced when its hindquarters were turned out.

RACE 3 : PORT LINCOLN HOTEL / SABOIS MAIDEN PLATE - 1350 metres (Cont'd)

Shortly after the start BOLINDA VALE (L. Hopwood) rolled out slightly onto DANCING MARY (J. Potter), which was inconvenienced.

MYKONOS SUNSET (K. Bishop) was held up from the vicinity of the 400 metres until the entrance to the straight when racing behind BOLINDA VALE (L. Hopwood), which had commenced to give ground, and inside NOW YOU'RE FLYING (T. Baker).

RACE 4 : REVOLUTION ROOFING RATING 60 & OVER HANDICAP - 1350 metres

Acting on information Stewards received in relation to the treatment of VENTIC, Stewards questioned that gelding's Trainer, Mr. B. Cozamanis Jnr regarding the treatment record of the gelding in the lead up to today's event. After being provided an explanation of the treatment details by Mr. Cozamanis and after considering evidence from the TRSA Veterinary Surgeon and the on-course Veterinary Surgeon, Stewards determined that they could not be satisfied on a balance of probabilities that VENTIC had been presented to race free of a prohibited substance. Acting under the powers provided in ARR.8(m), Stewards ordered the withdrawal of VENTIC at 2.20 pm. Mr. B. Cozamanis Jnr was advised a urine sample would be taken from the gelding.

TRESETTE (A. Patterson) jumped away awkwardly.

PRIMAL INSTINCT (T. Pannell) laid out under pressure over the concluding 100 metres inconveniencing TRESETTE (A. Patterson), which was taken wider.

RACE 5 : VERO / MGA INSURANCE / SABOIS 3YO RATING 0-64 HANDICAP - 1250 metres

RIFF RAFF (E. Boyd) was slow to begin.

FREIGHT QUEEN (P. Roff) and FREE RANGE (A. Herrmann) jumped away awkwardly.

PROPSHAFT (J. Potter) raced keenly in the early and middle stages of the event.

RACE 6 : INDEPENDENT DISTILLERS RATING 0-68 HANDICAP - 1200 metres

CLUB HA HA (T. O'Donnell) raced three wide without cover throughout the event.

At the entrance to the straight KOODA DAWN (A. Herrmann) shifted out to improve and in doing so bumped MEMORY COVE (T. Baker) on two occasions.

RACE 7 : WIBBERLEY'S CHARTERED ACCOUNTANTS RATING 0-59 HANDICAP – 1000 metres

OUR DESTINATION (A. Herrmann) and ROCHIRL (P. Roff) jumped away awkwardly.

AFTONLAND (T. Baker) and PICTORELLA (A. Patterson) raced wide without cover throughout the event.

BUDDY FANTASTIC (C. Lever) made the home turn awkwardly and shifted in, becoming unbalanced for a short distance.

L. Hopwood, the rider of NO VACANCY, reported to Stewards she was concerned with the gelding's action in the straight. NO VACANCY was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the off foreleg. Mr. R. Wilkins, the Trainer of NO VACANCY, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

RACE 8 : UNIBET RATING 0-59 HANDICAP - 1350 metres

The start of this race was delayed approximately five minutes owing to SPIRIT LINE, which kicked a fence in the mounting yard, proving difficult to proceed to the start. On arrival at the barriers SPIRIT LINE was examined by the Club's Veterinary Surgeon who reported the mare to be bleeding from the outside of its near hind heel and ruled it unfit to start. Acting on this advice, Stewards withdrew SPIRIT LINE at 5.22 pm. Mr. K. Healy, the Trainer of SPIRIT LINE, was advised a warning had been placed on the mare in relation to it proving difficult en route to the barriers.

The start was further delayed owing to STAR LEGION, which was kicked by another runner on arrival at the barriers, undergoing a veterinary examination. STAR LEGION was ruled fit to start.

COSTLY ARGUMENT (P. Gatt) was slow to begin.

KELPORT (E. Boyd) and BLACK WHISKEY (K. Bishop) raced wide without cover throughout the event.

CACOPHONY (T. Pannell) made the home turn awkwardly and shifted wider on the track.

CACOPHONY (T. Pannell) was inclined to lay out under pressure over the final 200 metres and approaching inside the 50 metres shifted out onto FRENCH ACADEMY (P. Roff), which was inconvenienced when taken out onto DUBAI VENGEANCE (A. Herrmann).

On pulling up E. Boyd, the rider of KELPORT, dismounted from the gelding in the vicinity of the 1200 metres and required medical attention. E. Boyd was examined by the on-course Ambulance personnel who advised she had a muscular injury to her back and would require a medical clearance prior to riding again.

RACE 3 : TOLL EXPRESS HANDICAP - 2400 metres

Mr. T. McEvoy, the Trainer of UCHIMURA, has advised Stewards that extensive veterinary examination of UCHIMURA post-race has diagnosed a fracture to the off fore pedal bone. Mr. McEvoy advised the gelding will now be retired.
