**STIPENDIARY STEWARDS' REPORT**

**Report on Race Meeting held at Gawler Racecourse**  
**by the Gawler & Barossa Jockey Club on Wednesday, 6 March 2013**

**TRACK:** Dead 4 (*Upgraded to Good 3 at 11.30 am*)

**WEATHER:** Fine

**RAIL:** Out 4 metres entire circuit.

**RACE 1 : THE BOSTON RUN / SABOIS DISTANCE MAIDEN PLATE – 2122 metres**

Approaching the finish STING LIKE A BEE (P. Gatt) had to steady momentarily when tightened onto SHEIK MOH HAND (C. Lindop) by TOY'S OPINION (J. Bowditch), which shifted in under riding.

**RACE 2 : SO SWEET IT IS / SABOIS FILLIES & MARES MAIDEN PLATE – 1211 metres**

On jumping away CHEERS RIHANNA (B. Hoppo) shifted in abruptly onto LA BELLA BAROSSA (A. Patterson), which was forced to lose its position when tightened onto DEHAVILLAND DIVA (E. Boyd), which shifted out slightly.

In the vicinity of the 900 metres DEHAVILLAND DIVA (E. Boyd) shifted in onto LA BELLA BAROSSA (A. Patterson), which was racing keenly, resulting in LA BELLA BAROSSA having to be steadied and in doing so, shifting out, inconveniencing ASHALIA (B. Claridge). E. Boyd was reprimanded and advised in future to make a better assessment prior to commencing to shift ground.

In the vicinity of the 800 metres MOLLIE MAE (T. Zanker) commenced to race keenly and shifted out on a number of occasions, contacting LA BELLA BAROSSA (A. Patterson), which was inconvenienced.

OUR DANICHI (K. Bishop) raced wide without cover throughout the event.

From the vicinity of the 700 metres until near the 500 metres CHEERS RIHANNA (B. Hoppo) was held up when racing behind DOTING (NZ) (J. Toeroek) and inside MOLLIE MAE (T. Zanker).

In the vicinity of the 400 metres LA BELLA BAROSSA (A. Patterson) shifted in slightly onto MOLLIE MAE (T. Zanker), which had to be momentarily steadied.

**RACE 3 : THE BAKERY BOLT / SABOIS THREE-YEAR-OLD MAIDEN PLATE – 1511 metres**

SHE'S GOT SOUL (C. Lindop) and WEEKEND HUSSY (S. Price) were slow to begin.

In the vicinity of the 1200 metres MAYBE JUST MAYBE (W. Kerford) shifted in onto HEART 'N' SPIRIT (M. Neilson), which was momentarily inconvenienced. Shortly after FREE THE WIND (A. Herrmann) became awkwardly placed on the heels of MAYBE JUST MAYBE for a short distance.

SHE'S GOT SOUL (C. Lindop) raced keenly in the early and middle stages of the event.

**RACE 3 : THE BAKERY BOLT / SABOIS THREE-YEAR-OLD MAIDEN PLATE – 1511 metres**  
**(Cont'd)**

Approaching the 200 metres AUTO PILOT (D. Tourneur) shifted to the outside of BAMBADANZ (S. Westover) in an attempt to improve and in doing so made contact with HEART 'N' SPIRIT (M. Neilson), which laid back onto AUTO PILOT, resulting in AUTO PILOT being inconvenienced.

J. Frew, the rider of the third placegetter KING'S DELIGHT, was reminded of his obligations under ARR.137(b) in relation to riding his mounts out to the end of the race.

DON'T THINK DO, which performed poorly, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

**RACE 4 : GAWLER RIVER CATTLE CO RATING 0-62 HANDICAP - 1111 metres**

Acting on confirmed advice from Mr. P. Seater, the Trainer of BRIMARVI DUE FACE, that the filly had injured itself at his stables and would be unfit to race, Stewards withdrew BRIMARVI DUE FACE at 10.10 am.

NABALI (E. Boyd) shifted in on jumping away onto STELLA JEUNE (C. Lindop), which was hampered when tightened onto ALANZA (J. Potter).

In the vicinity of the 800 metres NABALI (E. Boyd) shifted in slightly onto STELLA JEUNE (C. Lindop), which was inconvenienced. Thereafter STELLA JEUNE raced keenly on the heels of NABALI whilst being steadied until inside the 700 metres.

On pulling up T. Baker, the rider of OUR SECOND CHANCE, was dislodged from the gelding. T. Baker was examined by the on-course Ambulance personnel and passed fit to fulfil his remaining engagements.

E. Boyd, the rider of NABALI, was questioned regarding her use of the whip in the straight. E. Boyd pleaded guilty to a charge under ARR.137A(5)(a)(ii) in that she used her whip in a forehand manner on more than five occasions and was fined \$250. In arriving at this penalty, Stewards took into consideration that this was the first time E. Boyd had breached this Rule.

JUST PUSH ON was examined by the Club's Veterinary Surgeon who reported an injury to the off fore superficial flexor tendon. First Aid was administered. Ms. K. McAnulty and Mr. C. Binnie, the Co-Trainers of JUST PUSH ON, were advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

**RACE 5 : THE GRAYZER GALLOP / SABOIS COLTS, GELDINGS & ENTIRES MAIDEN PLATE - 1211 metres**

KING KAVIAR (W. Kerford) and KIPROTICH (L. Stojakovic) were slow to begin.

In the vicinity of the 1100 metres MR ROSES (K. Bishop), which was laying in, shifted in onto I'D PREFERDIAMONDS (J. Frew), which was forced to steady and lose its position when tightened onto KING KAVIAR (W. Kerford), which was inconvenienced. Shortly after, approaching the 1000 metres, MR ROSES laid in onto KING KAVIAR, which became awkward for a number of strides when racing in restricted room to the inside of that gelding. MR ROSES was examined by the Club's Veterinary Surgeon who reported no visible abnormalities. Mr. K. Matson, the Trainer of MR ROSES, was advised a warning had been placed on the gelding in relation to its racing manners. K. Bishop was advised of her obligations under ARR.140(b) in reported as soon as practicable anything which might have affected the running of her horse.

**RACE 5 : THE GRAYZER GALLOP / SABOIS COLTS, GELDINGS & ENTIRES MAIDEN PLATE - 1211 metres (Cont'd)**

T. Zanker, the rider of POP THE BUBBLE, reported the gelding was inclined to lay in, in the straight. POP THE BUBBLE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

**RACE 6 : ADELAIDE MOBILE LUNCH VANS RATING 0-68 HANDICAP - 1211 metres**

NOONDIE (S. Price) and SHADY STREET (T. Baker) raced wide without cover throughout the event.

**RACE 7 : GAWLER SOUTH BAKERY / SABOIS+ RATING 0-68 HANDICAP – 2122 metres**

On jumping away WILLEGO (T. O'Donnell) and FLICKER OF OZ (D. Tourneur) came together and bumped.

BEST OF MINX (J. Frew) jumped away awkwardly and shifted in onto S'AMUSE (L. Stojakovic), which was inconvenienced.

BLEVIC LAD (J. Toeroek) was slow to begin.

MAGUS (NZ) (B. Claridge) raced keenly in the early and middle stages of the event.

S'AMUSE (L. Stojakovic) laid out from the vicinity of the 1200 metres for the remainder of the event.

L. Stojakovic, the rider of S'AMUSE, reported the mare had not travelled throughout the event and had struggled to maintain contact with the field. She added that from the vicinity of the 1200 metres S'AMUSE commenced to lay out and proved difficult to control for the remainder of the event. S'AMUSE was examined by the Club's Veterinary Surgeon who reported a lower than expected heart rate. Mr. R. Moore, the Trainer of S'AMUSE, was advised the mare would be required to perform competitively in an Official Barrier Trial prior to accepting for a future race.

SISTER SWIFT was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

**RACE 8 : MAIN STREET BAKEHOUSE CLARE CLASS 1 HANDICAP - 1511 metres**

On arrival at the barriers MS TWENTYONE was examined by the Club's Veterinary Surgeon as the mare's rider, J. Toeroek, was concerned with its action. MS TWENTYONE was ruled fit to race.

DEE JAYS DASH (S. Cahill) jumped away awkwardly.

MS TWENTYONE (J. Toeroek) was slow to begin.

Approaching the 1200 metres BARJAS (A. Herrmann) shifted in onto SUPER SILKS (NZ) (J. Matthews), which had to be steadied for a short distance and then raced keenly for a number of strides when awkwardly placed on the heels of BARJAS.

LADY SONRO (D. Stra) raced wide without cover throughout the event.

DEE JAYS DASH (S. Cahill) was inclined to lay in under pressure in the straight.

**RACE 8 : MAIN STREET BAKEHOUSE CLARE CLASS 1 HANDICAP - 1511 metres**  
**(Cont'd)**

At the entrance to the straight J. Matthews, the rider of SUPER SILKS (NZ), was accidentally struck on the body on two occasions by the whip of A. Herrmann, the rider of BARJAS.

Approaching the 200 metres ECLAIR SPARGO (D. Tourneur) shifted out to improve and inconvenienced RORY'S UNION (B. Claridge), which had commenced to give ground.

S. Cahill, the rider of DEE JAYS DASH, explained he was instructed to take a position in the race where comfortable and felt the gelding had travelled well throughout the event after he was able to obtain a position towards the rear of the field with cover. He added that at the entrance to the straight he was racing behind CHESTER DOWNS (M. Neilson), which he felt would take him into the race, however, he was unable to maintain contact with that mare. He stated shortly after straightening his mount had an inclination to lay in and inside the 200 metres shifted in and became awkwardly placed on the heels of KHALAH ROSE (J. Kah) until the vicinity of the 100 metres.
