RACE 1 : BOOKMAKERS / SABOIS MAIDEN PLATE - 1100 metres

The Stewards accepted the explanation of Mr. M. Whittle, the Trainer of MIX'N TROUBLE, for his late arrival on course.

APPLEWOOD (J. Toeroek) stood flat-footed and was very slow to begin.

SANDHILL WARRIOR (D. Tourneur) was slow to begin.

APPLEWOOD (J. Toeroek) showed a tendency to lay out throughout the event and was uncompetitive. Mr. J. Searle, the Trainer of APPLEWOOD, was advised a warning has been placed on this mare in regard to her performance.

JACK'S A TIGER TOO (J. Frew) was inclined to lay out under pressure in the straight.

MALI'S BOY, which laid out throughout the event, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

APPLEWOOD was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 2: TATIARA TRANSPORT RATING 60 & OVER HANDICAP - 1200 metres

A. Herrmann, the rider of GOOD ONE, advised Stewards that racing inside the 600 metres she believed her mount made an awkward stride and thereafter it did not feel comfortable in its action and for that reason she did not place the gelding under pressure in the straight. GOOD ONE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 3: XXXX GOLD / SABOIS MAIDEN PLATE - 1300 metres

EBONY DIVA (S. Price) was inclined to rear on jumping away.

RACE 3: XXXX GOLD / SABOIS MAIDEN PLATE - 1300 metres (Cont'd)

In the vicinity of the 1000 metres FULLY LEGAL (J. Toeroek) shifted in and away from FRENCH COLLECTION (B. Carlile), which shifted in, resulting in FULLY LEGAL being momentarily inconvenienced.

In the vicinity of the 100 metres FULLY LEGAL (J. Toeroek) rolled in under pressure despite the efforts of its rider, resulting in FRENCH COLLECTION (B. Carlile) being taken in onto SKYE LAIRD (P. Marks), which improved into a tight run to the inside of that mare, resulting in SKYE LAIRD having to be steadied and losing its position.

S. Price, the rider of EBONY DIVA, was questioned regarding his use of the whip in a forehand manner prior to the 100 metres. S. Price pleaded guilty to a charge under ARR.137A(5)(a)(ii) in that he used his whip in a forehand manner on more than five occasions prior to the 100 metres and was reprimanded.

RACE 4: GUM PARK AGISTMENT RATING 0-65 HANDICAP - 1100 metres

Shortly after the start SAINT RICH (H. McKechnie) brushed with CASINO EXIT (A. Herrmann).

In the vicinity of the 800 metres JESSIE CANGO (P. Marks) shifted in, inconveniencing FINISTAR (J. Toeroek), which had to be steadied and lost its position. P. Marks was reminded of his obligations when shifting ground.

In the vicinity of the 100 metres JESSIE CANGO (P. Marks) shifted out under pressure and bumped FINISTAR (J. Toeroek), resulting in FINISTAR being taken wider on the track. As a consequence COLLA VOCE (E. Boyd), which was racing to the outside of FINISTAR, was inconvenienced when taken wider.

Approaching the winning post FINISTAR (J. Toeroek), which was continuing to be taken wider on the track by JESSIE CANGO (P. Marks), bumped with COLLA VOCE (E. Boyd). P. Marks was severely reprimanded and advised in future to ensure he was two lengths clear prior to commencing to shift ground.

Correct Weight for this event was delayed to allow E. Boyd, the rider of the second placegetter COLLA VOCE, and Mr. D. McNamee, the Trainer of the gelding, to view the official footage from the vicinity of the 100 metres. After doing so, E. Boyd lodged an objection against J. Toeroek being declared the winner on the grounds of alleged interference from the 75 metres to the winning post. After considering the evidence, on viewing the official footage and acting on their own observations, Stewards *dismissed* E. Boyd's objection.

RACE 5 : RAY WHITE REAL ESTATE BORDERTOWN RATING 0-59 HANDICAP – 1900 metres

THE CASTLE (NZ) (B. Carlile) jumped away awkwardly and was slow to begin.

In the vicinity of the 200 metres GATALISTIC (K. Post), when taking a tight run to the inside of MARY JO (NZ) (K. Walters), was inconvenienced when MARY JO (NZ) shifted in under pressure. As a consequence VIN DE VIE (J. Potter), which was racing to the inside of GATALISTIC, was taken in onto ROCK STAR BABY (D. Tourneur), which had to be steadied, resulting in DASHAGH (E. Boyd), which was racing to the inside of ROCK STAR BABY, having to be checked and losing its position.

RACE 6: HOLCIM RATING 0-59 HANDICAP - 1300 metres

ON THE TRAIL (C. Lindop) raced wide without cover throughout the event.
