**RACE 1 : FLINDERS PORTS RATING 0-64 HANDICAP - 1000 metres**

FRAARBELLE (E. Boyd) was slow to begin.

Over the concluding stages NORTHSIDE STAR (J. Graham), which was inclined to lay in, was inconvenienced by GOLD MOSS (M. Henderson), which laid out into that gelding's running line.

JUST A BIT OF LUCK (T. O'Donnell) was inclined to lay in under pressure in the straight.

**RACE 2 : CEDUNA PHARMACY / SABOIS MAIDEN PLATE - 1200 metres**

Prior to this event ROCKY'N'BULLWINKLE, which had not raced for two years, was examined by the Club's Veterinary Surgeon and was ruled fit to race.

MR KARGER (M. Henderson) reared as the gates opened.

ROCKY'N'BULLWINKLE (B. Hoppo) was inclined to lay in under pressure in the straight.

**RACE 3 : FLINDERS PORTS RATING 0-59 HANDICAP - 1200 metres**

On arrival at the barriers BELLBOOKANDCANDLE (T. O'Donnell) required to be resaddled.

BELLBOOKANDCANDLE (T. O'Donnell) was inclined to lay in, in the straight.

KELPORT (J. Graham), which did not stretch out during the event, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

**RACE 4 : VITERRA THEVENARD CUP - 1600 metres**

E. Boyd, the rider of TESTAGOLD, was questioned in regards to her whip use in the straight. After considering her explanation she was reminded of her obligations under ARR.137A(3) in that she used her whip excessively in a backhand manner.

**RACE 5 : PHILL STEVENS / PRESCOTT SECURITIES RATING 0-64 HANDICAP -**  
**1400 metres**

On return to Scale E. Boyd, rider of JACKIE'S PAPER, was dislodged. JACKIE'S PAPER was examined by the Club's Veterinary Surgeon who reported no visible abnormalities. E. Boyd was uninjured in the incident.

COSTLY ARGUMENT, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the off hind leg. Mr. T. Trenowden, the Trainer of COSTLY ARGUMENT, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.
