Report on Race Meeting held at Morphettville Parks Racecourse by the South Australian Jockey Club on Saturday, 23 March 2013

RACE 1: DISTINCTIVE HOMES HANDICAP - 1550 metres

MISTY EYES (M. Neilson) jumped away awkwardly and raced keenly in the early and middle stages of the event.

MISTY EYES (M. Neilson) made the home turn awkwardly and shifted wider on the track.

Approaching the finish FINAL COMMAND (J. Kah) rolled out under pressure, inconveniencing MISTY EYES (M. Neilson), which was taken out onto OUI SI ATTITUDE (S. Westover).

M. Neilson, the rider of MISTY EYES, reported the gelding laid out under pressure in the straight. MISTY EYES was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

MAHMENTUM was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the near hind leg. First Aid was administered. Mr. P. Moody, the Trainer of MAHMENTUM, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

RACE 2: SPORTINGBET HANDICAP - 1550 metres

- M. Neilson, the rider of SERENA, reported the filly was inclined to lay out throughout the event. SERENA was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.
- P. Gatt, the rider of MEADOWS MIST, reported the filly had an inclination to lay out in the early and middle stages of the event and after entering the straight he had become concerned with its action and for that reason did not ride MEADOWS MIST out in his usual manner. MEADOWS MIST was examined by the Club's Veterinary Surgeon who reported the filly to be lame in the near foreleg. Mr. J. Cornell, the Trainer of MEADOWS MIST, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

RACE 2: SPORTINGBET HANDICAP - 1550 metres (Cont'd)

C. Lindop, the rider of VIKING STAR, which performed below expectations, explained the gelding had not travelled well in the early and middle stages of the event and in her opinion was reluctant to race when inside other runners. She added that in the vicinity of the 400 metres VIKING STAR was reluctant to improve to the outside of DIFFERING FORTUNES (L. Stojakovic) and to the inside of MEADOWS MIST (P. Gatt) and in her opinion had finished the race off poorly. VIKING STAR was examined by the Club's Veterinary Surgeon who reported a lower than expected heart rate.

RACE 3: PROJECTION GRAPHICS HANDICAP - 1250 metres

LOHENGRIN (S. Cahill) was slow to begin.

On jumping away OUR MIMI (P. Gatt) and LADY LIGHTFOOT (J. Holder) came together and brushed.

ABSALON (J. Bowditch) raced keenly in the early and middle stages of the event.

SENSE OF SUN (J. Toeroek) raced wide without cover throughout the event.

LOHENGRIN (S. Cahill) was held up from the vicinity of the 400 metres until inside the 300 metres when racing behind DRAGON LORD (K. Bishop) and inside MOVING MONEY (C. Lindop).

Inside the 400 metres OUR MIMI (P. Gatt) became held up for a short distance when racing on the heels of MOVING MONEY (C. Lindop) and inside ALMIGHTY BULLET (T. Baker) and approaching the 300 metres shifted out in an attempt to improve and contacted ALMIGHTY BULLET, which was inconvenienced.

Approaching the 200 metres LOHENGRIN (S. Cahill) improved into a tight run between the heels of DRAGON LORD (K. Bishop) and MOVING MONEY (C. Lindop) to obtain clear ground and in doing so took MOVING MONEY out slightly onto OUR MIMI (P. Gatt), which was hampered when tightened onto ALMIGHTY BULLET (T. Baker). S. Cahill was reprimanded and advised in future to ensure there was sufficient room prior to attempting runs.

RACE 4: BOAG'S DRAUGHT HANDICAP - 1000 metres

The start of this race was delayed approximately one minute owing to the saddle on EXCITES ZELADY having to be adjusted on arrival at the barriers.

FLASK (S. Price) was slow to begin.

WHITE ROE (C. Lindop) reared on jumping away.

EXCITES ZELADY (K. Bishop) jumped away awkwardly and shifted in onto SURFINE (A. Herrmann), which was hampered when tightened onto MURTLE TURTLE (T. Baker).

In the vicinity of the 800 metres ECLAIR BIG BANG (NZ) (D. Tourneur) shifted in when insufficiently clear of RUN LIKE REAAN (J. Kah), which reacted and shifted out abruptly to avoid the heels of ECLAIR BIG BANG (NZ) onto MURTLE TURTLE (T. Baker), which was hampered when taken wider. As a consequence BOLD SENATOR (P. Gatt) had to be steadied off the heels of MURTLE TURTLE and WHITE ROE (C. Lindop) became awkwardly placed on the heels of BOLD SENATOR for a number of strides.

RACE 4: BOAG'S DRAUGHT HANDICAP - 1000 metres (Cont'd)

D. Tourneur was found guilty of a charge of Careless Riding under ARR.137(a) and was suspended from riding in races for a period to commence at midnight on Saturday, 23 March and to conclude at midnight on Wednesday, 10 April 2013; a period of nine (9) meetings. Stewards determined that this penalty be served concurrently with the six meeting suspension D. Tourneur incurred at Oakbank on Saturday, 16 March 2013.

ALERT BERT (J. Holder) raced extremely greenly in the straight and was inclined to shift about. ALERT BERT was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RUN LIKE REAAN was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

Stewards were concerned with J. Kah, the rider of RUN LIKE REAAN's, awareness and assessment of the incident in the vicinity of the 800 metres when ECLAIR BIG BANG (NZ) (D. Tourneur) shifted in and in particular that J. Kah had not taken any action resulting in RUN LIKE REAAN having to react of its own accord to avoid the heels of ECLAIR BIG BANG (NZ). J. Kah was advised she would be required to attend a session with the Rider's Advisory Group in relation to the matter.

RACE 5: HOLDFAST INSURANCE HANDICAP - 1950 metres

CAVALRY BLACK (T. Zanker) raced wide without cover throughout the event.

MAJOR DE (M. Neilson) raced wide without cover until the vicinity of the 1000 metres.

S. Cahill, the rider of VIMA, pleaded guilty to a charge under ARR.137(c) in that he made a celebratory gesture prior to his mount passing the winning post and was fined \$100.

DUJAC, which performed poorly, was examined by the Club's Veterinary Surgeon who reported minor cramping in the near hind leg.

RACE 6 : SCHWEPPES HANDICAP - 1250 metres

MARBLE RYE (A. Herrmann) jumped away awkwardly and shifted in, contacting EXCELL SHOES (J. Toeroek).

COULDN'T AGREEMORE (D. Tourneur) jumped away awkwardly.

DEBEERSONUS (J. Holder) raced keenly in the early and middle stages of the event.

COULDN'T AGREEMORE (D. Tourneur) was held up from the vicinity of the 400 metres until inside the 200 metres when racing behind EXCELL SHOES (D. Toeroek) and inside DEBEERSONUS (J. Holder) and after obtaining clear ground, shifted out onto MARBLE RYE (A. Herrmann), which was forced to steady momentarily inside the 100 metres when taken out onto WHITTEN'S DELIGHT (P. Gatt). D. Tourneur was reprimanded and advised in future to shift ground only when entitled to do so.

Correct Weight for this event was delayed to allow A. Herrmann, the rider of the fifth placegetter MARBLE RYE, and that gelding's Trainer, Mr. G. Richards, to view the official footage in the straight.

RACE 7: SLOANS SANDS MATRICE STAKES - 1300 metres

GOLDEN PENNY (P. Gatt) was slow to begin.

JUSTIFY THAT (D. Tourneur) jumped away awkwardly.

ESSAY RAIDER (C. Lindop) was inclined to lay out and raced wide without cover throughout the event.

Inside the 300 metres JUST DISCREET (A. Patterson) was unable to obtain clear ground when racing behind PERIDUKI (J. Potter) and inside MEADOWS JIM (S. Price) and had to alter course to the outside of MEADOWS JIM to attempt to obtain clear ground. Shortly after JUST DISCREET was reluctant to take a tight run between the heels of MEADOWS JIM and ROAD WARRIOR (T. Pannell) and was only able to obtain clear ground in the vicinity of the 100 metres when ROAD WARRIOR rolled out.

Over the final 100 metres ROAD WARRIOR (T. Pannell) laid out severely. ROAD WARRIOR was examined by the Club's Veterinary Surgeon who reported no visible abnormalities. Mr. J. O'Connor, the Trainer of ROAD WARRIOR, was advised a warning had been placed on the gelding in relation to its racing manners.

- C. Lindop, the rider of ESSAY RAIDER, reported the gelding was reluctant to take up a position to the immediate outside of other runners and was inclined to lay out throughout the event. ESSAY RAIDER was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.
- S. Cahill, the rider of MOLTO BENE, explained the filly had not stretched out well during the event and was inclined to lay in throughout. He added that in the vicinity of the 400 metres he had considered an option to ease MOLTO BENE and make a run to the outside of other runners but was of the opinion the filly was not travelling well enough to attempt the manoeuvre and runs were presenting to his inside.

RACE 8 : SCHWEPPES OAKS DAY 27TH APRIL HANDICAP - 1250 metres

ZAEIMUS (T. Pannell) jumped away awkwardly and shifted out onto CAPE CLEAR (C. Lever), which was hampered and lost its position when tightened onto ONTHEHUSSLE (S. Westover), which shifted in on jumping away.

JERSEY SHORE (P. Gatt) was slow to begin.

The saddle on CARBON HUNTER (J. Holder) shifted forward in the vicinity of the 1000 metres, placing that rider at a severe disadvantage for the remainder of the event.

FULL BORE (J. Toeroek) was held up from the vicinity of the 300 metres until inside the 200 metres when racing behind ONTHEHUSSLE (S. Westover) and inside CARBON HUNTER (J. Holder).

- J. Toeroek, the rider of FULL BORE, reported the gelding was inclined to lay out over the final 200 metres. FULL BORE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.
- C. Lever, the rider of CAPE CLEAR, explained that after the interference at the start he was unable to improve his position on the gelding due to the position of JERSEY SHORE (P. Gatt). He added that when JERSEY SHORE improved in the middle stages he was able to track that gelding to obtain cover and race closer to the speed. He stated that when asked for an effort inside the 500 metres CAPE CLEAR had responded and finished the race off well, however, he was disappointed as the gelding had shown a greater turn of foot in recent starts. CAPE CLEAR was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

GENERAL:

STRATHALBYN - WEDNESDAY, 13 MARCH 2013 RACE 3: BETFAIR / SABOIS FILLIES & MARES MAIDEN PLATE - 1100 metres

Mr. J. Stephens, the Trainer of VALTONE, advised Stewards the mare had sucked wind during this event and on return to his stables was showing signs of shin soreness. He advised VALTONE would now undergo a caslick operation and would be spelled.
