STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Streaky Bay Racecourse
by Streaky Bay Racing Club on Saturday, 23 March 2013

RACE 1 : BRENTON JOYCE MEMORIAL / SABOIS MAIDEN PLATE - 1000 metres

The start of this race was delayed approximately ten minutes owing to MR KARGER's late arrival on course. Mr. S. Drewitt, the Trainer of MR KARGER, explained to Stewards that on route to the racecourse the vehicle transporting his horses to today's race meeting had experienced a flat tyre therefore delaying their time of arrival on course. MR KARGER was examined by the Club's Veterinary Surgeon on arrival on course and ruled fit to race.

LUNAR RED (D. Stra) and MR KARGER (P. Roff) bumped on jumping away.

MR KARGER (P. Roff) raced ungenerously in the middle stages of the event.

DANCING MARY (J. Frew), which shifted in, and JAWANNA (W. Kerford), which shifted out, bumped on several occasions in the straight.

B. Hoppo, the rider of SING THAT SONG, reported his mount had a tendency to hang out under pressure.

D. Stra, the rider of LUNAR RED, reported her mount hung in throughout the event and she had difficulty in riding the gelding out to the line.

RACE 2 : LETCHER & MORONEY ACCOUNTANTS / BECK'S IGA & SIP'N'SAVE
RATING 0-64 HANDICAP - 1000 metres

P. Roff, the rider of ROCHIRL, which performed below expectations, explained the mare had not travelled during the event and failed to respond to his riding. He added, in his opinion, the mare may have come to the end of its preparation. Mr. B. Clarke, the Trainer of ROCHIRL, advised stewards the mare will now be spelled. ROCHIRL was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

GOLD MOSS was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the near foreleg. Ms. A. Morrison, the Trainer of GOLD MOSS, was advised a Veterinary Certificate of Fitness would be required prior to accepting for a future trial or race.

RACE 3 : STREAKY BAY RACING CLUB'S VALUED SPONSORS RATING 0-59
HANDICAP - 1200 metres

On jumping away OUR DESTINATION (E. Boyd) and SAUCY WAVE (B. Hoppo) came together and brushed.

At the entrance to the straight OUR DESTINATION (E. Boyd) was inclined to lay in for a short distance.

RACE 3 : STREAKY BAY RACING CLUB'S VALUED SPONSORS RATING 0-59
HANDICAP - 1200 metres (Cont'd)

P. Roff, the rider of DESTONY HAWK, reported his mount hung out throughout the event. DESTONY HAWK was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

ROAD TO DANETREE, which performed poorly, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 4 : LINCOLN ESTATE WINES / DEMPSEY FEED & SADDLERY RATING 0-68
HANDICAP - 1400 metres

On arrival at the barriers Apprentice E. Boyd, the rider of TESTAGOLD, reported she was concerned with her mount's action. TESTAGOLD was examined by the Club's Veterinary Surgeon and ruled fit to start.

On jumping away TESTAGOLD (E. Boyd) and MALEBO MAGIC (W. Kerford) brushed.

KELPORT suffered a bi-lateral bleeding attack during the event. Ms. T. Kropej, the Trainer of KELPORT, was advised the gelding was suspended from racing for a period of three months in accordance with ARR.53A.

RACE 5 : XXXX GOLD STREAKY BAY COMMUNITY HOTEL CUP - 1800 metres

MISS ABERDEEN (P. Roff) was slow to begin.

RACE 6 : STREAKY BAY & CEDUNA MEAT SERVICE / BILL BUTTERFIELD FARMS
0-59 HANDICAP 1800 metres

On jumping away ROCKY'N'BULLWINKLE (W. Kerford) shifted in contacting FRENCH ACADEMY (P. Roff).

DANTE'S BEST (E. Boyd) knuckled on jumping away.

ROCKY'N'BULLWINKLE (W. Kerford) raced three wide without cover throughout event.

W. Kerford, the rider of ROCKY'N'BULLWINKLE, which performed below expectations, explained the gelding was up in class from its two previous starts. He added as the gelding was having its third start this preparation, and prior to that had not raced for two years, in his opinion the step up in distance may not have suited. ROCKY'N'BULLWINKLE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.
