THOROUGHBRED RACING S.A. LIMITED STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Gawler Racecourse by the Gawler & Barossa Jockey Club on Sunday, 24 March 2013

RACE 1 : THE TERRACE FUNCTION CENTRE / SABOIS DISTANCE MAIDEN PLATE - 2122 metres

NEPHTHYS (T. Baker) jumped away awkwardly and shifted out onto KING CADEL (M. Neilson), which was taken out onto EXALTED GEM (J. Toeroek), resulting in these two horses being inconvenienced.

NEPHTHYS (T. Baker) commenced to race ungenerously when being restrained in the early stages and continued to do so until in the vicinity of the 1500 metres.

In the vicinity of the 400 metres SHARPAY MAGIC (A. Herrmann), which had commenced to lay in, shifted in and inconvenienced NEPHTHYS (T. Baker), which had commenced to weaken, resulting in NEPHTHYS having to be steadied.

T. Baker, the rider of NEPHTHYS, explained it was his intention to attempt to take up a forward position with cover but due to the manner in which the filly raced in the early stages, he was obliged to allow her to stride and lead the event.

RACE 2 : COOPERS MAIDEN PLATE - 1716 metres

JESTALOTTERY (L. Hopwood) jumped away awkwardly and was slow to begin.

Correct Weight for this event was delayed to allow Stewards to view the official footage of the start in relation to JESTALOTTERY.

J. Holder, the rider of BAMBADANZ, explained he had been instructed and it was his intention to take up a forward position in running and whilst able to do so, when challenged by CAITLONAYA (A. Herrmann) in the vicinity of the 400 metres, the filly was under pressure and was disappointing from that point on and did not respond to his riding in the manner he anticipated. BAMBADANZ was examined by the Club's Veterinary Surgeon who reported the filly to be lame in the off foreleg. Mr. J. O'Connor, the Trainer of BAMBADANZ, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

RACE 3: JACOBS CREEK / SABOIS THREE-YEAR-OLD MAIDEN PLATE - 1511 metres

DOWN THE MIDDLE (J. Toeroek) jumped away awkwardly.

RACE 3 : JACOBS CREEK / SABOIS THREE-YEAR-OLD MAIDEN PLATE - 1511 metres (Cont'd)

Approaching the 400 metres FREE THE WIND (A. Herrmann) became held up for a short distance when racing on the heels of DAZZLING LILLY (K. Bishop) and ABLUDAY (J. Kah).

DOWN THE MIDDLE (J. Toeroek) laid in, in the straight.

J. Toeroek, the rider of DOWN THE MIDDLE, reported his mount was inclined to hang in under pressure.

K. Bishop, the rider of DAZZLING LILLY, reported her mount hung out throughout the event. DAZZLING LILLY was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 4 : SPRING GULLY FOODS / SABOIS MAIDEN PLATE - 1211 metres

The start of this race was delayed approximately two minutes owing to OUR SECOND CHANCE proving very difficult to load.

DESDANE (L. Hopwood) and SEPTEMBER STAR (S. Price) jumped away awkwardly.

GUN RULE (J. Bowditch) and FAMOUS FIGHTER (S. Cahill) contacted on jumping away.

MARION TYPE (J. Holder) jumped away very awkwardly and contacted its outside barrier gate.

In the vicinity of the 800 metres GUN RULE (J. Bowditch), when taken out slightly by DESDANE (L. Hopwood), which rolled out, was obliged to steady off the heels of MARION TYPE (J. Holder) as that filly shifted in.

KRAFAYIS (J. Kah) raced wide without cover in the early and middle stages of the event.

S. Price, the rider of SEPTEMBER STAR, explained his instructions from the wide barrier were to attempt to obtain a position mid-field with cover if possible. He stated the manner in which his horse began and the formation of the field shortly after the start prevented him from complying with his instructions and he was obliged to race further back than intended. He added that approaching the 400 metres he was disappointed for clear running when racing to the inside of LURCH (M. Neilson). He also advised that once balanced in the straight and a clear run presented, SEPTEMBER STAR found the line strongly.

GUN RULE was examined by the Club's Veterinary Surgeon who reported atrial fibrillation. Ms. M. Smith, the Trainer of GUN RULE, was advised the results of an ECG are to be forwarded to the TRSA Veterinary Surgeon and the colt would be required to perform to the Stewards' satisfaction in an Official Barrier Trial prior to accepting for a future race.

RACE 5 : ADELAIDE GALVANISING / SABOIS FILLIES & MARES RATING 0-68 HANDICAP - 1511 metres

SEE SPARKY (A. Herrmann) raced wide without cover in the early stages of the event.

Approaching the 400 metres ELSEWHERE (M. Neilson) became held up for clear ground when racing behind FRAANIKOVA (J. Kah) and to the inside of SEE SPARKY (A. Herrmann) and shortly thereafter inside the 400 metres shifted to the inside of FRAANIKOVA to improve and tightened KHALAH ROSE (K. Bishop), which had to be steadied for a number of strides. M. Neilson was severely reprimanded and advised to take greater care in future when shifting ground.

RACE 6: NEWTON JAGUARS NETBALL CLUB CLASS 1 HANDICAP - 1211 metres

Acting on advice received from the Course Farrier that EBONY DIVA had been presented in shoes, which did not comply with the provisions of ARR.141B, with particular reference to the condition of the shoes fitted to the mare, EBONY DIVA was withdrawn by Stewards at 3.38 pm. An inquiry into the reasons Mr. C. Baker presented the mare with shoes that were considered not suitable to race in was adjourned to a date to be advised.

WILD JOURNEY (B. Claridge) raced wide without cover in the early stages of the event.

IDATRICE (S. Cahill), which became held up for clear running from in the vicinity of the 500 metres when racing behind GONSKI GIRL (J. Kah) and to the inside of FRILLY SKURT (J. Toeroek), was untested for some distance and was only able to obtain clear running inside the 100 metres.

GONSKI GIRL was examined by the Club's Veterinary Surgeon who reported the mare to be lame in the near foreleg. Mr. J. MacMillan, the Trainer of GONSKI GIRL, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

RACE 7 : SANDERS FODDER & MITAVITE GAWLER TRAINERS AWARD RATING 0-75 HANDICAP - 1511 metres

In the vicinity of the 300 metres SUPER SILKS (NZ) (A. Patterson) shifted to the outside of GOLD VINTAGE (L. Hopwood) to improve and in doing so tightened SERBIAN CROWN (M. Neilson) onto TASTEOFENERGY (T. Pannell) resulting in SERBIAN CROWN being hampered for a number of strides and contacting the hindquarters of TASTEOFENERGY, which was turned. A. Patterson was found guilty of a charge of Careless Riding for shifting ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Sunday, 24 March and to conclude at midnight on Sunday, 31 March 2013; a period of three (3) meetings.

SERBIAN CROWN was examined by the Club's Veterinary Surgeon who reported near hind muscle soreness. Mr. K. Sweeney, the Trainer of SERBIAN CROWN, advised the gelding would now be spelled.

RACE 8: LYNAS AUTO GROUP / SABOIS+ RATING 0-68 HANDICAP - 2122 metres

On arrival at the barriers OUTRAGEOUS MAN was examined by the Club's Veterinary Surgeon who reported a cut to the gelding's head and ruled it unfit to race. Acting on that report, OUTRAGEOUS MAN was withdrawn by Stewards at 4.55 pm.

FLICKER OF OZ (W. Kerford) jumped away awkwardly and as a consequence was slow into stride.

HELLO DUBAI (T. O'Donnell) raced three wide without cover in the middle stages of the event.

In the vicinity of the 500 metres CISCO (NZ) (S. Price) commenced to weaken and failed to finish the race off. CISCO (NZ) was examined by the Club's Veterinary Surgeon who reported a lower than expected heart rate.

Inside the 400 metres CABLE BAY (NZ) (J. Potter) became held up for clear running for a short distance when racing behind EXOTIC GIRL (NZ) (J. Matthews).
