Report on Race Meeting held at the Port Augusta Racecourse by the Port Augusta Racing Club on Sunday, 28 April 2013

RACE 1 : PASTORAL HOTEL MOTEL / SABOIS 3YO RATING 0-61 HANDICAP - 1100 metres

SALARY CAP (J. Toeroek) jumped away very awkwardly, shifted in abruptly and as a consequence was slow to begin. SALARY CAP was examined by the Club's Veterinary Surgeon who reported no visible abnormalities. Mr. R. Irons, the Trainer of SALARY CAP, was advised a repetition of the gelding's behaviour may lead to further action being taken against it.

RACE 2 : CINEMA AUGUSTA / SABOIS MAIDEN PLATE - 1600 metres

HE'S NO MUG (S. Cahill) and CENTRE RIPPLE (L. Stojakovic) were slow to begin.

RUN FOR CASH (S. Price) jumped away awkwardly.

IMAGINARIUM (T. O'Donnell) raced wide without cover in the middle stages of the event.

From the 500 metres BOLINDA VALE (L. Hopwood) commenced to weaken. BOLINDA VALE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 3 : GULF GETAWAYS RATING 0-61 HANDICAP (Division 1) - 1200 metres

On arrival at the barriers PRETTY DANZ required resaddling.

The start of this race was delayed approximately one minute owing to TWO TIMING (NZ) proving fractious behind the barriers.

In the vicinity of the 900 metres LORD OF THE CASTLE (R. Bell) shifted in onto DESTONY HAWK (L. Hopwood), which was obliged to be restrained. R. Bell was reprimanded and advised to only shift ground when he was entitled to do so.

In the vicinity of the 850 metres NATURAL HERO (S. Westover) rolled in onto CAPTAIN FINNISS (D. Stra), which had been racing ungenerously and threw its head up when being restrained.

RACE 3: GULF GETAWAYS RATING 0-61 HANDICAP (Division 1) - 1200 metres (Cont'd)

Approaching the 400 metres WICKED ROMEO (T. O'Donnell) was obliged to steady when NATURAL HERO (S. Westover) shifted in slightly.

Over the concluding stages DESTONY HAWK (L. Hopwood) laid in under pressure.

S. Westover, the rider of NATURAL HERO, reported the gelding hung in throughout the event. NATURAL HERO was examined by the Club's Veterinary Surgeon who reported a minor laceration to the near hind fetlock.

RACE 4: ROSSIGNS & MULTIPRINT RATING 0-61 HANDICAP (Division 2) - 1200 metres

Throughout the event REGAL RUBEN (L. Stojakovic) and BELLBOOKANDCANDLE (T. O'Donnell) raced wide without cover.

Inside the 600 metres BLUEPOLES (J. Potter) commenced to give ground and in the vicinity of the 300 metres was eased out of the event. BLUEPOLES was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the near fore fetlock joint. First Aid was administered. Ms. D. Klingenboeck, the Trainer of BLUEPOLES was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

In the vicinity of the 200 metres FLO'S HAPPY (S. Cahill) was inclined to lay in under pressure. FLO'S HAPPY was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 5 : PORT AUGUSTA STEEL CENTRE RATING 0-68 HANDICAP - 1850 metres

OUT DO ME (T. O'Donnell), BRING THEM ON (J. Potter) and MOUNTAIN CLIMBER (J. Toeroek) were slow to begin.

Inside the 1400 metres OUT DO ME (T. O'Donnell) improved into a tight run inside ALICE LONGING (L. Hopwood). T. O'Donnell was advised in future to only attempt runs where there is sufficient room.

In the vicinity of the 1200 metres SHE'SMISUNDERSTOOD (T. Pannell) raced keenly for some distance.

In the vicinity of the 900 metres FANTASTIC REIGN (S. Price) shifted out off the heels of ELEGIDO (J. Kah) to obtain clear ground.

Near the 800 metres OUT DO ME (T. O'Donnell) raced keenly on the heels of YOUNG TEARAWAY (D. Stra).

Inside the 800 metres ALICE LONGING (L. Hopwood) was obliged to be restrained off the heels of SHE'SMISUNDERSTOOD (T. Pannell), which shifted out slightly.

In the vicinity of the 600 metres SHE'SMISUNDERSTOOD (T. Pannell) was inconvenienced for a short distance when ESTEBANA (E. Boyd) commenced to weaken.

THE CATCHER was examined by the Club's Veterinary Surgeon who reported a superficial ulcer in the off side eye. First Aid was administered.

RACE 6: BUSES R US RATING 60 & OVER HANDICAP - 1400 metres

On arrival at the barriers TICKET TO VEGAS was examined by the Club's Veterinary Surgeon and ruled fit to start.

SAVANNAH PRINCE (NZ) (W. Kerford) shifted out on jumping away and made contact with PACINO (S. Price).

On jumping away TRIUMPHANT ONE (J. Potter) shifted out and brushed with TONI'S CONNECTION (L. Hopwood).

On jumping away TICKET TO VEGAS (J. Toeroek) shifted in onto FRESH TELL (D. Stra), which lost its position when tightened onto CLUB HA HA (A. Patterson), which was taken out by PELEKUNU VALLEY (NZ) (S. Cahill).

Near the 200 metres SAVANNAH PRINCE (NZ) (W. Kerford) rolled out and brushed with PELEKUNU VALLEY (NZ) (S. Cahill).

In the vicinity of the 100 metres TRIUMPHANT ONE (J. Potter) was obliged to be steadied when SAVANNAH PRINCE (NZ) (W. Kerford) rolled in under pressure.

J. Toeroek, the rider of TICKET TO VEGAS, reported the gelding over-raced throughout the event.

Following this race, Jockey L. Hopwood stood herself down from her remaining ride as she was feeling unwell. L. Hopwood was advised she would require a Medical Clearance prior to presenting to ride in a future race.

RACE 7: AUGUSTA CAN & BOTTLE RECYCLERS RATING 0-74 HANDICAP - 1100 metres

KISRAK (E. Boyd) jumped away awkwardly and shifted in.

THE SHAMAN (L. Stojakovic) was slow to begin.

GUMNUTS (J. Kah) jumped away awkwardly and shifted out, brushing with LUCKY SUNDAY (J. Frew).

RACE 8: JB RADIATORS RATING 0-59 HANDICAP - 1400 metres

Ms. D. Tulk, the Trainer of TEAM LAGO, advised Stewards she would instruct Apprentice J. Kah to lead, if possible, due to the gelding's favourable barrier draw today.

PELL MELL (J. Potter) jumped away awkwardly and shifted in, brushing with EIGHT RED (T. O'Donnell).

In the vicinity of the 200 metres ORDYNSKI'S HILL (J. Toeroek) commenced to weaken quickly. ORDYNSKI'S HILL was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

- S. Cahill, the rider of LITTLE BUSTER, reported the gelding was inclined to hang out from the 250 metres.
- M. Henderson, the rider of HOLD THE ACES, was questioned regarding his use of the whip prior to the 100 metres. He pleaded guilty to a charge under ARR.137A(5)(a)(i) in that he used his whip on consecutive occasions and under ARR.137A(5)(a)(ii) in that he used his whip in a forehand manner on more than five occasions prior to the 100 metres and was suspended from riding in races for a period to commence at midnight on Sunday, 28 April and to conclude at midnight on Sunday, 5 May 2013; a period of three (3) meetings.

RACE 8: JB RADIATORS RATING 0-59 HANDICAP - 1400 metres (Cont'd)

TEAM LAGO was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.
