**STIPENDIARY STEWARDS' REPORT**

**Report on Race Meeting held at Morphettville Racecourse**  
**by the South Australian Jockey Club on Saturday, 11 May 2013**

**TRACK:** Good 3

**WEATHER:** Overcast

**RAIL:** Out 2 metres entire circuit.

**RACE 1 : NATIONAL STAKES - 1200 metres**

The start of this race was delayed approximately one minute owing to BRING A RING proving difficult to load.

OPENING BELL (M. Payne) was slow to begin.

In the vicinity of the 1000 metres BRING A RING (V. Colgan), which commenced to over-race, shifted in and brushed VIVI VELOCE (D. Dunn).

OPENING BELL (M. Payne) raced greenly and was inclined to lay out from the vicinity of the 600 metres.

At the entrance to the straight VIVI VELOCE (D. Dunn) shifted out to improve and contacted BRING A RING (V. Colgan), which was taken wider.

Shortly after the entrance to the straight THE HUNTRESS (B. Rawiller) became held up for clear ground when racing behind ZIGGLER (J. Bowditch) and to the inside of MY LITTLE FRIEND (K. McEvoy) and inside the 300 metres altered course to the inside of ZIGGLER and ICONIC (N. Hall) to obtain clear running and thereafter, in the vicinity of the 200 metres, was obliged to shift to the outside of ICONIC, which had commenced to roll in.

Approaching the 100 metres THE HUNTRESS (B. Rawiller), when improving into a run between ZIGGLER (J. Bowditch) and ICONIC (N. Hall), was initially inconvenienced as ICONIC shifted out and in the vicinity of the 50 metres was taken out onto the heels of VIVI VELOCE (D. Dunn) by ICONIC, resulting in THE HUNTRESS losing its position when having to be checked to avoid the heels of VIVI VELOCE, which rolled in marginally. As a consequence ZIGGLER was inconvenienced when taken out by THE HUNTRESS. N. Hall was reprimanded and advised to take greater care when shifting ground in future.

Correct Weight for this event was delayed to allow B. Rawiller, the rider of the third placegetter THE HUNTRESS, to view the official footage in the straight.

THE HUNTRESS was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

ICONIC was examined by the Club's Veterinary Surgeon who reported a slow recovery.

**RACE 2 : SPORTINGBET SA FILLIES CLASSIC - 2500 metres**

Mr. M. Moroney, the Trainer of YANTAR (USA), which settled outside the leader at its last start, advised Stewards he would instruct Jockey D. Dunn to settle back in the field today if possible.

## **RACE 2 : SPORTINGBET SA FILLIES CLASSIC - 2500 metres (Cont'd)**

The start of this race was delayed approximately two minutes owing to a delay interstate.

SUMMERBLISS (L. Nolen) lost its off fore plate on jumping away.

From in the vicinity of the 600 metres SUMMERBLISS (L. Nolen) shifted out and brushed with LET'S MAKE ADEAL (M. Walker) for a short distance.

In the vicinity of the 300 metres SUMMERBLISS (L. Nolen) was tightened between LET'S MAKE ADEAL (M. Walker) and WOWEE (N. Hall), which was taken out by AVERAU (R. Wheeler). As a consequence WOWEE raced in restricted room to the outside of AVERAU and contacted SUMMERBLISS for a short distance, resulting in L. Nolen being unable to fully assist his mount. R. Wheeler was reminded of his obligations when shifting ground in future.

Inside the 200 metres SUMMERBLISS (L. Nolen), after being corrected, shifted in and brushed WOWEE (N. Hall).

Correct Weight for this event was delayed to allow L. Nolen, the rider of the third placegetter SUMMERBLISS, and that filly's Trainer, Mr. M. Kent, and M. Walker, the rider of the second placegetter LET'S MAKE ADEAL, to view the official footage in the straight.

PROPER MADAM lost its off hind plate and LET'S MAKE ADEAL lost its off fore plate during the event.

P. Gatt, the rider of PROPER MADAM, was questioned regarding his use of the whip prior to the 100 metres. He pleaded guilty to a charge under ARR.137A(5)(a)(ii) in that he used his whip in a forehand manner on more than five occasions prior to the 100 metres and was reprimanded.

SUMMERBLISS was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

## **RACE 3 : QUEEN'S CUP - 2500 metres**

In the vicinity of the 800 metres SHINY BUTTONS (B. Melham) shifted out to improve and contacted MOTIVADO (GB) (S. Baster), which was taken wider.

J. Bowditch, the rider of SOUTHERN INVASION, reported his mount hung in throughout the event. SOUTHERN INVASION was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in both hind legs. Mrs. M. Ruberry, the Trainer of SOUTHERN INVASION, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

## **RACE 4 : CENTAUREA STAKES - 2009 metres**

The start of this race was delayed approximately four minutes initially owing to an interstate delay and then owing to BLUE RIBBON proving difficult to load.

OUI SI ATTITUDE (S. Price) was slow to begin.

ELSEWHERE (P. Gatt) and BLUE RIBBON (D. Dunn) contacted when both horses jumped away awkwardly.

STELLA LANTE (V. Duric) jumped away awkwardly.

#### **RACE 4 : CENTAUREA STAKES - 2009 metres (Cont'd)**

FILIAR INVICTUS (N. Hall) shifted out on jumping away and contacted TABULATED (J. Holder).

PRINCESS PEGGY (V. Colgan) knuckled on jumping away.

LAKE SENTENTIA (M. Payne) raced wide without cover throughout the event.

Approaching the 1800 metres BLUE RIBBON (D. Dunn) was obliged to be restrained for a short distance when racing inside PRINCESS PEGGY (V. Colgan), which shifted in. V. Colgan was reprimanded and advised to take greater care when shifting ground in future.

#### **RACE 5 : DARLEY LAELIA STAKES - 1600 metres**

The start of this race was delayed approximately two minutes owing to a delay interstate.

KEYARNA BLUE (NZ) (M. Walker) was slow to begin, losing two to three lengths and thereafter failed to muster early speed.

HAZARD (K. McEvoy) and COINS (V. Duric) raced keenly in the early stages.

In the vicinity of the 1000 metres COINS (V. Duric), which raced ungenerously when being restrained off the heels of MYBENZ (M. Payne), shifted out abruptly and thereafter continued to race keenly for a short distance.

In the vicinity of the 500 metres KEYARNA BLUE (NZ) (M. Walker), which improved to the outside of CANDY BRIDGE (J. Bowditch), shifted out and contacted WHITTEN'S DELIGHT (V. Colgan), turning that filly's hindquarters. Shortly thereafter, KEYARNA BLUE (NZ) was disappointed for clear ground for a short distance when racing in restricted room between WHITTEN'S DELIGHT and the heels of CANDY BRIDGE.

J. Kah, the rider of LONCAY, reported the filly was inclined to lay out during the event. LONCAY was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

#### **RACE 6 : R A LEE STAKES - 1600 metres**

Mr. L. Macdonald, the Co-Trainer of ESSAY RAIDER, advised Stewards he would instruct Jockey C. Lindop to settle the gelding back in the field today if possible.

The start of this race was delayed approximately two minutes owing to a delay interstate.

DANISH SPY (J. Holder) and LINTON (J. Mott) contacted on jumping away. At the same time ISOPACH (N. Hall) jumped away awkwardly, shifted in and contacted GOLDBYA (S. Price), which was tightened onto LINTON, resulting in LINTON losing its position.

WALL STREET (NZ) (D. Dunn) jumped away awkwardly and inconvenienced MR LOWNDES (NZ) (K. McEvoy).

ESSAY RAIDER (C. Lindop) jumped away awkwardly.

GOLDBYA (S. Price) over-raced in the early stages of the event.

In the vicinity of the 400 metres ESSAY RAIDER (C. Lindop) became awkward on the heels of RIALYA (J. Bowditch) and was obliged to alter course to the inside of that gelding.

## **RACE 6 : R A LEE STAKES - 1600 metres (Cont'd)**

D. Dunn, the rider of WALL STREET (NZ), reported his mount did not stride out freely during the event. WALL STREET (NZ) was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

C. Lindop, the rider of ESSAY RAIDER, explained shortly after entering the straight the gelding commenced to lay in and failed to respond in the manner she expected. ESSAY RAIDER was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the off foreleg. Mr. L. Macdonald and Mr. A. Gluyas, the Co-Trainers of ESSAY RAIDER, were advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

## **RACE 7 : THE DISTINCTIVE HOMES GOODWOOD - 1200 metres**

MOMENT OF CHANGE (L. Nolen) was slow to begin.

YOSEI (M. Payne) and OUTLANDISH LAD (J. Holder) shifted ground on jumping away and contacted.

JUSTIFY THAT (K. Bishop) jumped away awkwardly and shifted in, contacting ALTAR (V. Duric).

ZEDI KNIGHT (C. Symons) jumped away awkwardly.

In the vicinity of the 200 metres YOSEI (M. Payne) became held up for clear running when racing behind MEADOWS JIM (D. Tourneur) and was obliged to alter course to the inside of that gelding and JUSTIFY THAT (K. Bishop) to obtain clear running approaching the 100 metres.

In the vicinity of the 150 metres MEADOWS JIM (D. Tourneur) shifted out taking GENERAL TRUCE (N. Hall) out onto RIZIZ (S. Price), which was obliged to be checked to avoid the heels of PLATELET (B. Melham), which shifted in marginally. As a consequence OUTLANDISH LAD (J. Holder), which was following, was obliged to be steadied off the heels of RIZIZ and was untested to the line thereafter as GENERAL TRUCE rolled out into its running line. D. Tourneur was severely reprimanded and advised to take greater care when shifting ground in future.

Approaching the 100 metres MOMENT OF CHANGE (L. Nolen) shifted out to improve and inconvenienced AMAETHON (D. Lane), which had to be momentarily steadied. L. Nolen was reminded of his obligations when shifting ground in future.

L. Nolen, the rider of MOMENT OF CHANGE, explained as a consequence of being slow away he was unable to take up a forward position as intended placing him at a disadvantage. He added the gelding felt fine in its action and finished the race off well. MOMENT OF CHANGE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

B. Rawiller, the rider of FACILE TIGRE, explained in the middle stages of the event his mount was unsettled for some distance due to the composition of the field. He added the gelding had every opportunity in the straight but failed to respond to his riding and was disappointing.

P. Gatt, the rider of KARACATIS, pleaded guilty to a charge under ARR.137A(4)(b) for using his whip in an action that raised his arm above shoulder height, and was fined \$500.

## **RACE 8 : CENTREBET PROUD MISS STAKES - 1200 metres**

BONNIE MAC (NZ) (M. Walker) and ENDLESS SHADOW (V. Colgan) shifted ground on jumping away and contacted.

JUST DISCREET (D. Tourneur) was slow to begin.

MEGA QUEEN (A. Herrmann) was slow to begin, losing two to three lengths.

TARIANA (P. Gatt) over-raced in the early stages of the event.

In the vicinity of the 900 metres CLASSY CHLOE (J. Bowditch) shifted in across the running of LIONHEARTED GIRL (J. Kah), resulting in that mare becoming awkwardly placed on the heels of CLASSY CHLOE for a number of strides, having to be restrained and shifting out, making contact with TARIANA (P. Gatt). As a consequence, EMBARK (L. Nolen) became awkwardly placed on the heels of LIONHEARTED GIRL and was obliged to shift out to avoid that mare's heels. J. Bowditch was severely reprimanded and advised to take greater care when shifting ground in future and reminded of his obligations under ARR.137(d) in relation to slowing the pace.

In the vicinity of the 700 metres JUST SYBIL (L. Stojakovic) rolled in and inconvenienced TARIANA (P. Gatt).

Approaching the 400 metres JULIET'S PRINCESS (USA) (C. Lindop) was obliged to be steadied when tightened by EMBARK (L. Nolen), which shifted out. L. Nolen was reprimanded and advised to take greater care when shifting ground in future.

Inside the 200 metres BONNIE MAC (NZ) (M. Walker), which raced greenly, shifted out abruptly, resulting in EMBARK (L. Nolen) shifting out and away from that mare onto YOU CAN DANCE (B. Melham), which was inconvenienced when taken wider.

Over the concluding stages S. Price, the rider of FAMILY PORTRAIT, which became awkward inside the heels of BONNIE MAC (NZ) (M. Walker), was unable to ride his mount out fully.

P. Gatt, the rider of TARIANA, reported he was concerned with the mare's action during the event. TARIANA was examined by the Club's Veterinary Surgeon who reported the mare to be lame in the near foreleg. Mr. M. Price, the Trainer of TARIANA, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.
