RACE 1 : COOPERS BREWERY RATING 0-76 HANDICAP - 1300 metres

FACE THE RISK (L. Londregan) was slow to begin.

In the vicinity of the 1000 metres DONNIDI SULINA (NZ) (M. Walters), which was racing keenly, became awkwardly placed on the heels of IN THE CHAIR (D. Tourneur) for several strides.

In the vicinity of the 900 metres IN THE CHAIR (D. Tourneur) improved onto the heels of BROOKLYN ROADS (NZ) (K. Walters) and had to be steadied for a short distance.

RACE 2 : RICHARD RAY INSURANCE BROKERS / SABOIS FILLIES & MARES RATING
0-65 HANDICAP - 1300 metres

MY JESSY (K. Post) jumped away awkwardly.

FRILLY SKURT (J. Toeroek) slipped behind on jumping away.

At the entrance to the straight FRILLY SKURT (J. Toeroek) shifted out to improve and contacted the hindquarters of HOLLY HOLY (NZ) (M. Neilson), which was momentarily unbalanced.

After passing the winning post MADEMOISELLE DENON (A. Herrmann) shifted in onto HOLLY HOLY (NZ) (M. Neilson) resulting in M. Neilson having to take hold. A. Herrmann was reminded of her obligations when shifting ground in future.

Correct Weight for this event was delayed to allow M. Neilson, the rider of the fourth placegetter HOLLY HOLY (NZ), to view the official footage in the straight.

LOST IN DUBAI (NZ), which performed below expectations, was examined by the Club's Veterinary Surgeon who reported a slower than expected recovery.

RACE 3 : KATNOOK ESTATE MAIDEN PLATE - 1700 metres

SIDIAKOV (K. Post) jumped away awkwardly and shifted out, brushing CRAY MAN (NZ) (K. Walters).

In the vicinity of the 1400 metres LACISUM (J. Rule) shifted in onto BARRIER BOYS (T. Baker), which shifted in and away onto LAESSA (A. Herrmann), which was taken in, contacting GOGO TORA (H. McKechnie), which became unbalanced. J. Rule was reprimanded and advised in future to ensure he was sufficiently clear prior to shifting ground and to be mindful of the angle of his mount when approaching other runners.

Inside the 1300 metres BARELY A GLASS (M. Neilson) shifted in and away from SKYE LAIRD (P. Marks) onto LAESSA (A. Herrmann), which shifted in, bumping GOGO TORA (H. McKechnie).

SIDIAKOV (K. Post) raced fiercely in the early and middle stages of the event and in the vicinity of the 1100 metres, shifted in abruptly onto BARELY A GLASS (M. Neilson), which was taken in onto LOCATION GOLD (J. Toeroek), which was forced to steady.

GOGO TORA (H. McKechnie), which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 4 : KALANGADOO CUP 13 OCTOBER / SABOIS MAIDEN PLATE – 1100 metres

REGAL DENON (C. Lever) was slow to begin.

In the vicinity of the 800 metres ANGEL DOVE (H. McKechnie), in attempting to restrain to obtain cover, over-reacted, got its head up and lost ground of its own accord.

In the vicinity of the 250 metres HONEST TO GOD (L. Londregan) and MRS BRAVO (P. Marks) came together and brushed.

J. Rule, the rider of CLINICAL, reported the mare was inclined to lay out and made excess respiratory noise throughout the event and for this reason he had not ridden the gelding out in his normal manner from the 600m. CLINICAL was examined by the Club's Veterinary Surgeon who reported no visible abnormalities. Trainer Mr G. Hicks was advised a warning had been placed on the gelding in relation to its poor performance.

D. Tourneur, the rider of PRESTIGE PEARL, was questioned regarding his riding of the mare from the 600 metres. D. Tourneur explained the mare had raced flat throughout the event and was uncomfortable in its action. He added that after testing PRESTIGE PEARL in the vicinity of the 400 metres he had formed the opinion it was not going to take ground off the runner ahead and for this reason he had not ridden it out in his usual manner in the straight. After considering his explanation, D. Tourneur was advised he should ride in a manner that did not invite question and was advised of his obligations under ARR.140(b) in reporting to Stewards as soon as practicable anything which may have affected the running of his horse. PRESTIGE PEARL was examined by the Club's Veterinary Surgeon who reported no visible abnormalities

RACE 5 : PENOLA LIFE MEMBERS / SABOIS MAIDEN PLATE - 1400 metres

The start of this race was delayed two minutes owing to NATTALIETA proving difficult to load. Mr. J. Tarin, the Trainer of NATTALIETA, was advised the mare would be required to gain approval to race in an Approval Jump Out or an Official Barrier Trial prior to accepting for a future race.

POSTERGIRL BECCY (C. Puls) was slow to begin.

RACE 5 : PENOLA LIFE MEMBERS / SABOIS MAIDEN PLATE - 1400 metres (Cont'd)

NATTALIETA (P. Marks) commenced to hang out severely from the vicinity of the 400 metres. NATTALIETA was examined by the Club's Veterinary Surgeon who reported shin soreness. Mr. J. Tarin, the Trainer of NATTALIETA, was advised a Veterinary Certificate of Fitness would be required prior to gaining approval to race.

POSTERGIRL BECCY (C. Puls) which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 6 : DJ'S CRUZIN COFFEE CLASS 2 HANDICAP - 1100 metres

Inside the 600 metres BEE IN HER BONNET (A. Herrmann) and MILWAUKEE BELLE (L. Londregan) came together and brushed.

RACE 7 : PENOLA HARDWARE RATING 0-68 HANDICAP - 1700 metres

SOLITARY MAN (NZ) (M. Walters) was slow to begin.

TUSCAN RANGER (H. McKechnie) jumped away awkwardly and was slow to begin.

In the vicinity of the 1500 metres SANDHILL JETT (D. Tourneur) shifted in abruptly as it left the chute, resulting in that gelding and its rider becoming unbalanced for several strides.

TONTO'S PRIDE (M. Neilson) raced in restricted room between SANDHILL JETT (D. Tourneur) and PUZZLEMAN (J. Toeroek) from the vicinity of the 500 metres until near the 300 metres.

Correct Weight for this event was delayed to allow Stewards to review the official footage of the start in relation to TUSCAN RANGER, after its rider H. McKechnie, advised the gelding may have got its leg up when the start was effected. After taking evidence from H. McKechnie, the Starter, Mr. S. Gebert and on viewing the official footage, the Stewards determined that TUSCAN RANGER had lifted its near hind leg immediately prior to the start being effected and deemed TUSCAN RANGER to be a runner in accordance with ARR.134A.

RACE 8 : MOUNT GAMBIER & DISTRICT COMMUNITY BANK RATING 0-65 HANDICAP – 1400 metres

The start of this race was delayed approximately two minutes owing to LOTS OF DOLLARS getting its leg up after being loaded. LOTS OF DOLLARS was examined by the Club's Veterinary Surgeon and ruled fit to start.

SON OF COCO (NZ) (K. Walters) shifted out on jumping away onto TELASNIP (K. Post), which was inconvenienced when tightened onto BOYDARI (D. Tourneur).

In the vicinity of the 1100 metres ON THE TRAIL (A. Herrmann) shifted in onto STEELY RESOLVE (L. Hopwood), which had to be steadied. A. Herrmann was reprimanded and advised to only shift ground when entitled to do so in future.

Approaching the finish TELASNIP (K. Post) was forced to race in restricted room between the heels of SON OF COCO (NZ) (K. Walters) and ON THE TRAIL (A. Herrmann).
