Report on Race Meeting held at Morphettville Racecourse
by the South Australian Jockey Club on Saturday, 8 June 2013

RACE 1 : LESLIE SHORT HURDLE - 3100 metres
(Run on Morphettville Parks Track)

MACEDONIAN (NZ) (J. Hateley) landed awkwardly after jumping the hurdle near the 300 metres on the first occasion.

TRENCHTOWN (IRE) (B. Small) landed awkwardly after jumping the hurdle near the 100 metres on the first occasion.

TRENCHTOWN (IRE) (B. Small) was eased out of the event in the vicinity of the 400 metres. TRENCHTOWN (IRE) was examined by the Club's Veterinary Surgeon who reported no visible abnormalities. Mr. P. Jones, the Trainer of TRENCHTOWN (IRE), advised the gelding would now be spelled.

DUMOSA (A. Herrmann) contacted the hurdle in the vicinity of the 200 metres on the final occasion and landed awkwardly.

RACE 2 : CENTREBET HANDICAP – 1200 metres

SCALAIRE (D. Tourneur) knuckled on jumping away, shifted out and contacted SASSENKILE (B. Claridge) which was inconvenienced.

Approaching the 1000 metres SCALAIRE (D Tourneur), which raced greenly, commenced to lay in, shifted in and was obliged to steady off the heels of BEYOND REASON (C. Lindop).

MAID OF LONHRO (J. Holder) raced keenly for a short distance inside the 1000 metres when being restrained.

Shortly after the entrance to the straight ATOMIC HERO (J Maund), which was laying in, was obliged to be steadied off the heels of THE YOWIE (P. Gatt) as that horse shifted in. As a consequence, ATOMIC HERO became held up for clear running behind THE YOWIE and to the inside of MAID OF LONHRO (J. Holder) for a short distance.

RACE 2 : CENTREBET HANDICAP – 1200 metres (Cont'd)

THE CONCORDE (J Bowditch) was inclined to lay out in the straight.

C. Lindop, the rider of BEYOND REASON, reported her mount did not stretch out during the race. BEYOND REASON was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

THE YOWIE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

THE CONCORDE (J Bowditch) was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 3 : SPORTINGBET HANDICAP - 1600 metres

WARATOR (D. Tourneur) jumped away awkwardly.

J Toeroek, the rider of BREDLIGN (NZ) reported that his mount raced keenly in the early stages of the event.

B. Claridge, the rider of OUT OF COOBER was questioned regarding his use of the whip prior to the 100 metres. He pleaded guilty to a charge under ARR.137A(5)(a)(ii) in that he used his whip in a forehand manner on more than five occasions prior the hundred metres and was reprimanded.

ROAD WARRIOR was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the off foreleg. Mr. J. O' Connor, the Trainer of ROAD WARRIOR, was advised a Veterinary Certificate of fitness would be required prior to presenting for a future trial or race.

Mr R. Balfour, the co-Trainer of RIVER'S LANE, advised Stewards the gelding would now be spelled.

RACE 4 : ADELAIDE GALVANISING HANDICAP – 1050 metres

JEEPERS CREEPERS (A. Patterson) was slow to begin, losing two to three lengths.

IMPULSE BUY (A. Herrmann) jumped away awkwardly and shifted in at the same time as SPOILSPOT (K. Bishop) jumped away awkwardly and shifted out, resulting in MACCA'S MOMENT (D. Tourneur) and DONATE (S. Price) being tightened between those runners. As a consequence both runners lost their position and DONATE was severely hampered.

NULLARBOR NYMPH (J. Toeroek) laid in, in the straight.

A. Herrmann, the rider of IMPULSE BUY, reported her mount was fractious in the barriers and jumped away awkwardly. She added the gelding did not stretch out freely over the concluding stages and was inclined to lay in. IMPULSE BUY was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

J. Toeroek, the rider of NULLARBOR NYMPH, reported his mount hung in during the event. NULLARBOR NYMPH was examined by the Club's Veterinary Surgeon who reported a slow recovery.

RACE 5 : HOLDFAST INSURANCE HANDICAP – 1200 metres

TWILIGHT DANCER (D. Tourneur) raced wide without cover throughout the event.

D. Tourneur, the rider of TWILIGHT DANCER, reported his mount raced keenly in the early and middle stages of the event.

RACE 6 : ADELAIDE CASINO HANDICAP – 2024 metres

Approaching the 1800 metres ASSABOY (D. Tourneur) got its head up and raced ungenerously for a short distance.

ASSABOY (D. Tourneur) was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the near hind leg. Mr P. Blanch, the Trainer of ASSABOY, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

J. Toeroek, the rider of BOJANI reported he felt his mount may have been galloped on during the event. BOJANI (J. Toeroek) was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 7 : SLOANS SANDS HANDICAP - 1050 metres

On arrival on course FLYING PHOENIX, which had not raced since June 2011, was examined by the Club's Veterinary Surgeon and ruled fit to race.

The start of this race was delayed approximately three minutes initially owing to C. Lindop, the rider of LILGIGGLEO, who was dislodged from the gelding en route to the start being examined by the on-course Ambulance personnel and ruled fit to fulfil her riding engagement. The start was also delayed owing to the bit on ON STRIKE requiring adjustment. ON STRIKE was examined by the Club's Veterinary Surgeon and ruled fit to race.

ON STRIKE (J Kah) jumped away awkwardly, shifted in and contacted AURUMCERT (T. Pannell), which was tightened on to LILGIGGLEO (C. Lindop) which, in turn, was taken in onto FLYING PHOENIX (K. Bishop), which shifted out, resulting in the hindquarters of FLYING PHOENIX being turned. As a consequence, LILGIGGLEO lost its position.

Shortly after the entrance to the straight MEADOWS JIM (E. Boyd), became awkward on the heels of READY STEADY VETTI (C. Lever) and was obliged to be momentarily steadied.

Mr R. Balfour, the co-Trainer of EL PRADO GOLD advised Stewards the gelding would now be spelled.

ON STRIKE was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the off foreleg. Mr J MacMillan, the Trainer of ON STRIKE, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

RACE 8 : BOAG'S DRAUGHT HANDICAP – 1600 metres

MANGANESE (J. Kah) reared on jumping away and was awkward to begin.

SILENT STASH (E. Boyd) jumped away very awkwardly. SILENT STASH raced keenly in the early stages.

BALLYPATRICK (L. Stojakovic) raced wide without cover throughout the event.

RACE 8 : BOAG'S DRAUGHT HANDICAP – 1600 metres (Cont'd)

D. Tourneur, the rider of ESSENCE, reported the mare raced flat and was disappointing. ESSENCE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

E. Boyd, the rider of SILENT STASH, reported the mare hung out in the straight. SILENT STASH was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

C. Lever, the rider of CLEARLY PASSIONATE, reported the mare hung out from 1300 metres. CLEARLY PASSIONATE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

Mr N. Smart, the Trainer of SILENT STASH, was questioned regarding the mare being presented to race without a lugging bit, which is its declared gear. Mr. Smart pleaded guilty to a charge under ARR.140A for negligence in saddling and was fined \$100.

RACE 1 – LOWARA / SABOIS DISTANCE MAIDEN PLATE - 2050 metres

Stewards concluded their inquiry into D. Tourneur's ride on MO SEANS in this event. Stewards considered betting and associated records in respect of this event and viewed the horse's past performances, in particular races in which D. Tourneur was the rider. D. Tourneur was further questioned and advised to ensure he rides his mounts in a manner that does not invite question by Stewards in future.
