THOROUGHBRED RACING S.A. LIMITED STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Morphettville Parks Racecourse by the South Australian Jockey Club on Saturday, 22 June 2013

MORPHETTVILLE PARKS TRACK: Slow 7

MORPHETTVILLE TRACK: Heavy 8 WEATHER: Showery

RAIL (Morphettville Parks): Out 7 metres 1000m to Winning Post, 4 metres remainder. RAIL (Morphettville): Out 8 metres 1200m to Winning Post, 5 metres remainder.

RACE 1: LESLIE SHORT HURDLE - 3200 metres (run on Morphettville Main Track)

EXALTED GEM (N O'Shea) jumped away awkwardly.

BEST OF MINX (P Flood) jumped the hurdle near the 800 metres, on the first occasion, awkwardly.

SPARKLING VICTORY (M Kelly) contacted the hurdle near the 1000 metres and landed very awkwardly. As a consequence, BACKBURN (S Jackson) which was following, was inconvenienced.

Approaching the entrance to the straight, APOSTLE (T Ryan), BEST OF MINX (P Flood), EXALTED GEM (N O'Shea) and MALDIVES (R Cully) were eased out of the event. APOSTLE, BEST OF MINX, EXALTED GEM and MALDIVES were examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

A Lynch, the rider of BRING THEM ON was questioned regarding his use of the whip prior to the finish. He was found guilty of a charge under ARR.137A(4)(b) in that he used his arm above shoulder height on two occasions and was fined \$100.

BRING THEM ON was examined by the Club's Veterinary Surgeon who reported the filly sustained a laceration to its near fore cannon. First aid was administered.

KING TRITON was examined by the Club's Veterinary Surgeon who reported the gelding sustained an abrasion to its off hind bumper. First aid was administered.

JERVOIS (NZ) was examined by the Club's Veterinary Surgeon who reported the gelding sustained a laceration to the inside of the off fore pastern. First aid was administered.

SPARKLING VICTORY was examined by the Club's Veterinary Surgeon who reported the gelding sustained a laceration to its off hind cannon. First aid was administered.

RACE 2: DARLEY HANDICAP - 1300 metres

The start of this race was delayed approximately two minutes owing to LA CONCIERGE and TIME TO TEST proving difficult to load.

LA CONCIERGE (A Herrmann) jumped away awkwardly and was then inconvenienced when tightened between MAID OF LONHRO (J Holder) and UNSPUN (T Pannell), which both shifted ground.

In the vicinity of the 400 metres MR BACKCHAT (V Colgan) became held up for clear running for a short distance when racing between the heels of LA CONCIERGE (A Herrmann) and DESTINY GOLD (J Toeroek) and was only able to obtain clear running shortly after straightening.

Over the concluding stages, PRINT MONEY (S Westover) was obliged to be steadied and alter course to the inside of MERMAID (A Patterson), which shifted out. A Patterson was reminded of his obligations when shifting ground in future.

J Holder, the rider of MAID OF LONHRO, and S Westover, the rider of PRINT MONEY both reported that their horses were reluctant to stretch out in the underfoot conditions.

MYSTICAL MISS lost its off hind plate during the event.

MR BACKCHAT was examined by the Club's Veterinary Surgeon who reported the gelding was lame in the near hind leg. Mr T McEvoy, the Trainer of MR BACKCHAT, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

RACE 3: IRISH RACE DAY 7TH SEPTEMBER HANDICAP - 1000 metres

BASIL DA MAN, which refused to have its tongue tie fitted prior to leaving the mounting yard, proceeded to the barriers, where a final attempt was made to fit the tongue tie. As the gelding resented all attempts, it was permitted to race without a tongue tie.

The start of this race was initially delayed owing to WEEKEND SPECIAL, which was fractious in the barriers after being loaded, getting its leg caught in the barrier structure and shifting its near fore plate. WEEKEND SPECIAL was attended to by the Farrier. WEEKEND SPECIAL was also examined by the Club's Veterinary Surgeon, and ruled fit to race.

The start was further delayed owing to Stewards attempting to avoid a clash with an interstate race being covered on (Sky 1) to allow Stewards an opportunity to have this event covered by (Sky 1). As a consequence, the race was delayed approximately eight minutes.

RACE 4: ALEX MCKINNON HANDICAP - 1950 metres

FULL BORE (J Toeroek) was slow to begin.

Approaching the 400 metres, MICKEN (NZ) (L Whelan), in an attempt to improve, shifted to the outside of ZERPRISE US ALL (C Lever) and contacted FULL BORE (J Toeroek), which was taken wider.

WILLEGO was examined by the Club's Veterinary Surgeon who reported the gelding suffered a bi-lateral bleeding attack during the event. Mr S Oxlade, the Trainer of WILLEGO, was advised the gelding was suspended from racing for a period of three months in accordance with ARR.53A.

RACE 5: PEGGY MCKINNON HANDICAP - 1400 metres

The start of this event was delayed approximately three minutes owing to MONICA KATE, which proved very difficult to load and refused to load, being declared a late scratching at 2.16 pm by order of Stewards. Mr L Richards, the stable representative of Mr G Richards, was advised, in view of the filly's loading history, MONICA KATE is now suspended for a period of one month, effective midnight Saturday, 22 June 2013 and to expire at midnight on Monday, 22 July, 2013, after which date, MONICA KATE must load without delay in an official barrier trial prior to accepting for a future race. The start was also delayed owing to CAPTAIN SHARP (NZ) becoming fractious in its barrier stall and having to be examined by the Club's Veterinary Surgeon, who ruled it unfit to race. Acting on that advice, Stewards withdrew CAPTAIN SHARP (NZ) at 2.18 pm.

As a consequence of CAPTAIN SHARP (NZ) becoming fractious, it made contact with TERRAPINNA in the adjoining stall. TERRAPINNA was examined by the Club's Veterinary Surgeon who passed the gelding fit to race.

D Tourneur, the rider of YOU'RE DISCREET, was shown the vision of the closing stages of this event and reminded of his obligations in respect of riding his mounts to the finish.

BATMAN (NZ) was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 6: CENTREBET HANDICAP - 1300 metres

P Gatt, the rider of ADDICTION TO ROCK, reported that the gelding failed to stretch out over the concluding stages. ADDICTION TO ROCK was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 7: DISTINCTIVE HOMES HANDICAP - 1400 metres

In the vicinity of the 1000 metres, ALCHEMY'S EIGHT (J Frew) contacted the inside running rail and shifted out. As a consequence, GREY MUSTANG (P Gatt), which was following, became awkward on the heels of ALCHEMY'S EIGHT, had to be steadied, and became unbalanced.

PRESTIGE GLEN (C Lever) became held up and was only able to obtain clear running approaching the 200 metres.

J Toeroek, the rider of TASTEOFENERGY, reported his mount compounded badly over the final 200 metres of the race. TASTEOFENERGY was examined by the Club's Veterinary Surgeon who reported the gelding lame in the near hind leg. Mr J Croucher, the Trainer of TASTEOFENERGY, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

J Maund, the rider of MY UNCLE VINNY, reported his mount may not have backed up today. MY UNCLE VINNY was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 8: MARSH HANDICAP - 1250 metres

As Mr C McDonald, the Trainer of BUGSY, omitted to scratch this colt from the event by the time required, Stewards ordered its withdrawal from the event at 8.10 am. Mr C McDonald was found guilty of a breach of LR.19.1.1 and fined \$200.

RACE 8: MARSH HANDICAP - 1250 metres (Cont'd)

Approaching the 1100 metres, GREEN GINGER (L Whelan) was obliged to race in restricted room between ZIPALANG (K Bishop), which rolled out, and STELLA JEUNE (J Holder), which shifted in. As a consequence, GREEN GINGER was obliged to be steadied and was unable to maintain its position. J Holder, was reminded of his obligations when shifting ground in future.

J Frew, the rider of RUB DOUBT, reported his mount was inclined to lay out during the event and as he became concerned with its action in the straight, he did not proceed with his riding over the final 200 metres of the event. RUB DOUBT was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

L Whelan, the rider of GREEN GINGER, explained her instructions were to take up a forward position with cover if possible. She stated that as the gelding was a little slow to begin, and due to the positioning of STELLA JEUNE (J Holder) to her outside in the vicinity of the 1100 metres, she was unable to take up a forward position and was obliged to settle back with cover. She also added that approaching the home turn, she had considered her options, but due to the position of the field, elected to proceed with her run towards the inside and shortly thereafter, had to alter course to the outside of runners to make her run. She added the gelding did not appear to appreciate the underfoot conditions.

GREEN GINGER was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

MY UNCLE VINNY was examined by the Club's Veterinary Surgeon who reported to visible abnormalities.
