STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Gawler Racecourse
by the Gawler & Barossa Jockey Club on Wednesday, 10 July 2013

Stewards: M. Santoro (A/Chairman), A. Hayles (HT) & S Callanan (F) (Stewards), D. Southgate & N. Castle (Deputy Stewards) & Dr. P. Horridge (Veterinary Surgeon).

TRACK: Slow 6

WEATHER: Fine

RAIL: Out 5 metres 1700m to 1500m, 4 metres remainder.

RACE 1 : JACOBS CREEK DISTANCE MAIDEN PLATE - 2122 metres

VIKING EXPRESS (NZ) (T. Zanker) reared on jumping away.

IMAGINARIUM (T. O'Donnell) raced wide without cover throughout the event.

J. Toeroek, the rider of SUREFIRE, which performed below expectations, explained the gelding had travelled well in the early and middle stages, however, when placed under pressure in the vicinity of the 600 metres, failed to respond to his riding and finished the race off poorly. SUREFIRE was examined by the Club's Veterinary Surgeon who reported a lower than expected heart rate.

IMAGINARIUM was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 2 : BETTY HICKEN MEMORIAL / SABOIS + RATING 0-68 HANDICAP – 2122 metres

Mr. D. Hewitt, the Trainer of CRUZ'N NOW, advised Stewards he would instruct Jockey L. Hopwood to attempt to obtain a position further back than at its most recent starts if possible in an attempt to have the gelding finish the race off stronger.

GIMME SOME SAVINGS (B. Claridge) laid out rounding the home turn onto NAVAN LASS (J. Potter), which was obliged to alter course to the inside of that gelding's heels and in doing so shifted in onto MALDIVES (J. Maund), which had to be steadied momentarily. B. Claridge and J. Potter were reminded of their obligations when shifting ground in future.

RACE 3 : GAWLER SOUTH BAKERY / SABOIS THREE-YEAR-OLD MAIDEN PLATE – 1512 metres

LI'L NINA (J. Holder) jumped away awkwardly and shifted out, contacting WRIST WATCH (J. Frew).

THE WISEMAN (P. Gatt) raced keenly in the early stages of the event and in the vicinity of the 1100 metres improved onto the heels of WRIST WATCH (J. Frew) and shifted out, contacting KING CADEL (J. Toeroek), which was inconvenienced when taken wider.

MARKADA, which performed poorly, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 4 : KINGSFORD HOTEL / SABOIS FILLIES AND MARES MAIDEN PLATE –
1111 metres

KOODA DUCHESS (K. Bishop) shifted out on jumping away onto AURELII (T. Pannell), which lost its position when tightened onto MINAVILLA (S. Price), which shifted in.

WIDEOUT (M. Neilson) raced wide without cover throughout the event.

From the vicinity of the 500 metres until near the 400 metres MAGICAL RUBY (P. Gatt) was awkwardly placed on the heels of FRIDAY NIGHT FLING (J. Frew) and inside WIDEOUT (M. Neilson).

At the entrance to the straight JEST A JILLY (A. Patterson) was disappointed when attempting a tight run between the heels of KOODA DUCHESS (K. Bishop) and LUCY AND I LOVE IT (S. Cahill), which rolled out slightly, resulting in JEST A JILLY having to alter course to obtain clear ground.

Shortly after entering the straight KOODA DUCHESS (K. Bishop) rolled out onto AURELII (T. Pannell), which had to be momentarily steadied.

In the vicinity of the 100 metres MINAVILLA (S. Price) was accidentally struck across the head by the whip of P. Gatt, the rider of MAGICAL RUBY, and shifted out abruptly, inconveniencing PRADASTAR (J. Potter).

FRIDAY NIGHT FLING, which performed poorly, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 5 : SUNSET & SADDLES MAIDEN PLATE - 1211 metres

The start of this race was delayed approximately two minutes owing to DUNGARVAN, which contacted a gate en route to the barriers, being examined by the Club's Veterinary Surgeon on arrival at the start. DUNGARVAN was ruled fit to race.

ROCKY DIAMOND (T. Pannell) and HITCH (T. Zanker) came together and bumped on jumping away and shortly after HITCH shifted in onto DUNGARVAN (K. Bishop), which was inconvenienced.

T. Pannell, the rider of ROCKY DIAMOND, was questioned regarding his use of the whip prior to the 100 metres. He pleaded guilty to a charge under ARR.137A(5)(a)(ii) in that he used his whip in a forehand manner on more than five occasions prior to the 100 metres and was reprimanded.

T. Zanker, the rider of HITCH, reported the gelding was reluctant to stretch out throughout the event. HITCH was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the off foreleg. Mr. G. Dunn, the Trainer of HITCH, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

PRECIOUS BOOTY, which performed poorly, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 6 : SANDERS / MITAVITE CG&E RATING 0-62 HANDICAP - 1512 metres

SET ON STONE (J. Potter) and SOCIAL ASSASSIN (B. Claridge) were slow to begin.

RACE 6 : SANDERS / MITAVITE CG&E RATING 0-62 HANDICAP - 1512 metres (Cont'd)

T. O'Donnell, the rider of MOUNT NANCY, which performed poorly, explained the gelding had travelled well in the early and middle stages of the event, however, in the vicinity of the 600 metres her saddle had shifted back slightly, placing her at a disadvantage. She added that approaching the 400 metres she had placed MOUNT NANCY under pressure but it failed to respond to her riding and had finished the event off poorly. MOUNT NANCY was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 7 : BARBADOS AT DUCATOON PARK / SABOIS FILLIES & MARES RATING 0-68 HANDICAP - 1512 metres

SILENT STASH (E. Boyd) raced keenly in the early and middle stages of the event.

LONCAY (J. Kah) laid out under pressure from the vicinity of the 400 metres. LONCAY was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

M. Neilson, the rider of WINGS ON HER FEET, was questioned regarding the use of his whip prior to the 100 metres. He pleaded guilty to a charge under ARR.137A(5)(a)(ii) in that he used his whip in a forehand manner on more than five occasions prior to the 100 metres and was fined \$400.

DANZEROUND THE SUN was examined by the Club's Veterinary Surgeon who reported atrial fibrillation. Mr. J. Dunn, the Trainer of DANZEROUND THE SUN, was advised the results of an ECG are to be forwarded to the TRSA Veterinary Surgeon prior to the mare performing satisfactorily in an Official Barrier Trial prior to accepting for a future race.

RACE 8 : COOPERS RATING 0-62 HANDICAP - 1211 metres

S'AMUSE (J. Maund) and RED BEGONIA (J. Toeroek) came together and bumped on jumping away.

Shortly after entering the straight RED BEGONIA (J. Toeroek) was reluctant to take a tight run between the heels of OUR LITTLETREASURE (S. Price) and SHAABAM (T. Pannell) and approaching the 200 metres, after obtaining the run, was inclined to lay in onto the heels of OUR LITTLETREASURE. RED BEGONIA was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

In the vicinity of the 50 metres J. Toeroek, the rider of RED BEGONIA, dropped his whip when it was accidentally struck by the whip of T. Pannell, the rider of SHAABAM.

IMAGE MASTER, which performed poorly, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.
