Slow 6 from the 1800 metres to the 1000 metres
WEATHER: Fine/Windy

RAIL: Out 3 metres 850m to 450m; True remainder.

## RACE 1: ARDROSSAN FOODLAND / SABOIS TWO-YEARS-OLD \& OVER MAIDEN PLATE - 1410 metres

The start of this race was delayed approximately one minute owing to REGAL DENON refusing to load. REGAL DENON was withdrawn by Stewards at 12.01 pm . Mr. S. Turner, the Trainer of REGAL DENON, was advised the gelding would be required to load without delay in an Official Barrier Trial prior to accepting for a future race.

ODE TO CAITLIN (S. Price) jumped away awkwardly.
FLASH MAKOTO (M. Neilson) jumped away awkwardly and shifted in, bumping SONG OF THE SANDS (J. Potter).

CLUBS ARE TRUMPS (A. Patterson) raced greenly in the early and middle stages of the event.
S. Price, the rider of ODE TO CAITLIN, was questioned regarding his use of the whip prior to the 100 metres. S. Price was charged with an offence under ARR.137A(5)(a)(ii) in that he used his whip in a forehand manner on more than five occasions prior the 100 metres. He pleaded guilty and was reprimanded.

## RACE 2 : GAWLER SOUTH BAKERY/ SABOIS 2YO MAIDEN PLATE - 1055 metres

HOLY GRAIL (T. Pannell) jumped away awkwardly and shifted out, bumping TUDOR ARMOV (V. Colgan), which shifted out momentarily inconveniencing PIGGY ROYALE (S. Price).

PLANETARY (J. Holder) raced ungenerously in the early and middle stages of the event.
In the vicinity of the 600 metres MOLLY THE SNIP (J. Potter) raced ungenerously and shifted out momentarily, inconveniencing PLANETARY (J. Holder).

MAYFAIR MOGUL (C. Lindop) raced greenly in the straight.

RACE 2 : GAWLER SOUTH BAKERY/ SABOIS 2YO MAIDEN PLATE - 1055 metres (Cont'd)

In the vicinity of the 200 metres MAYFAIR MOGUL (C. Lindop), which was continuing to race greenly, had to momentarily steady away from the heels of PLANETARY (J. Holder). MAYFAIR MOGUL was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

PIGGY ROYALE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

## RACE 3 : VISION PARK AGISTMENT \& EARTHMOVING / SABOIS MAIDEN PLATE

 - 1055 metresVAIN LADY (J. Holder) was slow to begin.
LOUDANZO (J. Potter) and KOODA DUCHESS (K. Bishop) brushed on jumping away.
In the vicinity of the 600 metres MOONLIGHT FOREST (M. Neilson), which was racing ungenerously, had to steady away from the heels of STRATEGIC DANCER (C. Lindop).

OKAY OH YAY lost its near fore and near hind plates during the event. OKAY OH YAY was examined by the Club's Veterinary Surgeon who reported the filly to be lame in the off foreleg. First Aid was administered. Mr R. Balfour, the Co-Trainer of OKAY OH YAY, was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

STRATEGIC DANCER lost its near fore plate during the event.

## RACE 4 : ARDROSSAN HOTEL MOTEL / SABOIS FILLIES \& MARES MAIDEN PLATE - 1310 metres

GOD'S CHILD (J. Kah) was slow to begin.
FAITH IN MARJU was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

## RACE 5 : EMOYENI WINES RATING 0-62 HCP - 1005 metres

In the vicinity of the 800 metres SHARK EYE (J. Potter) which was racing ungenerously, shifted in, momentarily inconveniencing TIGGY (B. Claridge).

## RACE 6 : WHEATSHEAF HOTEL - PRICE RATING 0-68 HCP - 2210 metres

Acting on confirmed advice from Mrs. S. Hayes, the Trainer of BLAZING MAX, that she was having difficulty in transporting the gelding to the track, Stewards withdrew BLAZING MAX at 10.55 am .

The start of this race was delayed approximately three minutes owing to UMALUKA, which was fractious after being loaded, rearing, and having to be examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the near hind leg. Acting on that advice, Stewards withdrew UMALUKA at 2.59 pm. Mr. K. Buick, the Trainer of UMALUKA, was advised the gelding would be required to perform satisfactorily in an Official Barrier Trial prior to accepting for a future race.

## RACE 6 : WHEATSHEAF HOTEL - PRICE RATING 0-68 HCP - 2210 metres (Cont'd)

ALICE LONGING (W. Kerford) raced three wide without cover in the early stages.
In the vicinity of the 1000 metres ALICE LONGING (W. Kerford) shifted in and away from STURGIS (NZ) (S. Price), resulting in SIR PRESIDENTE (NZ) (P. Gatt), which was racing to the inside of ALICE LONGING, having to steady and lose its position.

From the entrance to the straight to the vicinity of the 200 metres, SIR PRESIDENTE (NZ) (P. Gatt) was held up for clear running when racing between the heels of BLUEY'S ESCAPE (T. Pannell) and PIERREMONT ROCKS (J. Potter).

Jockey P. Gatt was reprimanded under ARR. 91 for leaving the Jockeys' Room after his last engagement without seeking the permission of Stewards.

## RACE 7 : DARREN LLOYD SIGNS RATING 0-68 HCP - 1210 metres

Acting on confirmed advice from Mrs. S. Hayes, Trainer of TO DO MAGIC, that she was having difficulty in transporting the gelding to the track, Stewards withdrew TO DO MAGIC at 10.55 am .

The start of this race was delayed approximately two minutes owing to PIGALLE having to be re-saddled, and T. Zanker, the rider of GREEN GINGER, being concerned with that gelding's action. GREEN GINGER was examined by the Club's Veterinary Surgeon who ruled the gelding fit to race. The start of this race was further delayed owing to STRAYING TIGER kicking the back of the gates and having to be examined by the Club's Veterinary Surgeon who ruled the gelding fit to race.

PIGALLE (T. O'Donnell) jumped away awkwardly and shifted in, KOODA DAWN (K. Bishop) jumped away awkwardly and shifted out, inconveniencing USCHRIKE (S. Price), PORTICI (T. Pannell), DARK ASSASSIN (J. Toeroek), GOD'S VALLEY (C. Lindop), SEE SPARKY (E. Boyd) and SANDHILL WARRIOR (D. Tourneur). As a result, GOD'S VALLEY and SANDHILL WARRIOR lost their positions.

SEE SPARKY was examined by the Club's Veterinary Surgeon who reported a slow recovery.

## RACE 8 : TEAM WISS PTY LTD RATING 0-62 HCP - 1410 metres

In the vicinity of the 1300 meters SCRAMOGUE (S. Price) had to be momentarily steadied and lost its position when GIFT OF KNOWLEDGE (A. Patterson) shifted in and away from DEVASENT (C. Lindop) as that gelding improved to take up a forward position.

CASH JOB (D. Stra) laid out under pressure in the straight.
RUB DOUBT (J. Frew) laid out in the straight and, in the vicinity of the 200 metres, was eased out of the event. RUB DOUBT was examined by the Club's Veterinary Surgeon who reported the mare to be lame in both hind legs. Mr. K. Frew, the Co-Trainer of RUB DOUBT, was advised that a Veterinary Certificate of Fitness would be required prior to accepting for a future trial or race.

SPAIN was examined by the Club's Veterinary Surgeon who reported excess upper respiratory noise.

Mr. S. Kavanagh, Trainer of SPAIN, was advised the results of an Endoscopic examination and a Veterinary Certificate of Fitness would be required prior to presenting for a future trial or race.

## RACE 8 : TEAM WISS PTY LTD RATING 0-62 HCP - 1410 metres (Cont'd)

Jockey S. Price was reprimanded under ARR. 91 for leaving the Jockeys' Room after his last engagement without seeking the permission of Stewards.
W. Kerford, the rider of CACOPHONY, was questioned regarding his use of the whip prior to the 100 metres. W. Kerford pleaded guilty to a charge under ARR.137(A)(5)(a)(i) in that he used his whip in a forehand manner in consecutive strides prior to the 100 metres and was fined $\$ 200$. W. Kerford pleaded guilty to a further charge under ARR.137(A)(5)(a)(ii) in that he used his whip in a forehand manner on more than five occasions prior to the 100 metres and was fined $\$ 200$.
