**Report on Race Meeting held at Gawler Racecourse**

**RACE 1 : KEVIN SHEEDY IN GAWLER / SABOIS TWO-YEAR-OLD MAIDEN PLATE**  
**- 1200 metres**

MCQUEEN (B. Claridge) shifted out on jumping away and bumped CHONDRA (K. Bishop).

ALL THE TIME (A. Herrmann) was slow to begin.

Approaching the 400 metres ALADEEN (C. Lindop) was momentarily held up when racing behind TOO DISCREET (D. Tourneur) and inside CHONDRA (K. Bishop). As a consequence, BERGERON (V. Colgan), which was racing behind ALADEEN, became held up for a number of strides.

MCQUEEN (B. Claridge) laid out under pressure in the straight. MCQUEEN was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

**RACE 2 : GAWLER TAXIS / SABOIS TWO-YEAR-OLD & OVER MAIDEN PLATE**  
**- 1700 metres**

On jumping away CRYSTAL VOYAGER (A. Patterson) shifted out onto PEPE RAPIDO (NZ) (J. Frew), which was inconvenienced when tightened onto VIKING EXPRESS (NZ) (T. Zanker).

TIMELYINTERRUPTION (V. Colgan) raced keenly in the early and middle stages of the event.

In the vicinity of the 700 metres ALBONETTI (B. Claridge) improved onto the heels of KAAPRICOSA (S. Price) and had to be steadied.

Approaching the 600 metres ALBONETTI (B. Claridge) shifted in onto PEPE RAPIDO (NZ) (J. Frew), which was forced to take hold. B. Claridge was reprimanded and advised in future to ensure he was sufficiently clear prior to shifting ground.

In the vicinity of the 400 metres SCALAIRE (D. Tourneur) rolled in onto DARK FANTASY (C. Lindop), which was inconvenienced.

TIMELYINTERRUPTION, which performed poorly, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

**RACE 2 : GAWLER TAXIS / SABOIS TWO-YEARS-OLD & OVER MAIDEN PLATE**  
**- 1700 metres (Cont'd)**

D. Tourneur, the rider of SCALAIRE reported the gelding had not travelled well throughout the event, made excess respiratory noise and, in his opinion, had not handled the track condition. SCALAIRE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

**RACE 3 : PUBLICANS' DAY / SABOIS FILLIES & MARES MAIDEN PLATE - 1100 metres**

NICKS 'N' CUTS (D. Tourneur) reared on jumping away and was slow to begin.

In the vicinity of the 600 metres FLYING WEDGETAIL (J. Holder) became held up for a short distance when racing behind LA BELLA BAROSSA (T. Baker) and inside BUTTERFLY QUEEN (L. Stojakovic).

**RACE 4 : KINGSFORD HOTEL / SABOIS MAIDEN PLATE - 1200 metres**

FINAL TWIST (T. Pannell) was slow to begin.

KING CLUB (A. Patterson) and MAPLE RULES (J. Frew) raced wide without cover throughout the event.

BUHAWI (C. Lindop) commenced to weaken from the vicinity of the 500 metres and finished the event off poorly. BUHAWI was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

L. Hopwood, the rider of CHINA CLOUD, reported the filly was inclined to lay out throughout the event. CHINA CLOUD was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

**RACE 5 : THE TERRACE CLASS 1 HANDICAP - 1500 metres**

The start of this race was delayed approximately one minute owing to DITCHED getting its leg up in the barrier structure after being loaded. DITCH was examined by the Club's Veterinary Surgeon and ruled fit to start.

DOTING (NZ) (V. Colgan) jumped away awkwardly.

J. Holder, the rider of KOMOVI, reported that the gelding did not travel comfortably throughout the event and, in his opinion, had not appreciated the track condition. KOMOVI was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

**RACE 6 : GAWLER SOUTH BAKERY RATING 0-62 HANDICAP - 2100 metres**

BRUNO (T. Pannell) shifted out on jumping away, contacting MAID OF FINNISS (J. Toeroek), which was taken out, bumping NOBLE ROMP (C. Lever).

FASTIZIO (D. Tourneur) was slow to begin.

In the vicinity of the 1500 metres CRUZ'N NOW (L. Hopwood) improved onto, and clipped the heels of, BLUEY'S ESCAPE (J. Frew) when that gelding eased the pace slightly, resulting in CRUZ'N NOW losing ground.

### **RACE 6 : GAWLER SOUTH BAKERY RATING 0-62 HANDICAP - 2100 metres (Cont'd)**

In the vicinity of the 600 metres BLUEY'S ESCAPE (J. Frew) dipped for no apparent reason.

At the entrance to the straight HEURIGER (C. Lindop) shifted out to improve and, in doing so, hampered PIERREMONT ROCKS (B. Claridge), which was tightened onto MAID OF FINNISS (J. Toeroek). C. Lindop was severely reprimanded and advised in future to ensure she was sufficiently clear prior to shifting ground.

Approaching the 200 metres CRUZ'N NOW (L. Hopwood) rolled out under pressure onto HEURIGER (C. Lindop), which was taken out onto PIERREMONT ROCKS (B. Claridge), which had to be eased across that gelding's heels.

BRUNO, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported a slower than expected recovery.

### **RACE 7 : COOPERS RATING 0-68 HANDICAP - 1700 metres**

Shortly after the start K. Bishop, the rider of DUNROSSIL, lost the use of her near side iron, placing her at a disadvantage for the remainder of the event.

In the vicinity of the 400 metres ALLEZ TARA (V. Colgan) was disappointed when attempting a tight run between the heels of CALL ME BISCUIT (A. Herrmann), which rolled out slightly, and CALLMEDAN (A. Patterson), which laid in, resulting in ALLEZ TARA becoming awkwardly placed between the heels of those runners for a number of strides.

At the entrance to the straight PETIT SOEUR (C. Lindop) had difficulty obtaining clear ground when initially racing behind the heels of TRENCHTOWN (IRE) (J. Maund) and shortly after, when attempting a tight run between the heels of SEA BAILE MOR (S. Cahill) and MAJOR DE (T. Baker) was only able to obtain clear ground inside the 200 metres.

CALL ME BISCUIT lost its off hind plate during the event.

CALL ME BISCUIT was examined by the Club's Veterinary Surgeon who reported lacerations to the off hind pastern. First Aid was administered.

CALLMEDAN and FIDESDI were examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

### **RACE 8 : JACOBS CREEK CLASS 2 HANDICAP - 1100 metres**

The start of this race was delayed approximately two minutes owing to BIG WEEKEND sitting down in its barrier after being loaded. BIG WEEKEND was examined by the Club's Veterinary Surgeon and ruled fit to start.

LIMBO QUEEN (D. Tootell) was slow to begin.

In the vicinity of the 800 metres TIGGY (K. Brooks) improved onto and had to be steadied off the heels of RUSTLE (L. Hopwood) as that mare eased the pace slightly, resulting in TIGGY becoming awkwardly placed on the heels of RUSTLE until inside the 600 metres.

In the vicinity of the 500 metres ODETTE (D. Tourneur) shifted in onto RUSTLE (L. Hopwood), which had to be steadied when taken in onto the heels of BIG WEEKEND (J. Holder).

**RACE 8 : JACOBS CREEK CLASS 2 HANDICAP - 1100 metres (Cont'd)**

LADY PHOENIX (K. Bishop) hung out from the vicinity of the 600 metres and in the vicinity of the 400 metres, shifted out onto RUSTLE (L. Hopwood), which had to be steadied off the heels of ODETTE (D. Tourneur), which shifted in slightly. LADY PHOENIX was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

TIGGY (K. Brooks) laid in under pressure in the straight. TIGGY was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

**GENERAL:**

Mr. S. Burford, the Trainer of THE WISEMAN in Race 2 and Ms. S. Ratsch, the Trainer of ELEGIDO in Race 5, were reprimanded under ARR.175(p) for failing to comply with a direction of the Stewards in relation to presenting their horses in the parade ring before being presented in the mounting yard.

**RACE 5 : THE TERRACE CLASS 1 HANDICAP - 1500 metres**

On Thursday, 25 July 2013 Mr. T. Snelling, the Trainer of KOMOVI, reported to Stewards that the gelding had been examined by the stable's Veterinary Surgeon who reported a respiratory tract infection.
