#### RACE 1 : AEM CONSOLIDATED RATING 0-58 HANDICAP - 1200 metres

The start of this event was delayed approximately four minutes owing to track maintenance.

UMA WAVE, which contacted a rail en route to the barriers, was examined by the Club's Veterinary Surgeon and ruled fit to race.

UMA WAVE (K. Brooks) was slow to begin.

In the vicinity of the 500 metres UMA WAVE (K. Brooks) rolled out and brushed LADY SONRO (C. Forrest), taking that horse wider on the track.

# RACE 2 : TOSHIBA RATING 0-58 HANDICAP - 1400 metres

The start of this event was delayed approximately one minute owing to the Ambulance having some difficulty proceeding to the barriers.

LITTLE BUSTER (T. O'Donnell) jumped away awkwardly and shifted in onto OTYLIA (D. Stra), which was hampered.

K. Brooks, the rider of JESTER LOUT, reported that the gelding may have got its tongue back during the running of the event. JESTER LOUT was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

# RACE 3 : APPLIED INDUSTRIAL / SKF SABOIS MAIDEN PLATE - 1000 metres

Ms. N. Bruggemann, the Trainer of NUN'S ESPRIT, was questioned regarding the reason she had presented the mare to race without a bit lifter, which was its approved gear. After considering Ms. Bruggemann's explanation, she was reprimanded under ARR.140(A) and was permitted to race the mare without a bit lifter as one was not available on course.

The start of this event was delayed approximately five minutes owing to SUDDEN TERROR refusing to load. SUDDEN TERROR was withdrawn by order of Stewards at 2.15 pm. Prior to the announcement of Correct Weight, Stewards ordered all monies invested on SUDDEN TERROR to be refunded in full and all bets made prior to the withdrawal to be paid on the face value of the ticket, that is 6c in the dollar for the win and 7c in the dollar for the place. Mr. S. Bates, the Trainer of SUDDEN TERROR, was advised the gelding would be required to load without delay in an Official Barrier Trial or Approval to Race Jump Out prior to accepting for a future race.

Approaching the Winning Post on the first occasion ROYAL ENTITY (L. Stojakovic) raced keenly on the heels of YOUNG TEARAWAY (K. Brooks), and had to be restrained.

ROYAL ENTITY, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

# RACE 6 : EXACT MINING / BSH WASTE SOLUTIONS RATING 0-62 HANDICAP - 1600 metres
