# Report on Race Meeting held at the Penola Racecourse by the Penola Racing Club on Thursday, 12 September 2013

## RACE 1: KATNOOK ESTATE RATING 0-68 HANDICAP - 1700 metres

PICKME (J. Potter) pulled hard in the middle stages of the event.

#### RACE 2: PENOLA LIFE MEMBERS / SABOIS MAIDEN PLATE - 1400 metres

Stewards acceded to a request from Mr. R. Daniel, the Trainer of TARRAGALS SPIRIT, to permit the gelding to race in blinkers today. He advised Stewards he had inadvertently omitted to lodge the gear change by the required time. Mr. R. Daniel was fined \$200 under ARR.140B(2) for failing to lodge a gear application and stable return by the required time.

On arrival at the barriers TARRAGALS SPIRIT was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the near foreleg. Acting on that advice, Stewards withdrew TARRAGALS SPIRIT at 1.17 pm. Mr. R. Daniel, the Trainer of TARRAGALS SPIRIT, was advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

FROM THE GRAVE (A. Patterson) jumped away awkwardly.

In the vicinity of the 200 metres FASTNET KATE (J. Kah) shifted out to improve around the heels of DOUBLESIX (D. Tourneur) and as a result bumped JUST FINE (H. McKechnie) on a number of occasions.

Approaching the winning post GO GIRLFRIEND (J. Toeroek) appeared to shy at the winning post and shifted out, inconveniencing DOUBLESIX (D. Tourneur).

COPPER CABLE, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

#### RACE 3: HOLCIM PENOLA / SABOIS MAIDEN PLATE - 1700 metres

BROKEN BRIDLE (S. Cahill) stood flat-footed and as a result was slow to begin.

In the vicinity of the 400 metres MALCOLMINTHEMIDDLE (C. Lindop) accidentally dropped her whip. C. Lindop was reprimanded under ARR.137(a) for carelessness.

## RACE 4: PENOLA – WINNER OUTSTANDING CLUB AWARD / SABOIS MAIDEN PLATE – 1100 metres

The start of this race was delayed approximately two minutes owing to ROYARRA having to be resaddled on arrival at the barriers.

FALAKINO (K. Post) was slow to begin.

- C. Lindop, the rider of COURT CLOWN, reported the gelding slipped behind in the vicinity of the 350 metres.
- H. McKechnie, the rider of GO CARNEGIE, reported her mount was inclined to race greenly throughout the event. GO CARNEGIE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

VALTONE, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

#### RACE 5: COOPERS BREWERY RATING 0-76 HANDICAP - 1300 metres

SOPHROSYNE (A. Creighton) jumped away awkwardly.

LITTLE ADAM (J. Frew) and BLUE HIGHWAY (NZ) (M. Walters) were slow to begin.

#### RACE 6: FINNS FINE FOODS RATING 0-62 HANDICAP - 1100 metres

MY WAY (C. Lindop) jumped away awkwardly and shifted out, inconveniencing BOBHARREB (J. Toeroek), which was awkwardly placed on the heels of PARIS SCENE (J. Kah).

S. Cahill, the rider of KNOX, reported he was of the opinion the gelding failed to handle today's track condition. KNOX was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

ICONSEEFRAARAWAY was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the near foreleg. Ms. S. Murphy, the Trainer of ICONSEEFRAARAWAY, was advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

#### RACE 7: KALANGADOO CUP 13 OCTOBER RATING 0-62 HANDICAP - 1400 metres

SOLITARY MAN (NZ) (M. Walters) was slow to begin.

In the vicinity of the 500 metres OCEAN STREET (D. Tourneur) shifted wider on the track in an attempt to improve and as a result momentarily inconvenienced ALBATROSS (A. Patterson). D. Tourneur was reminded of his obligations when shifting ground in future.

At the entrance to the straight ALBATROSS (A. Patterson) shifted wider on the track and inconvenienced KYBY LADY (C. Lindop).

LOTS OF HEART was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.
