Report on Race Meeting held at the Mindarie-Halidon Racecourse by the Mindarie-Halidon Racing Club on Sunday, 15 September 2013

RACE 1 : MALLEE DIPPING & MULESING / SABOIS C,G & E MAIDEN PLATE – 1000 metres

On jumping away JUST A BOB (S. Price) shifted in and made heavy contact with BLUE SHORE (T. Pannell), resulting in JUST A BOB becoming unbalanced.

B. Claridge, the rider of O'KEEFE, which performed below expectations, explained he had ridden the gelding aggressively out of the gates but was beaten for early speed and was unable to obtain a more forward position as intended. He added O'KEEFE had travelled well throughout and let down in the straight but only finished the race off fairly. O'KEEFE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 2 : KELVIN WESTBROOK TRANSPORT / LOXTON IRRIGATION / SABOIS F&M MAIDEN PLATE - 1000 metres

The start of this race was delayed approximately three minutes owing to JILLY'S EDGE being resaddled in the mounting yard and DAZZLING LILLY proving difficult to load.

DAZZLING LILLY (K. Bishop) jumped away awkwardly.

On jumping away SMOKY DUBAI (D. Stra) and ONDAVINO (C. Lindop) came together and brushed.

JILLY'S EDGE (J. Potter) shifted out on jumping away tightening MAXIMUM ATTITUDE (D. Tourneur) onto DELYSE'S HONOUR (J. Toeroek).

On jumping away MISS WYNETTE (B. Claridge) and HOST WITH THE MOST (L. Hopwood) brushed.

In the vicinity of the 600 metres SMOKY DUBAI (D. Stra) shifted out, taking JILLY'S EDGE (J. Potter) wider on the track.

In the middle stages DELYSE'S HONOUR (J. Toeroek) raced ungenerously and was inclined to get its head up when being restrained.

In the vicinity of the 300 metres ONDAVINO (C. Lindop) commenced to weaken and as a result SHE'S GOT SOUL (C. Forrest) became awkwardly placed on that filly's heels and shifted in slightly at the same time as MAXIMUM ATTITUDE (D. Tourneur) shifted out slightly, resulting in heavy contact between these two runners for a number of strides. As a result SHE'S GOT SOUL contacted ONDAVINO, which was inconvenienced when its hindquarters were turned.

RACE 2 : KELVIN WESTBROOK TRANSPORT / LOXTON IRRIGATION / SABOIS F&M MAIDEN PLATE - 1000 metres

J. Toeroek, the rider of DELYSE'S HONOUR, reported the mare made the first turn awkwardly.

Correct Weight for this event was delayed to allow D. Stra, the rider of the second placegetter SMOKY DUBAI, and Mr. S. Gower, the mare's Trainer, to view the official photo for first.

RACE 3: NORM HUMPHRYS MEMORIAL / SABOIS MAIDEN PLATE - 1380 metres

The start of this race was delayed approximately two minutes owing to the late arrival of the horses at the barriers.

Approaching the 600 metres RUBY BE THERE (J. Toeroek) raced keenly and was obliged to be restrained off the heels of STRAWPEDO (C. Lindop).

In the vicinity of the 600 metres LEAD THE WITNESS (B. Claridge) shifted out taking SASHA (A. Patterson) out onto STRAWPEDO (C. Lindop), which was taken wider on the track. B. Claridge was reprimanded and advised to take greater care in future when shifting ground.

From the 300 metres to the 150 metres KRAFAYIS (S. Price) was held up when racing behind DANCER'S DREAM (J. Potter) and inside LEAD THE WITNESS (B. Claridge).

In the vicinity of the 150 metres KRAFAYIS (S. Price) laid in under pressure onto the heels of DANCER'S DREAM (J. Potter).

Over the concluding stages STRAWPEDO (C. Lindop) laid in under pressure.

L. Hopwood, the rider of SHARK EYE, reported the gelding was inclined to hang out in the straight.

Correct Weight for this event was delayed to allow S. Price, the rider of the third placegetter KRAFAYIS, to view the official footage in the straight.

RACE 4 : ZADOW WELL DRILLING / LANDMARK GREENFIELD KAROONDA RATING 0-62 HANDICAP - 1000 metres

COURTING JUSTICE, which had not raced since December 2011, was examined by the Club's Veterinary Surgeon on arrival on course who ruled the gelding fit to race.

As the gates were released CHEERS RIHANNA (D. Stra) reared and as a result was slow to begin.

SAINT SHA ROSE (K. Brooks) jumped away awkwardly.

Approaching the 600 metres BRAWNY HUNTER (W. Kerford) shifted in and away from CALIFORNIAN DEVIL (K. Bishop), which shifted in slightly, resulting in COURTING JUSTICE (C. Lindop) being inconvenienced when tightened onto DE VILAINE (T. Baker).

BRAWNY HUNTER lost its near hind plate during the event.

RACE 5 : RADIO 801-5RM / RADIO 5MU & POWER FM RATING 0-62 HANDICAP - 1800 metres

On arrival on course, at the request of its Trainer, Mr. D. O'Leary, MYSTIC FOX, which was injured in the float en route to the racecourse, was examined by the Club's Veterinary Surgeon who reported a laceration to the head and abrasions to the neck and wither. First Aid was administered. MYSTIC FOX was ruled unfit to race. Acting on that advice, Stewards withdrew MYSTIC FOX at 12.18 pm.

On jumping away CALLMEDAN (A. Patterson) and ROYAL ENTITY (T. Baker) came together and brushed.

In the middle stages ROYAL ENTITY (T. Baker) was inclined to get its head up when being restrained.

From in the vicinity of the 600 metres to the 500 metres CALLMEDAN (A. Patterson) shifted out to improve and in doing so made contact with ALLEZ TARA (J. Maund) on a number of occasions. Both riders were advised, whilst Stewards encouraged competitive riding, they should remain mindful of their obligations under the Rules in respect of Careless Riding.

Approaching the 200 metres STORM BREWING (D. Tourneur) was held up on the heels of ROYAL ENTITY (T. Baker) and inside CALLMEDAN (A. Patterson), which was inclined to shift in and as a result STORM BREWING was obliged to shift out across the heels of CALLMEDAN to obtain clear ground.

ROYAL ENTITY lost its near fore plate during the event.

RACE 6: COLLINS INDUSTRIAL / MINDARIE-HALIDON CUP - 1800 metres

Acting on confirmed advice from Ms. S. Murphy, the Trainer of FOODEATER, that the gelding was suffering from a veterinary condition and would be unfit to race, Stewards withdrew FOODEATER at 8.28 am.

On jumping away SLIPPERY NINJA (A. Patterson) and KINGNADIM (NZ) (E. Boyd) came together and brushed.

KINGNADIM (NZ) (E. Boyd) raced wide without cover in the middle stages of the event.

T. Baker, the rider of SUREFIRE, was questioned regarding his use of the whip in the straight. T. Baker pleaded guilty to a charge under ARR.137A(5)(a)(i)&(ii) in that he used his whip in a forehand manner in consecutive strides and on more than five occasions prior to the 100 metres and was fined \$300.

RACE 7 : FLEA & DOUG FULLSTON MEMORIAL RATING 0-58 HANDCIAP - 1380 metres

PAM ANN, which escaped its handler in the mounting enclosure, was examined by the Club's Veterinary Surgeon on arrival at the start who ruled the mare fit to race.

In the vicinity of the 1200 metres HOTDEAL (L. Hopwood) was inclined to race fiercely.

In the vicinity of the 1100 metres HOTDEAL (L. Hopwood), which continued to race fiercely, shifted out tightening EMBELISE (J. Potter) onto ROUGH DEAL (T. Pannell), which was taken out onto SERIOUS DANGER (J. Frew), resulting in POTLUCK (C. Lindop) being inconvenienced and having to be restrained when taken onto the heels of BRIEF HAPPINESS (W. Kerford).

RACE 7 : FLEA & DOUG FULLSTON MEMORIAL RATING 0-58 HANDCIAP - 1380 metres (Cont'd)

PAM ANN (A. Patterson) made the turn in the vicinity of the 1100 metres awkwardly and shifted very wide taking DAN'S A LADY (J. Toeroek) wider on the track.

From the vicinity of the 400 metres to the 200 metres ROUGH DEAL (T. Pannell) was held up when racing behind BRIEF HAPPINESS (W. Kerford) and inside POTLUCK (C. Lindop).

Inside the 150 metres SPIRIT OF CAPRI (K. Brooks) attempted a tight run inside HOTDEAL (L. Hopwood) and was tightened onto the inside running rail, resulting in SPIRIT OF CAPRI being forced to steady and lose its position. K. Brooks was cautioned against taking runs where in the opinion of Stewards there was insufficient room and she was advised she would be required to attend a session with the Rider's Advisory Panel with respect to the incident.

J. Frew, the rider of SERIOUS DANGER, was questioned regarding making a celebratory gesture prior to passing the winning post. He pleaded guilty to a charge under ARR.137(c) and was fined \$100.

PAM ANN, which was eased out of the event over the concluding stages, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

ROUGH DEAL, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.
