## RACE 1 : CLARE VALLEY RACING CLUB / JOINERS ARMS HOTEL / NORTH LAURA HOTEL / KERIN LANDMARK RURAL 0-68 HANDICAP - 1000 metres

LOVE A SEQUALO (J. Maund) jumped away awkwardly, shifted out and tightened SHEPHERDS TALE (L. Stojakovic) onto DABAMIRAK (D. Evans), which shifted in. As a consequence SHEPHERDS TALE lost its position.

Approaching the 200 metres JACK'S A TIGER TOO (G. Davis) was held up for clear running for a short distance between EVE'S DELIGHT (C. Forrest) and DABAMIRAK (D. Evans) and was obliged to shift to the inside of EVE'S DELIGHT to obtain clear ground.

Correct Weight for this event was delayed to allow L. Hopwood, the rider of the second placegetter FALPOLLO, to view the official photo for first.

C. Forrest, the rider of EVE'S DELIGHT, was questioned regarding her use of the whip prior to the 100 metres. C. Forrest pleaded guilty to a charge under ARR.137A(5)(a)(ii) in that she used her whip in a forehand manner on more than five occasions prior to the 100 metres and was reprimanded.

# RACE 2 : COMERCIAL HOTEL / JOSLIN FAMILY AND SPORTS CHIROPRACTIC / CALTOWIE CRANE HIRE / JAMESTOWN COUNTRY RETREAT CARAVAN ARK / SABOIS MAIDEN PLATE - 1000 metres

Mr. M. Kluske, the Trainer of ONDAVINO, which behaved in an unruly manner, reared and dislodged its rider, L. Hopwood, in the mounting yard, was advised a warning had been placed on the filly and a repetition of similar behaviour in future may lead to stronger action being taken.

Mr. S. Trenowden, the Trainer of CHANDLERY, which proved difficult to load, was advised a warning had been placed on the gelding.

# RACE 3 : KELLY TOYOTA / MURRAY PEST CONTROL JAMESTOWN / WELKE TRANSPORT / JAMESTOWN CONTAINER DEPOT / GEORGETOWN HOTEL 0-62 HANDICAP - 1340 metres

Prior to the running of this race, Jockey L. Hopwood was examined by the first aid personnel and ruled unfit to ride for the remainder of the meeting.

From in the vicinity of the 600 metres until the entrance of the straight HARRISVILLE TOFF (W. Kerford) laid out. HARRISVILLE TOFF was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

Correct Weight for this event was delayed to allow L. Stojakovic, the rider of the second placegetter HAPPYENDO, to view the official photo for first.

D. Tootell, the rider of THORNY DEVIL, which performed below expectations, explained the gelding was off the bridle throughout the event and he had to continue to encourage the gelding to maintain its position in the field and it finished the race of poorly. He added in his opinion the gelding may have come to the end of its preparation. THORNY DEVIL was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

## RACE 4: BUNDALEER WINES / MAGIC MILLIONS / CALTOWIE SHEDS / JAMESTOWN ENGINEERING AND MANUFACTURING / SABOIS MAIDEN PLATE 1340 metres

KING'S DELIGHT (G. Davis) raced keenly and was inclined to lay out in the early and middle stages.

From the 300 metres until inside the 200 metres BIG POND (J. Maund) was inclined to lay in and in the vicinity of the 200 metres rolled in and momentarily inconvenienced ENCHANTMENT QUEEN (L. Stojakovic).

G. Davis, the rider of KING'S DELIGHT, was questioned regarding his use of the whip prior to the 100 metres. G. Davis pleaded guilty to a charge under ARR.137A(5)(a)(ii) in that he used his whip in a forehand manner on more than five occasions prior to the 100 metres and was reprimanded.

# RACE 5 : CARLTON UNITED BREWERY / REG HAMS EARTHMOVING AND HAULAGE / WILLSON WOOL / RYNNES HARDWARE AND SPORTS STORE JAMESTOWN CUP - 1800 metres

FIDESDI (D. Stra) was slow to begin.

Shortly after the start DRAFTED (B. Hoppo) shifted out tightening MORE PLEASE (L. Stojakovic) onto SHEIK MOH HAND (C. Forrest) resulting in MORE PLEASE racing in restricted room and having to be steadied, losing its position.

ROYAL ENTITY (T. Zanker) raced keenly in the middle stages.

- J. Maund, the rider of TASTEOFENERGY, was questioned regarding his use of the whip prior to the 100 metres. J. Maund pleaded guilty to a charge under ARR.137A(5)(a)(i) & (ii) in that he used his whip in a forehand manner in consecutive strides and on more than five occasions prior to the 100 metres and was reprimanded for both offences.
- B. Hoppo, the rider of DRAFTED, was questioned regarding his use of the whip prior to the 100 metres. B. Hoppo pleaded guilty to a charge under ARR.137A(5)(a)(ii) in that he used his whip in a forehand manner on more than five occasions prior to the 100 metres and was reprimanded.

## RACE 6: JAMESTOWN HOTEL / REDDEN BROS / QUALITY RURAL / SWAN PHARMACIES 0-58 HANDICAP - 1200 metres

NELLAFREEZE, which had not raced since February 2012, was examined by the Club's Veterinary Surgeon on arrival on course who ruled the mare fit to race.

LE CHARMANT, which had not raced since September 2011, was examined by the Club's Veterinary Surgeon on arrival on course who ruled the gelding fit to race.

RETAIN BELIEF (B. Hoppo) and UMA WAVE (K. Brooks) were slow to begin.

BIT O' ME (D. Evans) was inclined to lay out in the middle stages.
