**RACE 1 : ADELAIDE GALVANISING INDUSTRIES / SABOIS FILLIES & MARES MAIDEN PLATE - 1400 metres**

TOO COOL TO FOOL (NZ) (C. Lindop) jumped away awkwardly and shifted out, contacting JOAMBLE (J. Kah), which was tightened onto STRAWPEDO (B. Claridge), which had been taken in by CALL ME PENNY (J. Potter), which jumped away awkwardly.

In the vicinity of the 600 metres STRAWPEDO (B. Claridge) shifted out to improve and in doing so tightened TOO COOL TO FOOL (NZ) (C. Lindop) onto JOAMBLE (J. Kah).

Inside the 400 metres STRAWPEDO (B. Claridge) shifted out to obtain clear ground and brushed TOO COOL TO FOOL (NZ) (C. Lindop) on two occasions.

S. Price, the rider of KRAFAYIS, was questioned regarding the use of his whip prior to the 100 metres. He pleaded guilty to a charge under ARR.137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

KRAFAYIS, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

**RACE 2 : ATLAS EVENT & PARTY HIRE / SABOIS MAIDEN PLATE – 1600 metres**

On jumping away TOWER OF HOMAGE (J. Potter) shifted in and contacted MAJESTIC MOMENT (M. Neilson) and shortly after shifted back out, brushing GUN RULE (D. Tournour).

TOWER OF HOMAGE (J. Potter) raced keenly in the early and middle stages of the event.

**RACE 2 : ATLAS EVENT & PARTY HIRE / SABOIS MAIDEN PLATE – 1600 metres**  
**(Cont'd)**

In the vicinity of the 1300 metres GUN RULE (D. Tourneur) shifted in when insufficiently clear of MAJESTIC MOMENT (M. Neilson) taking that gelding in onto FIGURE THIS (A. Herrmann), which was forced to check to avoid the heels of MAJESTIC MOMENT. As a consequence FIGURE THIS was taken in, contacting the hindquarters of TYPHOON ROSE (J. Bowditch), which was unbalanced. D. Tourneur was found guilty of a charge of Careless Riding under ARR.137(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Wednesday, 16 October and to conclude at midnight on Sunday, 27 October 2013; a period of five (5) meetings.

Approaching the finish EMAIL (S. Price) shifted out and away from the whip of M. Neilson, the rider of MAJESTIC MOMENT.

ELEGANT RUSH (J. Kah) laid out under pressure over the concluding stages.

GUN RULE, which performed poorly, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

**RACE 3 : ANGAS SECURITIES / SABOIS THREE-YEAR-OLD MAIDEN PLATE –**  
**1200 metres**

Acting on confirmed advice from Mr. J. Smith, the Trainer of LAST MOMENT, that the filly refused to be loaded onto the float, Stewards withdrew LAST MOMENT at 11.20 am.

SASENKILE (B. Claridge) reared on jumping away.

FATE (S. Price) shifted in on jumping away contacting BACHATA (J. Maund), which was inconvenienced when tightened onto DUSTY LADY (T. Baker).

SASENKILE (B. Claridge) raced keenly in the early and middle stages of the event and in the vicinity of the 900 metres became awkwardly placed on the heels of STACK THE TRUCK (J. Frew) for a number of strides.

DUSTY LADY (T. Baker) made the turn in the vicinity of the 900 metres awkwardly and shifted wider on the track.

BACHATA was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

**RACE 4 : INDEPENDENT DISTILLERS AUSTRALIA FOUR-YEARS-OLD & OVER**  
**CLASS 1 HANDICAP - 1200 metres**

On arrival on course CHEERS RIHANNA was examined by the Club's Veterinary Surgeon who reported a minor laceration to the near hind leg. CHEERS RIHANNA was ruled fit to race.

DAREBIN (S. Price) jumped away awkwardly.

CHEERS RIHANNA (B. Hoppo) shifted out on jumping away and brushed POWER BUTTON (J. Toeroek).

### **RACE 5 : TATSBET FOUR-YEARS-OLD & OVER MAIDEN PLATE - 1200 metres**

On arrival on course TOKEN ONE was examined by the Club's Veterinary Surgeon who reported the gelding had injured itself in the float en route to the course and was unfit to race. Acting on that advice, Stewards withdrew TOKEN ONE at 12.15 pm.

THE MONKEY MAN (J. Bowditch) jumped away awkwardly.

OUR SENTIMENT (J. Potter) was slow into stride and raced keenly in the early and middle stages of the event.

In the vicinity of the 600 metres RODNEY ROADKILL (A. Herrmann) shifted out abruptly across the heels of PIERREMONT (S. Cahill) onto DASHING PEDRILLE (B. Claridge), which was inconvenienced when taken wider on the track. RODNEY ROADKILL continued to lay out for the remainder of the event. RODNEY ROADKILL was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

### **RACE 6 : ADVERTISER NEWSPAPERS CLASS 2 HANDICAP - 1050 metres**

LATIN HERO (T. Pannell) was inclined to rear on jumping away.

J. Frew, the rider of BELSYND, which performed poorly, explained the gelding felt uncomfortable in its action from the vicinity of the 600 metres and for that reason he did not ride BELSYND out in his normal manner in the straight. BELSYND was examined by the Club's Veterinary Surgeon who reported a penetration wound to the frog on the off hind hoof. First Aid was administered. Mrs. H. Lehmann, the Trainer of BELSYND, was advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

### **RACE 7 : COOPERS RATING 0-62 HANDICAP - 1600 metres**

LEAD THE WITNESS (B. Claridge) was slow to begin.

LEAD THE WITNESS (B. Claridge) laid in under pressure in the straight.

### **RACE 8 : JACOBS CREEK FOUR-YEARS-OLD & OVER RATING 0-62 HANDICAP – 1400 metres**

Acting on confirmed advice from Mr. N. Smart, the Trainer of BACK ON TARGET, that the gelding was suffering from the onset of a virus, Stewards withdrew BACK ON TARGET at 9.26 am.

On arrival on course PORTICI was examined by the Club's Veterinary Surgeon who reported an abrasion to the near side hip and foreleg. PORTICI was ruled fit to race.

On arrival on course POP STREET was examined by the Club's Veterinary Surgeon who reported some filling and an old abrasion over the off side knee. POP STREET was ruled fit to race.

Mr. T. McEvoy, the Trainer of POP STREET, put a submission to Stewards the gelding be withdrawn from this event due to the track upgrade. Stewards acceded to this request and withdrew POP STREET at 2.50 pm.

MONEY BAGS (J. Matthews) shifted in on jumping away and brushed WILDER WILDER (J. Kah). Shortly after TRIUMPHANT ONE (C. Lindop) shifted out abruptly, inconveniencing WILDER WILDER and MONEY BAGS.

**RACE 8 : JACOBS CREEK FOUR-YEARS-OLD & OVER RATING 0-62 HANDICAP –  
1400 metres (Cont'd)**

WILDER WILDER (J. Kah) raced keenly throughout the event.

ROCK ON RENNIE (D. Evans) raced three wide without cover throughout the event and laid in under pressure in the straight.

NEVER SCENE (J. Bowditch) was inclined to lay in over the concluding stages.

C. Lindop, the rider of TRIUMPHANT ONE, reported the gelding laid out throughout the event. TRIUMPHANT ONE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.
