

THOROUGHBRED RACING S.A. LIMITED
STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Morphettville Racecourse
by the South Australian Jockey Club on Saturday, 12 October 2013

(Upgraded to Good 3 @ 1.11 pm, retrospective to Race 1)

WEATHER: Fine

RAIL: Out 4 metres 1800m to 1200m, 6 metres remainder.

RACE 1 : BRIDGESTONE AUSTRALIA HANDICAP - 1200 metres

Mr L Macdonald, the Co-Trainer of ESSAY RAIDER, advised Stewards prior to the event that he would instruct Jockey C Lindop to ride the gelding more aggressively and attempt to obtain a handy position but to avoid leading in the event.

ESSAY RAIDER (C Lindop) jumped away very awkwardly, shifted out and contacted CABLE BAY (NZ) (J Potter), which in turn made contact with LAST DAY (NZ) (S Price).

ENDLESS SHADOW (H Coffey) over-raced in the early stages of the event.

J Toeroek, the rider of AURUMCERT, reported his mount over-raced in the early stages.

Following this race, the track was upgraded to a Good 3 at 1.11 pm, retrospective to Race 1.

RACE 2 : PRS CONVEYANCING HANDICAP - 1520 metres

In the vicinity of the 300 metres FIND A MOMENT (J Potter) improved to the outside of HEART OF ETERNITY (J Toeroek), which shifted out due to DESDANE (K Mallyon) shifting out slightly, resulting in FIND A MOMENT being hampered and taken out onto the heels of CLEARLY PASSIONATE (J Matthews).

DESDANE shifted its off hind plate during the event.

MAGIC TIGRESS lost its near fore plate during the event.

DESDANE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 3 : THE LEUKAEMIA FOUNDATION HANDICAP - 2020 metres

As no senior rider was available to replace A Herrmann on POWER TO POSSESS, Stewards gave permission for apprentice J Toeroek to ride the gelding.

RACE 3 : THE LEUKAEMIA FOUNDATION HANDICAP - 2020 metres (continued)

In the vicinity of the 1600 metres RUSSIAN ROCKER (GB) (L. Meech), which had commenced to race very keenly, became awkward on the heels of SIERRA SKIES (K Mallyon) and shifted out to avoid that mare's heels. As a result PERFECT LENGTH (S Price), which was following, clipped the heels of RUSSIAN ROCKER (GB) and stumbled.

Approaching the 400 metres WOTZITWORTH (H Coffey), which commenced to weaken, was obliged to steady and lose its position when tightened between SIERRA SKIES (K Mallyon) and GOSSIP GURU (C Lindop), which shifted out slightly.

In the vicinity of the 400 metres GOSSIP GURU (C Lindop) became held up for clear running for a number of strides behind POWER TO POSSESS (J Toeroek).

PERFECT LENGTH and MOSSEGO were examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 4 : HILL SMITH STAKES - 1800 metres

THOMASON (M Neilson) and GAMBLIN' GURU (C Lindop) jumped away awkwardly and shifted ground. As a consequence, EMPIRE ROCK (S Price) and SUPER FUN (S Cahill), which knuckled on jumping, were tightened, made contact and lost their positions. As a result the hindquarters of GAMBLIN' GURU were turned.

A Herrmann, the rider of CHONDRA, reported the gelding over-raced during the event.

B Claridge, the rider of BERGERON, was questioned regarding his use of the whip prior to the 100 metres. B Claridge pleaded guilty to a charge under ARR.137A(5)(a)(ii) in that he used his whip in a forehand manner on more than five occasions prior to the 100 metres and was fined \$200.

Correct Weight for this event was delayed to permit C Lindop, the rider of the second placegetter GAMBLIN' GURU, and that gelding's Co-Trainer Mr L Macdonald, to view the official footage over the concluding 200 metres.

RACE 5 : LEUKAEMIA FOUNDATION PATIENT VILLAGE HANDICAP - 1050 metres

BRAVE JOURNEY (J Frew) jumped away awkwardly and shortly thereafter was inconvenienced by RAKS MCLAREN (J Kah), which was taken in by CALIFORNIAN DEVIL (J Matthews).

NORDIC MONARCH raced wide without cover throughout the event.

In the vicinity of the 200 metres BRAVE JOURNEY (J Frew) raced in restricted room inside STRAVINSKY CODE (T Baker), which was taken in by CALIFORNIAN DEVIL (J Matthews) and was only able to ride his mount out fully from in the vicinity of the 100 metres. J Matthews was reminded of his obligations when shifting ground in future.

CALIFORNIAN DEVIL (J Matthews) was inconvenienced over the concluding stages by SPOILSPOT (H Coffey), which shifted in. H Coffey was reminded of his obligations, when shifting ground in future.

BRAVE JOURNEY was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 6 : THE CROWS FOUNDATION HANDICAP - 1600 metres

CHIEFTAIN JACK was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 7 : SEELEY INTERNATIONAL HANDICAP - 1200 metres

BURNRO and IT AND A BIT, which got away from their handlers in the parade ring, were captured, examined by the Club's Veterinary Surgeon and ruled fit to race.

BURNRO (J Kah) jumped away very awkwardly and shifted in abruptly onto HOUSE OF WAX (T Pannell), which was tightened onto CLASSY JACK (K Mallyon), resulting in IT AND A BIT (S Price) being tightened onto EXCITES ZELADY (A Herrmann) and IT AND A BIT losing its position.

TYPHOON (J Toeroek) shifted out shortly after the start and tightened HALL OF PEACE (C Lindop) onto EXCITES ZELADY (A Herrmann), resulting in HALL OF PEACE clipping the heels of TYPHOON.

IT AND A BIT (S Price) raced ungenerously in the middle stages of the event.

HOUSE OF WAX (T Pannell) raced greenly throughout the event.

In the vicinity of the 100 metres TYPHOON (J Toeroek) had to be momentarily steadied to avoid the heels of CLASSY JACK (K Mallyon), which rolled out.

HALL OF PEACE was examined by the Club's Veterinary Surgeon who reported the filly to be lame in the near hind leg. Mr. G Young, the Trainer of HALL OF PEACE, was advised a Veterinary Certificate of Fitness would be required prior to presenting the filly for a future trial or race.

CLASSY JACK was examined by the Club's Veterinary Surgeon who reported the gelding had sustained a laceration to its near fore pastern. First Aid was administered.

RACE 8 : JOHN SPAVIN MEMORIAL HANDICAP - 1200 metres

Mr P Blanch, the Trainer of WALKINGAROUNDMONEY, advised Stewards he would instruct Apprentice J Toeroek to attempt to settle the gelding back in the field from its wide barrier to allow the gelding to finish its race off.

In the vicinity of the 900 metres COLLA VOCE (E Boyd) became buffeted between USTINOV'S FURY (J Potter) and SNIP 'N' RUN (J Frew), when both shifted ground.

In the vicinity of the 400 metres FEAR THE FAITH (A Herrmann) became awkward on the heels of AQUIA CREEK (W Kerford), which rolled in.

In the vicinity of the 300 metres ON A DREAM (C Lindop) became held up between the heels of MY UNCLE VINNY (J Maund) and SWIFT SHAMROCK (J Childs) and was only able to obtain clear running in the vicinity of the 200 metres.

Approaching the 200 metres WALKINGAROUNDMONEY (J Toeroek) rolled in and tightened MY UNCLE VINNY (J Maund) onto SWIFT SHAMROCK (J Childs). Shortly thereafter, in the vicinity of the 200 metres, COLLA VOCE (E Boyd) improved to the outside of SWINGING SOLDIER (K Mallyon), which initially laid in but rolled out when being corrected. As a consequence COLLA VOCE was taken out by SWINGING SOLDIER and tightened SWIFT SHAMROCK onto MY UNCLE VINNY, which raced in restricted room to the inside of WALKINGAROUNDMONEY, resulting in SWIFT SHAMROCK having to be checked, losing its position. E Boyd and J Toeroek were severely reprimanded and advised to take greater care when shifting ground in future and K Mallyon was reminded of her obligations when her mounts commence to shift ground.
