RACE 1 : JOANNE'S ESPRESSO EXPRESS / SABOIS MAIDEN PLATE - 1100 metres

The start of this race was delayed approximately two minutes owing to the late arrival of the horses at the start.

MONICA'S MACHINE (M. Neilson) was slow to begin.

GRAHAM'S GIFT (B. Claridge) stood flat-footed and was very slow to begin.

GRAHAM'S GIFT was examined by the Club's Veterinary Surgeon who reported no visible abnormalities. Mrs. S. Jaensch, the Trainer of GRAHAM'S GIFT, was advised a warning has been placed on the filly in regard to it being slow to begin.

RACE 2 : S. & S. LOGISTICS / SABOIS MAIDEN PLATE – 1300 metres

SOLACE (J. Frew) knuckled on jumping away.

M. Neilson, the rider of DENNIE, reported the mare never felt comfortable throughout the event. DENNIE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

DEV was examined by the Club's Veterinary Surgeon who reported speedy cuts on both hocks.

RACE 3 : THOMAS, DEGARIS & CLARKSON / SABOIS MAIDEN PLATE – 1700 metres

DOUBLESIX (J. Toeroek) was slow to begin.

HOLABONITA (P. Marks) jumped away awkwardly and shifted out, bumping CRAY MAN (NZ) (K. Post).

HOLABONITA (P. Marks) was inclined to lay out throughout the event.

RACE 3 : THOMAS, DEGARIS & CLARKSON / SABOIS MAIDEN PLATE – 1700 metres (Cont'd)

In the vicinity of the 600 metres HOLABONITA (P. Marks), which continued to lay out, was eased out of the event as P. Marks being unable to ride the mare in a safe manner. HOLABONITA was examined by the Club's Veterinary Surgeon who reported the mare to shin sore in both forelegs. Mr. J. Tarin, the Trainer of HOLABONITA, was advised a Veterinary Certificate of Fitness would be required prior to presenting the mare for a future trial or race.

RACE 4 : KATNOOK ESTATE RATING 0-68 HANDICAP - 1100 metres

The start of this race was delayed approximately three minutes owing to the late arrival of the horses at the start.

In the vicinity of the 150 metres ZIRCONI ASPEN (J. Potter) and PARIS SCENE (J. Kah) brushed.

RACE 5 : HYLAND FOX SIGNS BENCHMARK 80 HANDICAP - 1300 metres

INNOCENT MUG (J. Kah) knuckled on jumping and as a result shifted in, bumping ACE OR JOKA (C. Lindop).

INNOCENT MUG (J. Kah) raced ungenerously in the early and middle stages of the event.

From inside the 400 metres until the entrance to the straight AM I FRENCH (A. Herrmann) was held up for clear running when racing on the heels of SACRED SNAADEE (M. Neilson).

RACE 6 : PINKERTON, PALM, HAMLYN & STEEN RATING 0-68 HANDICAP - 1400 metres

FRADEMA (M. Neilson) was slow to begin.

LE MARO (K. Post) raced ungenerously in the early stages of the event.

At the entrance to the straight ICONSEEFRAARAWAY (S. Cahill) had to steady momentarily away from the heels of STAR ACT (J. Kah), which rolled out under pressure.

RACE 7 : COOPERS BREWERY KALANGADOO CUP - 1700 metres

TREEOVUS (J. Potter) pulled hard in the early and middle stages of the event.

RACE 8 : GAMBIER EARTH MOVERS RATING 0-58 HANDICAP - 1700 metres

SOLITARY MAN (NZ) (M. Walters) stood flat-footed and was slow to begin.

In the vicinity of the 600 metres DUBAI KING (J. Frew) had to steady when racing tight to the inside of JACKS 'N' KINGS (A. Herrmann) and on the heels of GO GIRLFRIEND (J. Toeroek).

Approaching the 100 metres JACKS 'N' KINGS (A. Herrmann) had to momentarily steady when LOTS OF HEART (K. Post) shifted out. K. Post was reprimanded and advised to take greater care in future when shifting ground.

J. Frew, the rider of DUBAI KING, was reprimanded under ARR.83(a) for misconduct in that he used foul language during the event.
