**STIPENDIARY STEWARDS' REPORT**

**Report on Race Meeting held at Morphettville Racecourse**  
**by the South Australian Jockey Club on Saturday, 19 October 2013**

**TRACK:** Dead 4 (*Upgraded to Good 3 at 11.40 am*)

**WEATHER:** Fine

**RAIL:** Out 4 metres 1800m to 1200m, 6 metres remainder.

**RACE 1 : ADELAIDE GALVANISING HANDICAP - 2500 metres**

TRENCHTOWN (IRE) required attention to its tongue tie in the mounting yard and on arrival at the barriers had to have its tongue tie replaced.

Inside the 1800 metres ROWLAND (J. Kah) and SATURDAY SORCERER (S. Price) commenced to race keenly for a short distance. Thereafter, in the vicinity of the 1400 metres, ROWLAND became ungenerous for a short distance when awkwardly placed on the heels of ARTFUL TERRA (J. Toeroek).

In the vicinity of the 800 metres ROWLAND (J. Kah), which continued to race keenly, improved to take up a forward position.

From in the vicinity of the 500 metres until the entrance to the straight, SATURDAY SORCERER (S. Price) became held up for clear running on the heels of RAKI (H. Coffey) and ARTFUL TERRA (J. Toeroek).

J. Childs, the rider of NO DOUBTFIRE, was questioned regarding his use of the whip prior to the 100 metres. He pleaded guilty to a charge under ARR.137A(5)(a)(i) and (ii) for using his whip on more than five occasions and in consecutive strides prior to the 100 metres and was fined \$250.

**RACE 2 : DARLEY HANDICAP - 1800 metres**

TOMMY TWO (J. Toeroek) was slow to begin.

DRAFTED (T. Baker) shifted out at the start and brushed with BELGIETTO (P. Gatt).

J. Toeroek, the rider of TOMMY TWO, was unable to ride his mount out fully over the final 50 metres of the event when awkwardly placed on the heels of MOSSEGO (J. Childs), which rolled out under pressure.

MOSSEGO was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

C. Lindop, the rider of KUHREIHEN, reported the gelding hit a flat spot inside the 500 metres, became a little awkward in its action and as a consequence she had difficulty fully assisting her mount for a short distance. KUHREIHEN was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

J. Toeroek, the rider of TOMMY TWO, reported his mount felt awkward in its action during the event. TOMMY TWO was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

### **RACE 3 : PPI PROMOTION HANDICAP - 1000 metres**

LIGHT IT UP (J. Potter) and TENNESSEE GROOM (NZ) (T. Baker) contacted at the start.

BRING A RING (H. Coffey) and JOSEPH ARNOLD (M. Neilson) over-raced in the early stages of the event.

H. Coffey, the rider of BRING A RING, explained he was instructed to allow the filly to settle where it was comfortable. He added he was conscious that at its previous start at Flemington the filly raced from back in the field and finished the race off strongly and in view of this fact he was comfortable to settle back of mid-field early but shortly thereafter BRING A RING commenced to race keenly and in the vicinity of the 700 metres when TENNESSEE GROOM (NZ) (T. Baker) shifted out to improve and brushed with his mount, it appeared to resent the contact and raced ungenerously for a number of strides. He stated whilst the filly felt sound in its action, it finished the race off in a disappointing manner.

BRING A RING was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

JOSEPH ARNOLD, which performed poorly, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

### **RACE 4 : SCHWEPPE HANDICAP - 1100 metres**

GOLDEN LION (L. Hopwood) jumped away awkwardly.

REAL FANTASY (C. Lindop) jumped away awkwardly and shifted out, brushing EXALTED ROSE (J. Holder).

BRIMARVI PRINCE (J. Toeroek) and LIZANA (S. Price) contacted on jumping away when both began awkwardly.

SHOT IN JEST (M. Neilson) jumped away awkwardly onto STRAVINSKY CODE (J. Kah), which raced in tight room for several strides.

DIGNITARY (P. Gatt) raced keenly in the early stages of the event.

In the vicinity of the 700 metres REAL FANTASY (C. Lindop), which was inclined to lay out, rolled out at the same time as STRAVINSKY CODE (J. Kah) rolled in slightly, resulting in REAL FANTASY being obliged to steady off the heels of STRAVINSKY CODE. As a consequence LIZANA (S. Price), which was following, was inconvenienced and shifted out onto DIGNITARY (P. Gatt), which was obliged to be steadied when awkwardly placed on the heels of LIZANA. As a result DIGNITARY was severely hampered. Shortly thereafter REAL FANTASY again rolled out and had to be steadied off the heels of STRAVINSKY CODE.

In the vicinity of the 700 metres JACK'S A TIGER TOO (A. Patterson) rolled in and tightened SOL BRILLANTE (H. Coffey), which shifted out when being steadied, resulting in SOL BRILLANTE inconveniencing BRIMARVI PRINCE (J. Toeroek), which was taken wider onto GOLDEN LION (L. Hopwood), which was inconvenienced.

SHOT IN JEST lost its off fore plate during the event.

A. Herrmann, the rider of SEAL NO MORE, reported her mount was inclined to lay out throughout the event. SEAL NO MORE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

EXALTED ROSE was examined by the Club's Veterinary Surgeon who reported the mare to be suffering moderate heat stress and thumps. First Aid was administered.

### **RACE 5 : HOLDFAST INSURANCE HANDICAP - 1200 metres**

The start of this race was delayed approximately two minutes owing to MITFORD GIRL, which reared after being loaded in its barrier stall, dislodging its rider J. Toeroek, having to be examined by the Club's Veterinary Surgeon who ruled the mare fit to race. J. Toeroek was uninjured in the incident.

Shortly after the start BISCAYNE BLUE (A. Herrmann) shifted out and away from HUNTED ANGEL (A. Patterson), which rolled out. As a consequence BISCAYNE BLUE contacted with MITFORD GIRL (J. Toeroek), which was tightened onto GLAMOROUS (J. Holder), resulting in MITFORD GIRL being inconvenienced. Shortly thereafter GLAMOROUS lost its position as a consequence of being taken onto the heels of KELLY ROYALE (S. Price), which shifted in to improve.

MITFORD GIRL was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

### **RACE 6 : SPORTINGBET HANDICAP - 1200 metres**

Mr. D. O'Leary, the Trainer of EUREKA PULSE, advised Stewards he would instruct Apprentice J. Kah to attempt, if possible, to settle back of mid-field with cover to allow the gelding to finish its race off.

BERMONDSEY had its tongue tie refitted on arrival at the barriers and was examined by the Club's Veterinary Surgeon who ruled the gelding fit to race.

CROSS CONSTANCE had to be re-saddled on arrival at the barriers.

POP STREET (B. Claridge) shifted out shortly after the start and inconvenienced CROSS CONSTANCE (A. Herrmann), which was taken wider.

BERMONDSEY (H. Coffey) was inclined to lay out throughout in the straight.

In the vicinity of the 700 metres GREAT MEMORIES (C. Lindop) shifted out and attempted to improve to the outside of CROSS CONSTANCE (A. Herrmann) and in doing so contacted with NEW EMPIRE (J. Maund), which held its line. As a consequence GREAT MEMORIES was inconvenienced and lost its position.

J. Kah, the rider of EUREKA PULSE, explained she attempted to comply with her instructions but was unable to do so and settled further back than intended and raced wide without cover in the early stages due to the pace and the formation of the field and was only able to obtain cover near the 700 metres. She also stated thereafter the gelding was inclined to lay out rounding the home turn. EUREKA PULSE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

BERMONDSEY was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the near foreleg. Mr. J. O'Connor, the Trainer of BERMONDSEY, was advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

### **RACE 7 : DOMINANT DURBRIDGE STAKES - 1200 metres**

WHITLAM (L. Stojakovic) and NATURAL DISASTER (T. Pannell) contacted on jumping away. Shortly after KARACATIS (P. Gatt), which also jumped away awkwardly, shifted in and tightened NATURAL DISASTER onto WHITLAM, resulting in NATURAL DISASTER losing its position.

## **RACE 7 : DOMINANT DURBRIDGE STAKES - 1200 metres (Cont'd)**

In the vicinity of the 400 metres BELLA DOLCE (J. Childs) commenced to weaken. As a result WHITLAM (L. Stojakovic) became held up on the heels of that mare for a short distance and inside the 400 metres, when shifting out to improve, inconvenienced OUTLANDISH LAD (M. Neilson), which was taken onto the heels of DAYTONA GREY (C. Lindop), resulting in OUTLANDISH LAD becoming held up for a number of strides.

In the vicinity of the 200 metres WHITLAM (L. Stojakovic) shifted out slightly onto DAYTONA GREY (C. Lindop), which raced in restricted room for a short distance as GOLDEN PENNY (S. Price) improved to its outside and shifted in.

Inside the 100 metres KARACATIS (P. Gatt), which was inclined to shift both ways, shifted out taking WHITLAM (L. Stojakovic) out onto OUTLANDISH LAD (M. Neilson), which was tightened onto the heels of DIRE WARNING (J. Holder), resulting in OUTLANDISH LAD having to be steadied and unable to be ridden to the line.

M. Neilson, the rider of OUTLANDISH LAD, reported on return to Scale his mount appeared to have an injury to its near foreleg. OUTLANDISH LAD was examined by the Club's Veterinary Surgeon who reported lacerations to the back of the near fore knee joint. First Aid was administered.

MAYBE DISCREET was examined by the Club's Veterinary Surgeon who reported the mare to be lame in the off hind leg. Mr. P. Stokes, the Trainer of MAYBE DISCREET, was advised a Veterinary Certificate of Fitness would be required prior to presenting the mare for a future trial or race.

P. Gatt, the rider of KARACATIS, explained he had been instructed to obtain a position one out, one back with cover if possible. He stated the gelding began better than expected and was aggressive in the first furlong but after being crossed by BELLA DOLCE (J. Childs), appeared to come back and settled, but in the vicinity of the 600 metres he was obliged to encourage the gelding to improve and KARACATIS failed to finish to the race off as expected, changed stride in the straight on a number of occasions, shifted both ways and was disappointing. KARACATIS was examined by the Club's Veterinary Surgeon who reported a slow recovery.

BELLA DOLCE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

## **RACE 8 : BOAG'S DRAUGHT HANDICAP - 1600 metres**

MANGANESE (J. Holder) jumped away very awkwardly and contacted the inside of its barrier stall.

At the entrance to the straight WHITTEN'S BREW (H. Coffey) was disappointed for clear running to the outside of BENEFIT (A. Herrmann), which shifted out and improved. As a consequence WHITTEN'S BREW became held up between the heels of BENEFIT and HALAYR JET (J. Childs) for some distance and thereafter, approaching the 100 metres, WHITTEN'S BREW became held up between the heels of LILGIGGLEO (J. Kah), which shifted out, and HALAYR JET (J. Childs), which maintained its line. As a result WHITTEN'S BREW was untested to the line.

ORBITAL MOTION (J. Frew) was disappointed for clear running at the entrance to the straight when racing outside LILGIGGLEO (J. Kah), which shifted out and was obliged to alter course to the inside of that gelding to obtain clear ground.

FRESHMAN (S. Price) laid in, in the straight.

**RACE 8 : BOAG'S DRAUGHT HANDICAP - 1600 metres (Cont'd)**

WHITTEN'S BREW, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.
