# THOROUGHBRED RACING S.A. LIMITED STIPENDIARY STEWARDS' REPORT

## Report on Race Meeting held at the Port Lincoln Racecourse by the Port Lincoln Racing Club on Sunday, 20 October 2013

### RACE 1 : COOMUNGA CENTENARY / SABOIS MAIDEN PLATE - 1360 metres

CACKLE (W. Kerford) jumped away awkwardly and shifted out, tightening OUR BELIEF (K. Bishop) onto KAREN THE SEYIS (M. Neilson), which was tightened onto PACIFIC JOURNEY (E. Boyd), which was taken out onto LEWIS STREET (P. Roff), resulting in PACIFIC JOURNEY becoming tightened and losing its position.

In the vicinity of the 1200 metres CACKLE (W. Kerford) brushed with OUR BELIEF (K. Bishop). Thereafter CACKLE commenced to buck for a short distance. CACKLE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities. Mr. D. Courtney, the Trainer of CACKLE, was advised the filly would be required to perform to the Stewards' satisfaction in an Official Barrier Trial prior to accepting for a future race.

Correct Weight for this event was delayed to allow Stewards to review the official footage of the start.

### RACE 2 : PURE BLONDE RATING 0-68 HANDICAP - 1360 metres

On arrival at the start MIGHTY MOMENT (T. Pannell) had to be re-saddled.

Approaching the 1200 metres MONTALTO (P. Roff) shifted in, resulting in BELLA MUCHACHA (L. Hopwood) having to ease her mount when tightened onto HAPPYENDO (E. Boyd). P. Roff was reminded of his obligations in relation to giving riders to his inside the room to which they are entitled.

In the vicinity of the 800 metres HAPPYENDO (E. Boyd) rolled out and brushed JUST PURE FUN (D. Evans), which was unbalanced momentarily.

JUST PURE FUN (D. Evans) was inclined to lay in under pressure in the straight obliging D. Evans to stop riding and straighten the mare.

HAPPYENDO (E. Boyd) was inclined to lay in over the concluding stages.

### RACE 2: PURE BLONDE RATING 0-68 HANDICAP - 1360 metres (Cont'd)

D. Evans, the rider of JUST PURE FUN, explained he had intended to race forward of mid-field but could not obtain that position due to the formation of the field. He added he travelled wide without cover throughout the event and he put the mare under pressure in the straight but JUST PURE FUN did not respond in the manner he expected. JUST PURE FUN, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported a small cut to the inside of the near hind fetlock.

### RACE 3 : CARLTON DRAUGHT / SABOIS FILLIES & MARES RATING 0-68 HANDICAP – 1200 metres

CALIFORNIAN DEVIL, which lost its off fore plate in the parade ring, required Farrier attention. CALIFORNIAN DEVIL was examined by the Club's Veterinary Surgeon who ruled the mare fit to race

ARTIE'S ANGEL (E. Boyd) was slow to begin.

CALIFORNIAN DEVIL (K. Bishop) shifted in on jumping away.

MARINA DEL REY (D. Tourneur) shifted out on jumping away.

T. Baker, the rider of DELIGHTFUL ISABEL, reported in his opinion the mare was short in its action. DELIGHTFUL ISABEL, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

# RACE 4 : DECEMBER 6TH WELCOME TO SUMMER, TWILIGHT RACES / SABOIS MAIDEN PLATE - 1000 metres

On arrival on course THE HEADLINER, which had not raced since December 2012, was examined by the Club's Veterinary Surgeon who ruled the gelding fit to race.

CHLOBOROUGH (K. Bishop) was slow to begin and missed the start three to four lengths.

LUNAR GALAXY (M. Neilson) was slow to begin.

FORESHORE MAK (T. Baker) was inclined to lay in throughout the event. FORESHORE MAK was examined by the Club's Veterinary Surgeon who reported no visible abnormalities, other than the gelding requires dental attention. Mr. B. Cozamanis Jnr., the Trainer of FORESHORE MAK, was advised to have the gelding's teeth attended to.

LUNAR GALAXY (M. Neilson) was inclined to lay in under pressure in the straight.

Over the concluding stages FORESHORE MAK (T. Baker) shifted in abruptly under pressure onto WHERE HEARTS LIE (T. Pannell), which was obliged to steady. T. Baker was reminded in future to straighten his mounts sooner than he did on this occasion.

Correct Weight for this event was delayed to allow Stewards to review the official footage of the start. K. Bishop, the rider of CHLOBOROUGH, and that gelding's Trainer, Mr. J. Dunn, made a submission to Stewards that CHLOBOROUGH be declared a non-runner as it was their opinion the gelding was being restrained by a Barrier Attendant when the start was effected and was denied a fair start. After considering evidence from the Official Starter, Mr. G. Woods, Stewards declared CHLOBOROUGH a non-runner in accordance with ARR.134A.

### RACE 5: SHARE YALUMBA RATING 0-62 HANDICAP - 1000 metres

On arrival on course DISCOUNTED, which had not raced since October 2012, was examined by the Club's Veterinary Surgeon who ruled the gelding fit to race.

The start of this race was delayed approximately three minutes owing to GOOD CONDUCT and KOODA DUCHESS having to be re-saddled on arrival at the barriers and BEE IN HER BONNET having its noseband adjusted.

DISCOUNTED (L. Hopwood) was inclined to rear as the gates were released.

In the vicinity of the 300 metres BLUZAR (J. Maund), which was tiring, shifted in and away from HARDERS (A. Patterson) and commenced to weaken.

### RACE 6: EP ASBESTOS BENCHMARK 80 HANDICAP - 1200 metres

RUSSIAN JAR (IRE) (T. Baker) jumped away awkwardly and was slow to begin.

HANK'S NEPHEW (E. Boyd) knuckled on jumping away.

In the vicinity of the 200 metres ACHENAR (D. Tourneur) shifted out under pressure onto SPIRIT OF FLATLEY (J. Maund) at the same time as BLACK BARRA (J. Potter) rolled in slightly, resulting in SPIRIT OF FLATLEY becoming tightened and having to be eased, losing its position and having to alter course across heels to the inside of ACHENAR to obtain clear running. As a result VINARD (K. Bishop) was taken in by SPIRIT OF FLATLEY onto PRIMAL INSTINCT (L. Hopwood), which was inconvenienced. D. Tourneur was severely reprimanded and advised in future to stop riding and straighten his mounts before they shift ground.

HANK'S NEPHEW, which returned to Scale with blood in its mouth, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

# RACE 7 : PLRC MEMBERS COLTS, GELDINGS & ENTIRES RATING 0-62 HANDICAP – 1200 metres

SOCIAL ASSASSIN (M. Neilson), which was fractious in the barriers prior to the start being effected, was slow to begin.

In the vicinity of the 1000 metres IMAGE MASTER (D. Tourneur) raced fiercely for a short distance.

From the 100 metres HEZA HUSSLER (A. Patterson) was held up for clear running behind IMAGE MASTER (D. Tourneur) and inside MOON DEVIL (P. Roff) and was untested to the line. HEZA HUSSLER was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

LE COLUMBIA, which performed poorly, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.
