# Report on Race Meeting held at Morphettville Parks Racecourse by the South Australian Jockey Club on Saturday, 26 October 2013

## RACE 1 : GLENELG GOLF CLUB THREE-YEARS-OLD MAIDEN PLATE - 1000 metres

PHOENIX ARIZONA (NZ) (J. Holder) jumped away awkwardly.

In the vicinity of the 700 metres BISHOP JOCK (L. Hopwood) raced ungenerously and made the turn awkwardly.

Shortly prior to the entrance to the straight PHOENIX ARIZONA (NZ) (J. Holder) became held up for a number of strides behind BOOTH (B. Claridge) and to the inside of SUNFLOWER CLUB (A. Patterson).

Approaching the 100 metres BOOTH (B. Claridge), which was racing greenly, shifted out and inconvenienced PHOENIX ARIZONA (NZ) (J. Holder), which was inclined to lay in, resulting in that gelding being taken off its course.

BOOTH was examined by the Club's Veterinary Surgeon who reported a small laceration to the near fore lateral cannon. First Aid was administered.

LISTENING DEVICE was examined by the Club's Veterinary Surgeon who reported a minor laceration to the outside of the near fore cannon. First Aid was administered.

#### RACE 2 : TOLL EXPRESS HANDICAP - 2250 metres

On arrival at the barriers MONTEFALCO required its tongue tie to be refitted. MONTEFALCO was examined by the Club's Veterinary Surgeon who ruled the gelding fit to race.

On jumping away GOLDEN SCHNAPS (L. Hopwood) was inconvenienced between LATE NIGHT DRINK (J. Kah) and MONTEFALCO (A. Patterson), which both shifted ground.

#### RACE 2: TOLL EXPRESS HANDICAP - 2250 metres (Cont'd)

In the vicinity of the 700 metres LATE NIGHT DRINK (J. Kah) shifted out into the running of PERFECT LENGTH (D. Tourneur), which was obliged to be checked to avoid that gelding's heels. As a consequence PERFECT LENGTH was taken out onto EXALTED GEM (S. Price), which was inconvenienced, and MONTEFALCO (A. Patterson), which was following, was momentarily inconvenienced. J. Kah pleaded guilty to a charge of Careless Riding under AR137(a) in that she shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Saturday, 2 November and to conclude at midnight on Sunday, 10 November 2013; a period of five (5) meetings.

SMOKE BURNER (H. Coffey) was disappointed for clear running approaching the 200 metres between POWER TO POSSESS (A. Herrmann) and GOSSIP GURU (J. Holder) and was obliged to shift to the outside of GOSSIP GURU to obtain clear running.

Approaching the 50 metres GOSSIP GURU (J. Holder) shifted out and away from POWER TO POSSESS (A. Herrmann), taking SMOKE BURNER (H. Coffey) wider on the track.

Correct Weight for this event was delayed to allow H. Coffey, the rider of the second placegetter SMOKE BURNER, and that gelding's Trainer, Mr. P. Stokes, to view the official footage in the straight.

J. Kah, the rider of LATE NIGHT DRINK, reported on return to Scale in her opinion the gelding felt sore in the near foreleg on pulling up. LATE NIGHT DRINK was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the near foreleg. Mr. G. Richards, the Trainer of LATE NIGHT DRINK, was advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

SMOKE BURNER and EXALTED GEM were examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

#### RACE 3: TOYOTA FLEET MANAGEMENT HANDICAP - 1400 metres

CHONDRA (E. Boyd) raced keenly in the early stages and inside the 800 metres raced ungenerously when awkwardly placed on the heels of STACK THE TRUCK (A. Patterson).

EXCITES ZELADY (A. Herrmann) laid in from in the vicinity of the 500 metres.

EXCITES ZELADY lost its near fore plate and CAPODECINA lost its off hind plate during the event.

A. Herrmann, the rider of EXCITES ZELADY, was questioned regarding the use of her whip prior to the 100 metres. A. Herrmann pleaded guilty to a charge under AR137A(5)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was reprimanded.

H. Coffey, the rider of PIT BOSS, explained he had been instructed to have the gelding find a position where comfortable, however, he had the expectation of settling in a position midfield. He added that after jumping from a wide barrier he was unable to obtain a position closer to the speed without placing undue pressure on PIT BOSS due to the formation of the field and elected to ease his mount and obtain cover in a rearward position. He stated that after obtaining this position, the pace of the race seemed to ease which was detrimental to his mount and when placed under pressure in the vicinity of the 700 metres, PIT BOSS only responded fairly to his efforts. PIT BOSS was examined by the Club's Veterinary Surgeon who reported a lower than expected heart rate.

#### RACE 4: HINO TRUCKS HANDICAP - 1400 metres

MAGICAL PEARL (M. Neilson) laid out from in the vicinity of the 600 metres. MAGICAL PEARL was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

SEASON OF FORTUNE (M. Walters) laid in, in the straight.

## RACE 5 : LEXUS HANDICAP - 1000 metres

HALLE ROCKS (D. Tourneur) and WISE AND HAPPY (J. Kah) contacted on jumping away when both horses jumped away awkwardly.

In the vicinity of the 700 metres MAELSTROM (H. Coffey) was obliged to be steadied as STREETCAR VALOUR (J. Holder) rolled in.

THIAMANDI was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

#### RACE 6: ONE TOYOTA HANDICAP - 1400 metres

On jumping away DARTOOK (NZ) (T. Pannell) and SWINGING SOLDIER (J. Holder) brushed.

DASHING PEDRILLE (B. Claridge) raced three wide without cover throughout the event.

EXTRA VIRGIN (J. Frew) became held up for clear running for a short distance near the 300 metres when racing behind KATE'S DREAM (M. Neilson) and inside DASHING PEDRILLE (B. Claridge).

DARTOOK (NZ) (T. Pannell) became held up for clear running shortly after the entrance to the straight until near the 200 metres.

DANCING POETESS (J. Kah) was unable to obtain clear running from the entrance to the straight until inside the 200 metres.

VISUAL IMPACT (A. Patterson) was held up for clear ground from in the vicinity of the 300 metres and was obliged to alter course to the outside of SWINGING SOLDIER (J. Holder) inside the 200 metres.

DASHING PEDRILLE, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported an elevated heart rate and a slower than expected recovery. Mr. T. McEvoy, the Trainer of DASHING PEDRILLE, was advised a Veterinary Certificate of Fitness would be required prior to presenting the mare for a future trial or race.

DARTOOK (NZ) was examined by the Club's Veterinary Surgeon who reported the mare to be lame in the off hind leg. First Aid was administered. Mr. R. Balfour, the Co-Trainer of DARTOOK (NZ), was advised a Veterinary Certificate of Fitness would be required prior to presenting the mare for a future trial or race.

#### RACE 7: TOYOTA HANDICAP - 1250 metres

Mr. C. Binnie, the Co-Trainer of OUR LITTLETREASURE, advised Stewards he would instruct Apprentice J. Toeroek to attempt to ride the mare more forward and behind the speed today if possible.

#### RACE 7: TOYOTA HANDICAP - 1250 metres (Cont'd)

On jumping away SHEEZ ON TOP (S. Price) shifted in and contacted COLLA VOCE (A. Patterson).

MY UNCLE VINNY (E. Boyd) and DAREBIN (T. Pannell) came together and contacted shortly after the start.

Shortly after the entrance to the straight OUR LITTLETREASURE (J. Toeroek) shifted out to improve and contacted DAREBIN (T. Pannell), which was inconvenienced. Shortly thereafter J. Toeroek, the rider of OUR LITTLETREASURE, became unbalanced for a stride when his mount was inclined to lay out.

J. Holder, the rider of LATIN HERO, reported the gelding did not stretch out from the 300 metres.

#### RACE 8: TOYOTA MATERIAL HANDLING HANDICAP - 1400 metres

OCSMEPOP (M. Neilson) was slow to begin.

THIDWICK THE MOOSE (H. Coffey) raced wide without cover in the early stages of the event.

WOAKWINE (J. Kah) raced wide without cover in the middle stages of the event.

Over the concluding stages ROWDY ROCKER (L. Hopwood) shifted in under pressure. As a result LAST DAY (NZ) (J. Toeroek) had to be aware of the heels of ROWDY ROCKER. L. Hopwood was reminded of her obligations when shifting ground in future.

THIDWICK THE MOOSE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

J. Kah, the rider of WOAKWINE, reported her mount hung out throughout the event. WOAKWINE was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the off hind leg. Mr. J. Opperman, the Trainer of WOAKWINE, was advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

# **GENERAL:**

#### RACE 8: TOYOTA MATERIAL HANDLING HANDICAP - 1400 metres

Mr. D. O'Leary, as the Trainer and person responsible for the proper saddling of VALUE AS, pleaded guilty to a charge under AR140A(1) in that he failed to ensure the correct saddle for this horse was collected from the Scales area and presented to saddle the horse and was fined \$200.
