Report on Race Meeting held at Morphettville Racecourse by the South Australian Jockey Club on Tuesday, 5 November 2013

RACE 1: SPORTINGBET / SABOIS MAIDEN PLATE - 1600 metres

In the vicinity of the 1200 metres ROCMARR (J. Toeroek) shifted in taking JUNIOR (T. Baker) in onto PEACE OF HEAVEN (L. Hopwood), which was obliged to be checked, losing its position. J. Toeroek pleaded guilty to a charge of Careless Riding under AR137(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Saturday, 9 November and to conclude at midnight on Wednesday, 20 November 2013; a period of five (5) meetings.

DELAWAY BROM (J. Bowditch) was unable to obtain clear running from the entrance to the straight until near the 300 metres where it was obliged to shift out and in doing so, inconvenienced ROCMARR (J. Toeroek), which had commenced to weaken. ROCMARR was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

TOO COOL TO FOOL (NZ) lost its off hind plate during the event.

RACE 2 : HOLDFAST INSURANCE / SABOIS 3-Y-O COLTS AND GELDINGS MAIDEN PLATE - 1050 metres

J. Matthews, who was dislodged from his mount LUCKY SYMBOL in the mounting yard when it reared, was examined by the First Care Medical personnel and declared fit to fulfil his riding engagement.

The start of this race was delayed approximately two minutes owing to MEADOWS ANGEL becoming fractious in its barrier stall, dislodging Jockey L. Hopwood. L. Hopwood was examined by the First Care Medical personnel and declared fit to fulfil her riding engagement. MEADOWS ANGEL was examined by the Club's Veterinary Surgeon and ruled fit to start.

PRINCE LUKAS (S. Westover) was slow to begin.

PHOENIX ARIZONA (NZ) (J. Bowditch) and ALERT BERT (J. Holder) raced keenly in the early and middle stages of the event.

RACE 2 : HOLDFAST INSURANCE / SABOIS 3-Y-O COLTS AND GELDINGS MAIDEN PLATE - 1050 metres (Cont'd)

I'MTELLINGYOUNOW (NZ) (J. Toeroek) raced greenly, commenced to lay out and raced very wide on the home turn and continued to lay out in the straight, racing very wide for the remainder of the event. I'MTELLINGYOUNOW (NZ) was examined by the Club's Veterinary Surgeon who reported no visible abnormalities. Mr. C. Graves, the Trainer of I'MTELLINGYOUNOW (NZ), was advised the gelding would be required to perform to the Stewards' satisfaction in an Official Barrier Trial prior to accepting for a future race.

Shortly after the entrance to the straight PRINCE LUKAS (S. Westover), which raced greenly, shifted out of its own accord and clipped the heels of FATE (A. Patterson).

S. Price, the rider of BEER SIR, reported the gelding was inclined to lay in and felt short in its action. BEER SIR was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the near foreleg. Mr. B. Dunn, the Trainer of BEER SIR, was advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

The track was upgraded to Good 3 at 12.20 pm, retrospective to Race 2.

RACE 3 : SCHWEPPES / SABOIS THREE-YEAR-OLD FILLIES MAIDEN PLATE - 1050 metres

The start of this race was delayed approximately three minutes owing to SCANTY, which was kicked by another runner on arrival at the barriers, having to be examined by the Club's Veterinary Surgeon who ruled the filly unfit. Acting on that advice, Stewards withdrew SCANTY at 12.57 pm.

Approaching the 400 metres INFIDEL (J. Toeroek) dipped for no apparent reason.

At the entrance to the straight BIG ON BLING (J. Matthews) was obliged to steady off the heels of BOLDACIOUS GIRL (L. Hopwood), which shifted out.

COMSTRUM (T. Baker) laid in, in the straight.

J. Matthews, the rider of BIG ON BLING, pleaded guilty to a charge under AR137(c) for making a celebratory gesture prior to passing the winning post and was fined \$300.

Correct Weight for this event was delayed to allow A. Herrmann, the rider of FACE LEICA STAR, and that filly's Trainer, Mr. G. Richards, to view the official footage of the start. After considering submissions from A. Herrmann, Mr. Richards and Mr. S. Pearson, the Official Starter, and viewing the official footage of the start, Stewards were satisfied that FACE LEICA STAR, which was fractious in its barrier stall and assisted by a Barrier Assistant, was not denied a fair start.

Subsequent to the event SCANTY was again examined by the Club's Veterinary Surgeon who reported a haematoma on the near side rib area. First Aid was administered. Mr. B. Smart, the Trainer of SCANTY, was advised a Veterinary Certificate of Fitness would be required prior to presenting the filly for a future trial or race.

RACE 4: YOUR LOCAL IGA / SABOIS MAIDEN PLATE - 1200 metres

On arrival on course ANY EXIT was examined by the Club's Veterinary Surgeon who ruled the mare fit to race.

RACE 4: YOUR LOCAL IGA / SABOIS MAIDEN PLATE - 1200 metres (Cont'd)

The start of this race was delayed approximately three minutes owing to the bridle and bit fitted to BUHAWI requiring adjustment on arrival at the start. At a subsequent inquiry, Stewards took evidence from Mrs. M. Glatz, the gelding's Trainer, and the Starter, Mr. S. Pearson, and decided to take no action in the matter.

In the vicinity of the 1000 metres CALIFORNIA KING (J. Bowditch) shifted in and tightened TOKEN ONE (E. Boyd), which had to be restrained. As a consequence TOKEN ONE was taken in onto ANY EXIT (S. Price), which had to be restrained when tightened onto HIDDEN'S SISTER (A. Patterson), resulting in ANY EXIT and HIDDEN'S SISTER making contact and becoming unbalanced. J. Bowditch was found guilty of a charge of Careless Riding under AR137(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Saturday, 9 November and to conclude at midnight on Sunday, 17 November 2013; a period of (4) meetings.

BUCK'S FLAT (S. Cahill) was inclined to lay out in the straight.

CALIFORNIA KING lost its near fore plate during the event.

- S. Cahill, the rider of BUCK'S FLAT, reported in his opinion there was something amiss with the gelding. BUCK'S FLAT was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the off hind leg. Mrs. B. Geracitano, the Trainer of BUCK'S FLAT, was advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.
- S. Price, the rider of ANY EXIT, reported his mount felt flat during the event.

Following this event J. Toeroek was examined by the First Care Medical personnel who declared him unfit to fulfil his remaining riding engagements.

RACE 5: MOUNT BARKER FOODLAND CLASS 1 HANDICAP - 1050 metres

The start of this race was delayed approximately one minute owing to an interstate delay.

SAN JUAN AMIGO (T. Pannell) jumped away very awkwardly.

KOMOVI (J. Holder) jumped away awkwardly, shifted out and contacted SEAL NO MORE (L. Hopwood).

- S. Cahill, the rider of RYCHLE, reported in his opinion the mare was short in her action and did not stretch out during the event.
- J. Bowditch, the rider of FALPOLLO, reported the mare was making a breathing noise after the race.
- T. Pannell, the rider of SAN JUAN AMIGO, explained the gelding began very awkwardly, is still very immature and despite travelling well during the event, did not finish the race off as he expected and in his opinion the weight carried today may have been a factor in its performance.

RACE 6: ANGELAKIS BROS RATING 0-62 HANDICAP - 1800 metres

Stewards acceded to a request from Mr. K. Sweeney, the Trainer of MANGANESE, to scratch the gelding as there was no claiming Apprentice available to ride the horse and withdrew MANGANESE at 2.12 pm.

RACE 6: ANGELAKIS BROS RATING 0-62 HANDICAP - 1800 metres (Cont'd)

- J. Maund, the rider of ARADANCHI, reported he felt there was something amiss with the gelding. ARADANCHI was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.
- J. Holder, the rider of ENVIRONMENT PATRON (NZ), reported the gelding got its tongue over the bit during the event.

RACE 7: ENDEAVOUR HOMES SPRING STAYERS SERIES FINAL - 2600 metres

As the only claiming Apprentice E. Boyd was not available to ride, Stewards granted permission for J. Potter to ride NISHIAZABU.

The start of this race was delayed approximately two minutes owing to an interstate delay.

LATE NIGHT DRINK (S. Westover) jumped away awkwardly and shifted out, tightening DUNROSSIL (J. Maund) onto GOSSIP GURU (J. Holder), which was tightened onto STORM BREWING (T. Pannell).

Approaching the 2000 metres POWER TO POSSESS (A. Herrmann) became awkwardly placed inside the heels of SMOKE BURNER (T. Baker), which shifted in. As a consequence POWER TO POSSESS had to be checked, losing its position and thereafter raced keenly for some distance. T. Baker pleaded guilty to a charge of Careless Riding under AR137(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Thursday, 7 November and to conclude at midnight on Wednesday, 13 November 2013; a period of three (3) meetings.

RACE 8: TATTSBET MARES RATING 0-82 HANDICAP - 1500 metres

As there was no claiming Apprentice available to ride GLAMOROUS, Stewards permitted J. Maund to ride the mare.

The start of this race was delayed approximately two minutes.

DANCING POETESS (J. Holder) and GLAMOROUS (J. Maund) became tightened and were inconvenienced on jumping away between BISCAYNE BLUE (A. Herrmann) and FRAANIKOVA (L. Hopwood), which both shifted ground.

HENNY (T. Baker) raced wide without cover throughout the event.

Approaching the entrance to the straight BISCAYNE BLUE (A. Herrmann) attempted to improve into a tight run between KELLY ROYALE (E. Boyd) and FIND A MOMENT (J. Potter) and became held up for several strides.

FIND A MOMENT (J. Potter) raced in restricted room at the entrance to the straight between FRAANIKOVA (L. Hopwood) and BISCAYNE BLUE (A. Herrmann) for a short distance and thereafter, approaching the 100 metres, became held up between the heels of CLEARLY PASSIONATE (J. Bowditch) and DESDANE (S. Price) for several strides and was only able to be tested approaching the 50 metres when obliged to alter course to the inside of CLEARLY PASSIONATE.

RACE 8: TATTSBET MARES RATING 0-82 HANDICAP - 1500 metres (Cont'd)

Over the concluding stages KELLY ROYALE (E. Boyd) shifted out under pressure resulting in CLEARLY PASSIONATE (J. Bowditch) being obliged to steady when taken out onto DESDANE (S. Price). E. Boyd was severely reprimanded and advised to take greater care when shifting ground in future.

A. Herrmann, the rider of BISCAYNE BLUE, pleaded guilty to a charge under AR145 for weighing in more than $\frac{1}{2}$ kg over the weight at which she weighed out (1 kg) and was fined \$200.

RACE 9: BOAG'S DRAUGHT RATING 0-62 HANDICAP - 1200 metres

The start of this race was delayed approximately two minutes owing to ZAYAK having to be resaddled prior to leaving the mounting enclosure.

SMOKY DUBAI (S. Cahill) jumped away awkwardly and shifted in and away from FATHER TONY (J. Bowditch) onto GOLDEN LION (L. Hopwood), which was inconvenienced when tightened onto SUPREME RULER (J. Maund).

LURCH (S. Westover) over-raced in the early stages of the event.

ZAYAK and SMOKY DUBAI were examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

GENERAL:

RACE 9: BOAG'S DRAUGHT RATING 0-62 HANDICAP - 1200 metres

Prior to ZAYAK leaving the mounting enclosure, it was discovered that Jockey T. Baker had weighed out for this event below the weight at which he was required to weigh out. Stewards ordered the saddle fitted to ZAYAK be returned to the Scales area. T. Baker's weight was confirmed to be 54 kg when he was required to weigh out at 57.5 kg. T. Baker reweighed at the correct weight and ZAYAK was resaddled. At a subsequent inquiry, T. Baker was found guilty and the Clerk of Scales on duty pleaded guilty to a charge under AR175(k) in that their negligence in the weighing out process could have led to a breach of AR143. Having regard for the circumstances that led to the initial error, the fact that T. Baker had alerted Stewards prior to the horse leaving the mounting enclosure, both parties forthright evidence and their respective pleas. Stewards issued both parties with a reprimand.
