

THOROUGHBRED RACING S.A. LIMITED
STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Gawler Racecourse
by the Gawler & Barossa Jockey Club on Thursday, 7 November 2013

Stewards: S. Callanan (A/Chairman) J. Petzer, A. Hayles (HT) & D. Bucknell (F) (Stewards), I. Dally (Deputy Steward) & Dr. P. Horridge (Veterinary Surgeon).

TRACK: Dead 4 (*Upgraded to Good 3 at 2.45 pm, retrospective to Race 4*) **WEATHER:** Overcast

RAIL: True

RACE 1 : COOPERS CLEAR CLASS 1 HANDICAP - 1200 metres

RED DAZZLE (J. Toeroek) jumped away awkwardly and shifted out contacting WAR HEIGHTS (D. Tourneur).

SHADOWS OF VENUS (J. Maund) jumped away awkwardly and shifted out onto MINAVILLA (S. Price), which was inconvenienced.

Approaching the 900 metres WAR HEIGHTS (D. Tourneur) shifted in onto MINAVILLA (S. Price), which had to be steadied. D. Tourneur was reminded of his obligations and advised to take greater care when shifting ground in future.

WAR HEIGHTS (D. Tourneur), which was inclined to lay in during the event, was unable to obtain clear running from in the vicinity of the 600 metres until approaching the 150 metres.

D. Tourneur, the rider of WAR HEIGHTS, explained after beginning fairly he elected to gain cover towards the rear of the field. He stated the gelding travelled well but was inclined to lay in under pressure in the straight, which made it difficult to obtain a clear run until approaching the 150 metres. WAR HEIGHTS was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 2 : KINGSFORD HOTEL / SABOIS DISTANCE MAIDEN PLATE - 2100 metres

LOVERS RULES (J. Frew) was slow to begin.

In the vicinity of the 1800 metres MISTAKEN VALUE (S. Cahill) shifted in onto VALIK (C. Forrest), which had to be steadied. Thereafter VALIK over-raced for a short distance. S. Cahill was reprimanded and advised to take greater care when shifting ground in future.

C. Forrest, the rider of VALIK, was questioned regarding her riding of the gelding from in the vicinity of the 600 metres. She explained she was instructed to allow the gelding to settle without it being hustled along early. She added she was also made aware the gelding has a tendency to not respond to the use of the whip in a positive manner. She stated when the field improved near the 600 metres, whilst she had conceded ground, she had not become concerned and being mindful of her instructions regarding the whip, she continued to ride VALIK hands and heels in an attempt to improve her position but the gelding failed to respond to her riding and finished the race off in a disappointing manner. Mr. S. Padman, the Trainer of VALIK, confirmed the instructions provided to C. Forrest and added that in his opinion, when C. Forrest used the whip in a slapping motion down the gelding's shoulder, it appeared not to respond and gave the impression it was off the bridle. VALIK was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 3 : COOPERS PALE ALE MARES 0-62 HANDICAP - 1200 metres

On arrival at the barriers UMA WAVE, which contacted the gate on exiting the mounting enclosure, was examined by the Club's Veterinary Surgeon and ruled fit to race.

UMA WAVE (L. Stojakovic) jumped away awkwardly.

EMILY BELLE (M. Neilson) became held up for clear running momentarily rounding the home turn.

D. Tourneur, the rider of LADY PHOENIX, reported his mount hung out throughout the event.

M. Neilson, the rider of EMILY BELLE, reported his mount appeared to shy at the winning post.

UMA WAVE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 4 : SAM NEWMAN AT THE TERRACE / SABOIS FOUR-YEARS-OLD & OVER MAIDEN PLATE - 1100 metres

The start of this race was delayed approximately two minutes owing to the breast plate on TRICKED UP TAM requiring attention on arrival at the barriers.

TRICKED UP TAM (S. Cahill) jumped away awkwardly and was slow into stride.

D. Tourneur, the rider of KING OF THE MOMENT, reported his mount raced greenly throughout the event.

ZARANKA was examined by the Club's Veterinary Surgeon who reported a slow recovery.

TRICKED UP TAM was examined by the Club's Veterinary Surgeon who reported the mare to be suffering moderate heat stress. First Aid was administered.

The track was upgraded to Good 3 at 2.45 pm retrospective to Race 4.

RACE 5 : GAWLER SOUTH BAKERY / SABOIS FILLIES AND MARES MAIDEN PLATE – 1200 metres

The start of this race was delayed approximately one minute owing to HAIL MAHER proving difficult to load.

PALACE LYRIC (J. Holder) jumped away awkwardly, contacting MONEY'S MONEY (S. Price).

In the vicinity of the 1000 metres SNEAKY MEASURE (L. Hopwood) raced ungenerously for a short distance.

In the vicinity of the 1000 metres MAGICAL RUBY (M. Neilson) shifted in, inconveniencing MONEY'S MONEY (S. Price). M. Neilson was reprimanded and advised to shift ground only when clear in future.

In the vicinity of the 800 metres PIERREMONT MAGIC (S. Cahill) improved onto the heels of BEACON OF LIGHT (J. Maund) and had to be restrained for a number of strides.

**RACE 5 : GAWLER SOUTH BAKERY / SABOIS FILLIES AND MARES MAIDEN PLATE –
1200 metres (Cont'd)**

Inside the 600 metres MONEY'S MONEY (S. Price) had a tendency to lay out onto CHAMPAGNE KRIS (T. Pannell), which was weakening, resulting in CHAMPAGNE KRIS being taken out onto LUNAR QUEEN (J. Potter), making contact with that mare's hindquarters.

In the vicinity of the 500 metres HAIL MAHER (B. Claridge) shifted out to obtain clear running and inconvenienced CHAMPAGNE KRIS (T. Pannell), which was weakening. B. Claridge was severely reprimanded and advised to take greater care when shifting ground in future.

Approaching the 400 metres MONEY'S MONEY (S. Price) rolled in onto PALACE LYRIC (J. Holder), which was inconvenienced. As a consequence PIERREMONT MAGIC (S. Cahill), which was racing to the inside of PALACE LYRIC, became unbalanced for a number of strides when being restrained.

In the vicinity of the 300 metres MONEY'S MONEY (S. Price) shifted out onto PALACE LYRIC (J. Holder), which was obliged to steady, forcing SAGABELLA (A. Patterson) wider on the track. S. Price was reprimanded and advised to take greater care when shifting ground in future.

HAIL MAHER (B. Claridge) raced very greenly in the straight and shifted in abruptly on a number of occasions, hampering LUNAR QUEEN (J. Potter). HAIL MAHER was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 6 : JACOBS CREEK RATING 0-58 HANDICAP - 1100 metres

MORCHOWIE MISS (D. Tourneur) jumped away awkwardly, contacting THE PRINCESS (A. Doyle), which was inconvenienced.

AGED IN OAK (J. Toeroek) jumped away awkwardly, contacting WYARA MISS (J. Potter), which was inconvenienced.

NEHRU (J. Frew) jumped away awkwardly and contacted LE CHARMANT (T. Zanker).

On jumping away BUTTERFLY QUEEN (L. Stojakovic) knuckled.

THE PRINCESS (A. Doyle) had a tendency to lay out rounding the home turn and when placed under pressure in the straight.

MORCHOWIE MISS (D. Tourneur) laid in under pressure in the straight.

J. Frew, the rider of NEHRU, reported his mount laid out throughout the event.

RACE 7 : SPORTSBET RATING 0-62 HANDICAP - 1500 metres

After the entrance to the straight ECLAIR SAMBA (NZ) (D. Tourneur) laid in and momentarily inconvenienced DAN'S A LADY (J. Toeroek), which shifted in onto FREE THE WIND (A. Herrmann), which was inconvenienced for several strides.

Approaching the 200 metres ECLAIR SAMBA (NZ) (D. Tourneur), which continued to lay in, shifted in onto DOWN THE MIDDLE (S. Price), which was taken out by CATON (L. Hopwood). As a consequence MYSTIC FOX (J. Potter) shifted out and away from ECLAIR SAMBA (NZ), which shifted out when being corrected and contacted CHESTER DOWNS (J. Holder), resulting in both horses becoming unbalanced.

GENERAL:

Jockey B. Claridge was reprimanded under AR91 for leaving the course after his last engagement without seeking Stewards' permission.

RACE 7 : ENDEAVOUR HOMES SPRING STAYERS SERIES FINAL - 2600 metres

T. Baker, the rider of SMOKE BURNER, was questioned regarding his use of the whip prior to the 100 metres. He pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip in a forehand manner on more than five occasions prior to the 100 metres and was fined \$500.

A. Herrmann, the rider of POWER TO POSSESS, was questioned regarding her use of the whip prior to the 100 metres. She pleaded guilty to a charge under AR137A(5)(a)(ii) in that she used her whip in a forehand manner on more than five occasions prior to the 100 metres and was fined \$300.

T. Pannell, the rider of STORM BREWING, was questioned regarding his use of the whip prior to the 100 metres. He pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip in a forehand manner on more than five occasions prior to the 100 metres and was fined \$300.
