Report on Race Meeting held at Morphetville Parks Racecourse
by the South Australian Jockey Club on Saturday, 16 November 2013

RACE 1 : CHRISTMAS TWILIGHT RACES 20TH DECEMBER PLATE – 1000 metres

The start of this event was delayed approximately five minutes owing to BRIDGEY FLYER losing its near fore plate en route to the barriers. BRIDGEY FLYER was re-shod and examined by the Club's Veterinary Surgeon, who ruled it fit to start.

OUR CAVALIA (S Price) jumped away awkwardly and shifted in at the same time as SHOW SET (J Potter) jumped away awkwardly and shifted out, resulting in contact between these two runners and OUR CAVALIA being inconvenienced when taken wider on the track.

KAPAULENKO (J Kah) laid out from in the vicinity of the 600 metres.

OUR CAVALIA (S Price) and SHOW SET (J Potter) raced greenly in the straight and laid out.

Over the concluding stages, OUR CAVALIA (S Price) shifted out and away from KAPAULENKO (J Kah), which laid out under pressure.

OUR CAVALIA was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

SHOW SET lost its off fore plate during the event.

RACE 2 : EXPRESS COLOUR PRINTING HANDICAP – 1250 metres

BRIMARVI PRINCE (J Kah) and STRAYING TIGER (J Potter) jumped away awkwardly.

DIFFERING FORTUNES (S Price) became held up for clear running for a short distance near the 300 metres when racing behind GATINEAU RIVER (M Neilson) and KING'S PARDON (D Tourneur).

BRIMARVI PRINCE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 3 : RYAN FERGUSON HANDICAP – 1250 metres

Shortly after the start EXTREME VALUE (P Roff) shifted out onto COUNTERSNIP (D Moor), which was tightened onto CAPODECINA (A Herrmann), which lost its position when tightened onto PRINT MONEY (T Pannell).

RACE 3 : RYAN FERGUSON HANDICAP – 1250 metres (Cont'd)

In the vicinity of the 1100 metres CAPODECINA (A Herrmann) was obliged to steady off the heels of LIGHT IT UP (S Cahill), which shifted in. S Cahill was reminded of his obligations when shifting ground in future.

PRINT MONEY (T Pannell) was inclined to lay in, in the early stages of the straight.

A Herrmann, the rider of CAPODECINA, was questioned regarding her use of the whip prior to the 100 metres. She pleaded guilty to a charge under AR137A(5)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was fined \$300.

S Cahill, the rider of LIGHT IT UP, reported his mount laid out during the event. LIGHT IT UP was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in both forelegs. Mr R Balfour, the Co-Trainer of LIGHT IT UP, was advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

D Tourneur, the rider of BIG ON BLING, reported, in his opinion, the filly felt awkward in its action in the near hind leg. BIG ON BLING was examined by the Club's Veterinary Surgeon who reported the filly to be exhibiting signs of tying-up.

INTREPIDO (NZ) was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

Following this race, the track was upgraded to Good 3 at 1.58 pm, retrospective to Race 3.

RACE 4 : DESIREE GILL MEMORIAL HANDICAP – 1550 metres

GOLDBYA (M Neilson) was slow to begin.

Inside the 1200 metres WHITE SAMBUCA (NZ) (D Tourneur) became awkward on the heels of JUSTIFY THAT (K Mallyon) for a number of strides, got its head up and raced ungenerously.

M Neilson, the rider of GOLDBYA, explained his instructions were to attempt to settle in a forward position but due to the manner in which the gelding began he was unable to take up a forward position and was obliged to settle back with cover. He stated that in the vicinity of the 1200 metres he followed WHITE SAMBUCA (NZ) (D Tourneur) and anticipated that gelding might settle closer to the rail but when this did not eventuate he was obliged to maintain his cover behind that horse for some distance and race wider than intended. He added that after following WHITE SAMBUCA (NZ) into the run he asked his mount for an effort near the 600 metres and the gelding responded in a positive manner and finished the race off strongly. GOLDBYA was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

WHITE SAMBUCA (NZ) was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the near foreleg. Mr P Stokes was advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

GRAND SCHILLER was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 5 : ADELAIDE ACCESS TAXIS HANDICAP – 2250 metres

In the vicinity of the 1600 metres DRAFTED (W Kerford) shied for no apparent reason, unbalancing its rider who lost his footing from his off side iron. W Kerford was able to regain control of his off side iron shortly thereafter. As a consequence CABLE BAY (NZ) (J Beriman), which was racing to the outside of DRAFTED, was inconvenienced when taken wider.

GOOD THINKING (K Mallyon) became held up for clear running at the entrance to the straight when racing inside the heels of DRAFTED (W Kerford) and was only able to obtain clear running approaching the 200 metres where it was obliged to shift out.

MOSSEGO (D Tourneur) was held up for clear ground from the entrance to the straight until near the 200 metres.

GOSSIP GURU was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 6 : HOMECARE PLUS HANDICAP – 1400 metres

Mr M Hickmott, the Trainer of PINS OF PELE (NZ), advised Stewards he would instruct Jockey S Cahill to attempt to settle with cover and avoid leading.

LUCKY LIVI (J Kah) jumped away awkwardly, shifted out and contacted LATIN HERO (J Holder), which was taken onto WHITTEN'S BREW (B Claridge), which lost its position when tightened onto PORTICI (T Pannell).

In the vicinity of the 200 metres LURCH (D Tourneur) laid out under pressure taking PORTICI (T Pannell) out into the running of PINS OF PELE (NZ) (S Cahill), which had to be steadied.

A Patterson, the rider of SWIFT SHAMROCK, which performed below expectations, explained he was instructed to take up a forward position and lead if possible and attempt to have the gelding relax as it can have a tendency to over-race. He added that after finding the lead comfortably, SWIFT SHAMROCK commenced to race fiercely and pulled hard despite his efforts from the vicinity of the 1200 metres to near the 600 metres and failed to finish the race off. SWIFT SHAMROCK was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 7 : PARAQUAD SA HANDICAP – 1400 metres

The start of this event was delayed approximately two minutes owing to the bit lifter fitted to the bit of SHEEZ ON TOP requiring attention on arrival at the barriers. It was established that the bit lifter had broken and was not serviceable and as no replacement bit lifter was available, Stewards permitted the mare to race with a ring bit. An announcement to this effect was made prior to this event.

Inside the 1200 metres MEDAL CONTENDER (A Herrmann), which was racing ungenerously, was obliged to be steadied when racing inside the heels of SHEEZ ON TOP (S Price).

CLEARLY PASSIONATE (A Patterson) raced wide without cover in the early stages.

At the entrance to the straight DANCING POETESS (J Holder) shifted out taking POTICHE (H Coffey) out onto KELLY ROYALE (E Boyd), which had to be steadied.

H Coffey, the rider of POTICHE explained the mare was very disappointing today, raced flat during the event and didn't finish the race off as expected. POTICHE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 7 : PARAQUAD SA HANDICAP – 1400 metres (Cont'd)

KATE'S DREAM was examined by the Club's Veterinary Surgeon who reported the mare had sustained a minor laceration to the off fore cannon bone. First Aid was administered.

MEDAL CONTENDER was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 8 : BOAG'S DRAUGHT HANDICAP – 1000 metres

STRIDING SUCCESS was declared to race in a bit lifter. As no bit lifter was available, Stewards permitted gelding to race with a lugging bit.

The start of this race was delayed approximately three minutes owing to STRAVINSKY CODE refusing to present to be loaded into the barriers.

COMMAND RULER (NZ) (W Kerford) was slow to begin.

In the vicinity of the 200 metres ETHBAAL (E. Boyd) was obliged to be steadied when racing to the outside of TIGARA'S GEM (K. Mallyon), which shifted out under pressure. As a consequence SAN JUAN AMIGO (D. Moor), which was following, was momentarily inconvenienced.

D. Moor, the rider of SAN JUAN AMIGO, reported his mount raced greenly throughout the event. SAN JUAN AMIGO was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the off foreleg. Mr. R. Balfour, the Co-Trainer of SAN JUAN AMIGO, was advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

GENERAL:

RACE 8 : BOAG'S DRAUGHT HANDICAP – 1000 metres

J. Kah, the rider of STRIDING SUCCESS, pleaded guilty to a charge under AR175(k) for being negligent in weighing in that she weighed out without a surcingle requiring her saddle to be returned and J. Kah having to be reweighed. J. Kah was fined \$100.
