**Report on Race Meeting held at Clare Racecourse**

**RACE 1 : XXXX GOLD / SABOIS MAIDEN PLATE - 1700 metres**

PRADASTAR (A. Herrmann) and DELAWAY BROM (T. Pannell) jumped away awkwardly.

PRADASTAR (A. Herrmann) raced greenly throughout and near the 400 metres had to be steadied off the heels of NORTHSIDE LAD (C. Forrest), which commenced to weaken.

J. Frew, the rider of DIAMOND HUSH, reported his mount made excess respiratory noise during the event. DIAMOND HUSH was examined by the Club's Veterinary Surgeon who reported a slow recovery.

T. Pannell, the rider of DELAWAY BROM, explained he had been instructed to attempt to obtain a forward position, however, due to the pace, he was only able to obtain a position mid-field with cover. He stated his mount travelled well, however, when he attempted to improve from the 500 metres, the filly did not quicken, lost ground and was finished the race off poorly. DELAWAY BROM was examined by the Club's Veterinary Surgeon who reported the filly to be lame in the near foreleg. Mr. T. Doudle, the Trainer of DELAWAY BROM, was advised a Veterinary Certificate of Fitness would be required prior to presenting the filly for a future trial or race.

**RACE 2 : TAYLOR'S WINES / SABOIS MAIDEN PLATE - 1200 metres**

On arrival on course COPPER CABLE, which was savaged by another horse en route to the course, was examined by the Club's Veterinary Surgeon who reported severe abrasions to both sides of the neck and near side hip and ruled the gelding unfit to race. First Aid was administered. Acting on this advice, Stewards withdrew COPPER CABLE at 1.03 pm.

TOKEN ONE (D. Tootell) and JANICE MAY (J. Potter) were slow to begin.

On jumping away SPEEDY TOUCH (A. Herrmann) shifted out onto BISHOP JOCK (S. Westover), which was taken out onto TOKEN ONE (D. Tootell), which was inconvenienced.

SPEEDY TOUCH (A. Herrmann) was inclined to hang out from approaching the 700 metres and continued to hang out until the entrance to the straight.

BISHOP JOCK (S. Westover) was inclined to lay in rounding the home turn, when racing to the inside of JANICE MAY (J. Potter).

## **RACE 2 : TAYLOR'S WINES / SABOIS MAIDEN PLATE - 1200 metres (Cont'd)**

SPEEDY TOUCH was examined by the Club's Veterinary Surgeon who reported excess upper respiratory noise. Ms. E. Hubbard, the Trainer of SPEEDY TOUCH, was advised a Veterinary Certificate of Fitness, including the results of a laryngoscopic examination, would be required prior to presenting the gelding for a future trial. Ms. Hubbard was also advised the gelding would be required to perform to the Stewards' satisfaction in an Official Barrier Trial prior to accepting for a future race.

JANICE MAY was examined by the Club's Veterinary Surgeon who reported swelling on the outside of the off foreleg. First Aid was administered.

## **RACE 3 : MAGIC FM / 5CS / SABOIS FILLIES AND MARES MAIDEN PLATE – 1100 metres**

D. Tourneur, the rider of WICKED KISS, was dislodged en route to the barriers. D. Tourneur was examined by the First Care Medical personnel and ruled fit to fulfil his engagements. On arrival at the barriers WICKED KISS was examined by the Club's Veterinary Surgeon and ruled fit to race.

On jumping away FACE LEICA STAR (T. Zanker) shifted out and made contact with THARP TIME (S. Westover).

Approaching the 700 metres FACE LEICA STAR (T. Zanker) was inclined to hang out and as a result inconvenienced THARP TIME (S. Westover), which was taken wider on the track.

DANCER'S DREAM (S. Cahill) was held up from the entrance to the straight until inside the 100 metres when awkwardly placed between the heels of HOST WITH THE MOST (J. Potter) and WICKED KISS (D. Tourneur).

S. Cahill, the rider of DANCER'S DREAM, explained he had been instructed to obtain a position with cover if possible. He added that the mare had travelled well, however, on entering the straight he was unable to obtain clear ground and attempted a run to the inside of HOST WITH THE MOST (J. Potter) but his mount was unable to quicken. He stated that after obtaining clear running to the outside of WICKED KISS (D. Tourneur) his mount did not quicken as he expected.

DAJEBONY RO was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

## **RACE 4 : ARMAGH FINANCIAL SERVICES RATING 0-58 HANDICAP – 1800 metres**

On arrival at the start, BARRIERS, which brushed a gate when leaving the mounting enclosure, was examined by the Club's Veterinary Surgeon and ruled fit to race.

SULLENBERGER, which was fractious in the barriers after being loaded, reared and became cast. SULLENBERGER was withdrawn by Stewards at 3.06 pm. MONTEFALCO and WAIKIKI GIRL which were in the adjacent barriers stalls, was examined by the Club's Veterinary Surgeon and ruled fit to race. L. Stojakovic, the rider of SULLENBERGER, was uninjured in the incident and was ruled fit to fulfil her remaining engagements by the First Care Medical personnel. Mr. B. Potter, the Trainer of SULLENBERGER, was advised the gelding would be required to present at either an Official Barrier Trial or an Official Jump Out to gain approval to race.

MILD MANNERED (A. Herrmann) was slow to begin.

Shortly after jumping HARRISVILLE TOFF (S. Cahill) shifted out and inconvenienced MILD MANNERED (A. Herrmann).

**RACE 4 : ARMAGH FINANCIAL SERVICES RATING 0-58 HANDICAP – 1800 metres**  
**(Cont'd)**

Approaching the 300 metres BARRIERS (E. Boyd) had to be steadied off the heels of TINKLER'S LANE (NZ) (T. Pannell), which shifted out, and became awkward for a number of strides. Shortly after MILD MANNERED (A. Herrmann) rolled in slightly at the same time as MYSTIC FOX (J. Potter) shifted out, resulting in BARRIERS having to check. J. Potter was advised to take greater care when shifting ground in future.

MILD MANNERED, which performed poorly, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

**RACE 5 : JIM BARRY WINES RATING 0-72 HANDICAP - 1200 metres**

On arrival at the barriers UMA WAVE required resaddling.

CAMBIASO (K. Brooks), which was slow to begin, was hampered by WILLEGO (T. O'Donnell) and UMA WAVE (L. Stojakovic), which shifted ground on jumping away.

On jumping away NOBLE ROMP (A. Patterson) was inconvenienced when tightened between TWILIGHT DANCER (D. Tourneur) and BRIEF HAPPINESS (A. Doyle), which both shifted ground.

BRIEF HAPPINESS (A. Doyle) was inclined to lay out from the 700 metres to entrance to the straight.

**RACE 6 : TAMINGA HOTEL CLARE VALLEY CUP - 1800 metres**

Shortly after the start CORDUROY (T. Pannell) shifted out onto FRAANIKOVA (J. Kah), which was taken out onto PACINO (S. Cahill), which lost its position when tightened onto WOTZITWORTH (A. Patterson), which was hampered.

ALLEZ TARA (J. Maund) over-raced in the early stages of the event.

In the vicinity of the 1300 metres SACRED SNAADEE (D. Tootell) had to be steadied off the heels of SANDHILL PRINCE (D. Tourneur), which shifted in. D. Tourneur was reprimanded and advised in future to ensure he was sufficiently clear when shifting ground.

Approaching the 400 metres SACRED SNAADEE (D. Tootell) improved onto, and had to be steadied off the heels of SANDHILL PRINCE (D. Tourneur), which had not commenced to make its run.

Mr. J. MacMillan, the Trainer of FRAANIKOVA, was reprimanded for making contact with Apprentice J. Kah prior to her weighing in.

MANGANESE was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the off foreleg. Mr. K. Sweeney, the Trainer of MANGANESE, was advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

**RACE 7 : KIRRIHILL WINES RATING 0-58 HANDICAP - 1100 metres**

SIR TRENTIN (K. Brooks) was slow to begin and missed the start several lengths.

SEE SPARKY (A. Herrmann) over-raced in the early stages of the event.

Race 4 – SULLENBERGER – Suspended – Required to present at either an Official Barrier Trial or Official Jump Out to gain approval to race – Fractious in barriers. Race 6 – MANGANESE - Not to race – Vet Certificate of Fitness required prior to trial or race – Lameness off foreleg.
