**RACE 1 : CASTEC RURAL SUPPLIES RATING 0-68 HANDICAP - 1200 metres**

The start of this race was delayed approximately five minutes owing to the false rail leaving the chute having to be realigned and also due to Stewards having to hold to avoid a clash with an interstate event.

FORT CHAUVEL (P. Marks) jumped away awkwardly and raced keenly in the early and middle stages of the event.

In the vicinity of the 50 metres CASINO MISS (L. Hopwood) shifted out abruptly away from WELCOME NED (C. Jones), which had improved quickly to that mare's inside, resulting in CASINO MISS having to take hold off the heels of TULLY PLENTY (A. Herrmann).

Over the concluding stages WELCOME NED (C. Jones) shifted out under pressure, contacting TULLY PLENTY (A. Herrmann), which was momentarily unbalanced. C. Jones was advised in future she would be required to make a greater effort to keep her mounts straight when they commence to shift.

**RACE 2 : WOLF BLASS / SABOIS MAIDEN PLATE - 1000 metres**

The start of this race was delayed approximately three minutes owing to the delay in the previous event.

TROUBLED GLASS (C. Lindop) was slow to begin and shortly after was hampered when contacted by NIGHT NEWS (J. Toeroek), which jumped away awkwardly and shifted out.

DANUBE DELTA (NZ) (S. Noble) jumped away awkwardly.

MINI PERFUME (A. Patterson) jumped away awkwardly and shifted out, brushing DUBAILATION (C. Forrest).

## **RACE 2 : WOLF BLASS / SABOIS MAIDEN PLATE - 1000 metres (Cont'd)**

GALLIUMS TABARET (L. Hopwood) raced keenly in the early stages of the event.

In the vicinity of the 300 metres DUBAILATION (C. Forrest), which was racing greenly, shifted in onto QUEEN NEDIYM (A. Herrmann), which was inconvenienced when tightened onto MINI PERFUME (A. Patterson).

J. Kah, the rider of SANDHILL HERO, explained the gelding had jumped away only fairly and was unable to take up a position closer to the speed despite her efforts. She added the gelding was not comfortable in its action in the early and middle stages of the event and raced greenly, however, when placed under pressure inside the 600 metres, responded to her riding and in her opinion finished the race off well. SANDHILL HERO was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

## **RACE 3 : NARACORTE TOYOTA / SABOIS MAIDEN PLATE - 1430 metres**

SPARE ONE (S. Noble) dipped on jumping away.

JUST A BOB (S. Price) raced three wide without cover throughout the event.

In the vicinity of the 400 metres EMAIL (J. Kah) shifted out and brushed WANNA THRILL (A. Patterson).

In the vicinity of the 300 metres SPARE ONE (S. Noble) shifted out and brushed EMAIL (J. Kah) and shortly after shifted back in onto VILIFY (A. Herrmann), inconveniencing that mare.

BIT OF A LAIR (S. Cahill) laid in under pressure in the straight and in the vicinity of the 150 metres, shifted in, inconveniencing HASTA LA GORBY (C. Lindop), which was tightened onto FASTNET KATE (C. Forrest).

WANNA THRILL (A. Patterson) was inclined to roll in under pressure in the straight towards TRANSFORMING (L. Hopwood), which shifted in and away, and brushed HASTA LA GORBY (C. Lindop) on two occasions in the vicinity of the 100 metres.

FASTNET KATE (C. Forrest) was unable to obtain clear ground over the final 100 metres when awkwardly placed on the heels of BIT OF A LAIR (S. Cahill) and inside HASTA LA GORBY (C. Lindop).

JUST A BOB, which commenced to give ground from the 600 metres, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

## **RACE 4 : PENFOLDS BENCHMARK 80 HANDICAP - 1430 metres**

ACE OR JOKA, which brushed a perimeter fence on leaving the mounting yard, was examined by the Club's Veterinary Surgeon on arrival at the start and ruled fit to race.

SEASON OF FORTUNE (S. Noble) was slow to begin.

C. Forrest, the rider of STRIKE BREAKER, reported the gelding was inclined to lay out throughout the event and she was concerned with its action over the concluding stages. STRIKE BREAKER was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

J. Toeroek, the rider of MY WAY, reported the gelding was inclined to lay out throughout the event.

### **RACE 5 : SMITH & HOPPER RATING 0-68 HANDICAP - 2000 metres**

RICHARD THE (C. Lindop) laid in under pressure in the straight, brushing COOL AS HEL (S. Cahill) on a number of occasions as that gelding was inclined to shift out.

J. Kah, the rider of SURPRISE US, reported the gelding was inclined to lay out throughout the event. SURPRISE US was examined by the Club's Veterinary Surgeon who reported minor lacerations to the near hind leg.

S. Cahill, the rider of COOL AS HEL, explained the gelding had travelled well in the early and middle stages of the event, however, when placed under pressure in the vicinity of the 400 metres, failed to respond to his riding and commenced to hang out severely. COOL AS HEL was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RICHARD THE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

### **RACE 6 : PATRICK OF COONAWARRA RATING 0-62 HANDICAP - 1000 metres**

OURHALO, which brushed a fence on leaving the mounting enclosure, was examined by the Club's Veterinary Surgeon on arrival at the start and ruled fit to race.

WORROLONG LAD (C. Lindop) jumped away awkwardly and shifted out, brushing NORDIC MONARCH (E. Boyd) and shortly after shifted back in abruptly, inconveniencing KILL BILL (A. Herrmann).

BIG SKY (J. Frew) raced wide without cover throughout the event.

GREYBROW (S. Price) raced wide without cover throughout the event and was inclined to lay out under pressure in the straight.

From the vicinity of the 400 metres KILL BILL (A. Herrmann) was held up until the entrance to the straight when able to ease across the heels of COURTING JUSTICE (J. Potter) to obtain clear ground.

### **RACE 7 : MALONE RATING 0-58 HANDICAP - 1430 metres**

Shortly after the start METRO CAT (P. Marks) shifted in onto VIN DE VIE (A. Herrmann), which was hampered and lost its position when tightened onto CREON (L. Hopwood), which was inconvenienced when taken in onto LOTS OF HEART (K. Post), which had been taken out by BANGLES (J. Dertilis), which lost its position when taken out by ACT OF FREEDOM (S. Noble).

DAZZIKI (C. Lindop) raced wide without cover throughout the event.

Inside the 100 metres VIN DE VIE (A. Herrmann) laid out onto the heels of LOTS OF HEART (K. Post), which held its line, resulting in VIN DE VIE having to ease across that gelding's heels to obtain clear ground.

METRO CAT, which commenced to give ground in the vicinity of the 600 metres, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

C. Lindop, the rider of DAZZIKI, reported she placed the mare under pressure in the vicinity of the 800 metres and it failed to respond to her riding and she became concerned with its action and for that reason had not ridden the mare out in her normal manner in the straight. DAZZIKI was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

**GENERAL:**

On Sunday, 1 December 2013, Mr. G. Lesnikowski reported that on return to his stable JUST A BOB (Race 3) and KRAFAYIS (Race 5) were both sore in front.
