THOROUGHBRED RACING S.A. LIMITED STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Morphettville Parks Racecourse by the South Australian Jockey Club on Saturday, 30 November 2013

RACE 1: ADELAIDE GALVANISING PLATE - 1000 metres

MANHATTAN PRINCE (A. Patterson) was slow to begin.

I AM GYPSY (A. Herrmann), which jumped away awkwardly, was then inclined to over-race in the early stages of the event and commenced to race greenly in the middle stages and hung out severely in the vicinity of the 600 metres for a short distance. I AM GYPSY was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

BOSSY MISS MOSSY (S. Price) and INNOVATIVE JILL (J. Kah) contacted on jumping away.

In the vicinity of the 500 metres BONITA ICE (M. Neilson) was awkwardly placed inside the heels of BOSSY MISS MOSSY (S. Price) for a short distance.

BONITA ICE (M. Neilson) raced greenly in the straight and shifted ground both ways between the 300 metres and the 200 metres.

Approaching the 100 metres INNOVATIVE JILL (J. Kah) shifted out abruptly and inconvenienced SHOW SET (J. Potter), which was taken wider. As a consequence I AM GYPSY (A. Herrmann) was inconvenienced.

M. Neilson, the rider of BONITA ICE, reported his saddle slipped back shortly after the start, placing him at a disadvantage for the remainder of the event. He also reported the filly did not feel comfortable in its action. BONITA ICE was examined by the Club's Veterinary Surgeon who reported a laceration to the off fore pastern. First Aid was administered.

RACE 2 : CBS INC RATING 0-86 - 1250 metres

The start of this race was delayed approximately one minute owing to racecourse staff having to attend to seagulls, which settled between the 200 metres and the 100 metres.

GATINEAU RIVER (J. Bowditch) was slow to begin.

RACE 2: CBS INC RATING 0-86 - 1250 metres (Cont'd)

OUR NKWAZI (C. Lindop) became held up for clear running for a short distance near the 400 metres when racing inside the heels of LE BEAU CHEVAL (K. Connor) and behind IDALOU (J. Toeroek).

J. Bowditch, the rider of GATINEAU RIVER, explained as a consequence of his mount not beginning on terms, he was unable to take up a forward position as intended which placed him at a disadvantage during the race.

GATINEAU RIVER was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 3: RSL CARE SA 3YO BENCHMARK 72 - 1250 metres

Mr. S. Trenowden, the Trainer of COSMIC KHELEYF, advised Stewards he would instruct Jockey S. Price to attempt to obtain a position on pace in the race.

On arrival at the barriers WAR HEIGHTS was examined by the Club's Veterinary Surgeon and ruled fit to race.

The start of this race was delayed approximately two minutes owing to a number of horses proving difficult to load.

WAR HEIGHTS lost its near fore plate during the event.

YEN, which was inclined to lay in, in the straight, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities other than the filly lost its off fore plate during the event.

Subsequent to the event WAR HEIGHTS was again examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 4: THE TPI RATING 0-72 - 1250 metres

MEGA QUEEN (J. Toeroek) was slow into stride.

EXALTED WILLIAM (C. Lindop) and APALA (A. Herrmann) raced wide without cover in the early stages.

HEZA HUSSLER (S. Cahill) was inclined to lay in, in the straight.

J. Toeroek, the rider of MEGA QUEEN, reported his mount did not stretch out during the event. MEGA QUEEN, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 5 : THE WOLF BLASS WINES BENCHMARK 90 - 1400 metres

On arrival on course CELLARMASTER (NZ) was examined by the Club's Veterinary Surgeon who reported an insignificant swelling on the gelding's neck. CELLARMASTER (NZ) was ruled fit to race.

The start of this race was delayed approximately four minutes initially owing to an interstate delay and also owing to MISTY EYES requiring the attention of the Farrier after it lost its near fore plate en route to the barriers. MISTY EYES was examined by the Club's Veterinary Surgeon and ruled fit to race.

RACE 5: THE WOLF BLASS WINES BENCHMARK 90 - 1400 metres (Cont'd)

JUSTIFY THAT (J. Toeroek) jumped away awkwardly, shifted in and tightened EXTRA VIRGIN (J. Kah) onto RIVER'S LANE (E. Boyd), resulting in both runners being inconvenienced.

EXTRA VIRGIN (J. Kah) became held up for a short distance at the entrance to the straight when racing behind JUSTIFY THAT (J. Toeroek) and inside DAYTONA GREY (C. Lindop) and was obliged to alter course to the inside of JUSTIFY THAT to obtain clear running approaching the 200 metres.

Correct Weight for this event was delayed to allow E. Boyd, the rider of the second placegetter RIVER'S LANE, and Mr. R. Balfour, the Co-Trainer of the gelding, to view the official footage in the straight.

EXTRA VIRGIN lost its near hind plate during the event.

DAYTONA GREY was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in both forelegs. Mr. L. Macdonald, the Co-Trainer of DAYTONA GREY, was advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

JUSTIFY THAT was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 6: THE HAIGH'S CUP RATING 0-86 - 1950 metres

The start of this race was delayed approximately two minutes owing initially to an interstate delay and also to LUCKY LIVI and CHIEFTAIN JACK proving fractious after being loaded.

ALBONETTI (L. Hopwood) was held up for clear running from in the vicinity of the 400 metres when racing between TEXAN WARNEY (J. Toeroek) and LUCKY LIVI (C. Lindop) and shortly after entering the straight elected to improve into a run to the outside of TEXAN WARNEY but was unable to do so due to the positioning of DETOX (M. Neilson) and was obliged to alter course to the inside of TEXAN WARNEY to improve. Shortly thereafter, approaching the 100 metres, ALBONETTI was again obliged to shift in to obtain clear running.

M. Neilson, the rider of DETOX, explained he was comfortable to settle back of mid-field early but was conscious of the pace in the event and approaching the 800 metres elected to shift out wider on the track in an attempt to maintain the mare's momentum. He added that whilst he considered the tempo was genuine, he was conscious of the weight carried by the mare and for that reason commenced his run inside the 600 metres but DETOX failed to finish the race off and was disappointing. He added the mare was inclined to lay out under pressure. DETOX was examined by the Club's Veterinary Surgeon who reported the mare to be lame in the near hind leg. Mr. J. Stephens, the Trainer of DETOX, was advised a Veterinary Certificate of Fitness would be required prior to presenting the mare for a future trial or race.

RACE 7: ALF GARD MEMORIAL CUP RATING 0-78 - 1000 metres

On arrival on course UNFAITHFULLY was examined by the Club's Veterinary Surgeon who reported the mare to be lame in the off foreleg and unfit to race. Acting on that advice, Stewards withdrew UNFAITHFULLY at 3.45 pm. Mr. D. Egan, the rider of UNFAITHFULLY, was advised a Veterinary Certificate of Fitness would be required prior to presenting the mare for a future trial or race.

RACE 7: ALF GARD MEMORIAL CUP RATING 0-78 - 1000 metres (Cont'd)

MARBLE RYE (A. Herrmann) became held up for clear running for a number of strides on entering the straight when racing behind NULLARBOR NYMPH (J. Toeroek).

OGUNDE lost its off hind plate during the event.

J. Toeroek, the rider of NULLARBOR NYMPH, reported his mount was inclined to lay in during the event.

STRAVINSKY CODE and OGUNDE were examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 8: SPORTINGBET RATING 0-78 - 1400 metres

ASSABOY required resaddling on arrival at the barriers.

PEACE OF HEAVEN, which contacted the mounting enclosure gate en route to the barriers, was examined by the Club's Veterinary Surgeon who ruled it fit to race.

MONEY BAGS (M. Neilson) jumped away awkwardly, shifted in and contacted PORTICI (T. Pannell), which was taken in onto LATIN HERO (J. Holder), which began awkwardly, resulting in LATIN HERO being inconvenienced.

ASSABOY (J. Bowditch) and ROWDY ROCKER (A. Herrmann) contacted at the start.

Inside the 1200 metres ROWDY ROCKER (A. Herrmann) and PORTICI (T. Pannell) contacted for a number of strides as ROWDY ROCKER shifted in to obtain a position closer to the rail.

In the vicinity of the 900 metres DIFFERING FORTUNES (S. Price) rolled in and momentarily inconvenienced ROWDY ROCKER (A. Herrmann).

Approaching the 200 metres DIFFERING FORTUNES (S. Price), which laid in, raced in restricted room between PORTICI (T. Pannell) and MONEY BAGS (M. Neilson), which both shifted ground, and had to be steadied.

Over the concluding stages LATIN HERO (J. Holder) was tightened between ROSES IN THE GLEN (C. Lindop), which maintained its line, and PORTICI (T. Pannell), which rolled in under pressure.

J. Toeroek, the rider of MAHMENTUM, explained his instructions were to take up a forward position and after riding the gelding aggressively in the early stages to comply with his instructions, he was unable to do so and was obliged to settle back of mid-field due to the pace and composition of the field. Thereafter he was obliged to race wide without cover for some distance and when asked for an effort in the vicinity of the 600 metres, the gelding failed to respond to his riding and finished the race off in a disappointing manner. He added for that reason he did not persist with his riding over the final 200 metres as the gelding commenced to weaken and lose contact with the field. MAHMENTUM was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

ROSES IN THE GLEN was examined by the Club's Veterinary Surgeon who reported mild abdominal discomfort.
