RACE 1: BOAG'S DRAUGHT HANDICAP - 1400 metres

Mr J. Hyam, the Trainer of PETMAN, advised Stewards he would instruct Apprentice S. Westover to attempt to find a position back of midfield with cover rather than on pace, as the horse has been at its most recent starts, in an attempt to have the gelding finish off its race better.

On jumping away the offside iron of BARIGAN BOY (O. Ay) was dislodged from the saddle, placing that rider at a severe disadvantage for the remainder of the event.

PETMAN lost its near fore plate during the running of the event.

Stewards ordered that tickets be held to establish if BARIGAN BOY had carried the correct weight in the event. O. Ay was not less than half a kilogram under his declared weight when he weighed in and correct weight was declared.

MONEY BAGS was examined by the Club's Veterinary Surgeon who reported the gelding had suffered a bilateral bleeding attack during the event. Mr P. Stokes, the Trainer of MONEY BAGS, was advised that MONEY BAGS was now suspended from racing for a period of 3 months in accordance with AR53A.

RACE 2 : TATTSBET HANDICAP - 1250 metres

BELTONIC (N. Beriman) was slow to begin.

RACE 2: TATTSBET HANDICAP - 1250 metres (Cont'd)

Inside the 1000 metres MEDAL CONTENDER (D. Tourneur) became awkwardly placed on the heels of DANCE FOR CASH (P. Gatt) as the pace eased, resulting in MEDAL CONTENDER making the turn awkwardly and shifting out, inconveniencing NIMASAEL (L. Hopwood). STEREOSONIC (NZ) (J. Mott), which was racing behind MEDAL CONTENDER, had to be restrained and in doing so shifted out, clipping the heels of MEDAL CONTENDER, making contact with the hindquarters of MARBLE RYE (A. Herrmann), which became unbalanced.

BELTONIC (N. Beriman) was inclined to lay out from the vicinity of the 600 metres.

MEDAL CONTENDER (D. Tourneur) had difficulty obtaining clear ground in the straight when racing behind NIMASAEL (L. Hopwood) and between MARBLE RYE (A. Herrmann) and DANCE FOR CASH (P. Gatt).

DANCE FOR CASH was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 3: SCHWEPPES HANDICAP - 1000 metres

CRABBING (S. Westover) was slow to begin.

BLUE MAGNATE (A. Herrmann) jumped away awkwardly.

ARDERE (T. Pannell) shifted out on jumping away and contacted ALPHABETIC (H. McKechnie).

Approaching the 200 metres BLUE MAGNATE (A. Herrmann) shifted out to improve and in doing so brushed CRABBING (S. Westover).

RACE 4: ALAN SHEPPARD CONSTRUCTIONS HANDICAP - 1950 metres

In the vicinity of the 1850 metres BIT OF A SCHILLER (J. Frew) shifted in onto SOUTHERN INVASION (A. Herrmann), which shifted in and away onto SMOKE BURNER (D. Tourneur), and was forced to steady. J. Frew was severely reprimanded and advised in future to shift ground only when entitled to do so.

CATON (L. Hopwood) raced three wide without cover throughout the event.

SMOKE BURNER (D. Tourneur) laid out under pressure over the concluding 100 metres and inside the 50 metres shifted out onto SOUTHERN INVASION (A. Herrmann), which was forced to steady when tightened onto BIT OF A SCHILLER (J. Frew). D. Tourneur was severely reprimanded and advised in future he would be required to make an effort to straighten his mounts when they commence to shift ground.

Correct Weight for this event was delayed to allow A. Herrmann, rider of the fourth placegetter SOUTHERN INVASION, to view the official vision in the straight.

RACE 5 : SPORTINGBET HANDICAP - 1250 metres

REBEL TRUCE (J. Mott) shifted in on jumping away, inconveniencing GOLDBYA (M. Neilson), which was tightened onto NATURAL DISASTER (D. Stra).

In the vicinity of the 700 metres REBEL TRUCE (J. Mott) laid in onto MAGICAL PEARL (P. Gatt), which became awkwardly placed on that gelding's heels for a number of strides. REBEL TRUCE continued to lay in for the remainder of the event.

RACE 5 : SPORTINGBET HANDICAP – 1250 metres (Cont'd)

NATURAL DISASTER (D. Stra) laid out under pressure in the straight.

REBEL TRUCE was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in both forelegs. Mr P. Payne, the Trainer of REBEL TRUCE, was advised that a veterinary certificate of fitness would be required prior to accepting for a future trial or race.

NATURAL DISASTER and GOLDBYA were examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 6: ANGELAKIS BROS HANDICAP - 1400 metres

ASTRO DAMUS (J. Maund) shifted out on jumping away, hampering BALLYPATRICK (J. Holder), which was tightened onto TOKEN ONE (D. Tootell).

In the vicinity of the 1000 metres ASTRO DAMUS (J. Maund) improved onto the heels of TOKEN ONE (D. Tootell) as that rider eased the pace to obtain cover behind LITTLE BRO (J. Mott), resulting in ASTRO DAMUS getting its head up and becoming awkward on that gelding's heels for a number of strides.

Inside the 1000 metres ON A DREAM (C. Lindop) raced keenly for a short distance whilst being restrained.

ASTRO DAMUS (J. Maund) made the turn in the vicinity of the 800 metres awkwardly and shifted out onto the heels of TOKEN ONE (D. Tootell).

BALLYPATRICK, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported the gelding had a lower than expected heart rate.

RACE 7: AUSTRALIA DAY RACES 25TH JANUARY HANDICAP - 1400 metres

CHARLES IN CHARGE (M. Neilson) shifted out on jumping away, tightening COUP DE BEEL (NZ) (C. Lindop) onto TRUENO (T. Pannell), which became unbalanced when its hindquarters were turned out and was taken out, contacting ALANAJUNE (J. Holder).

COUP DE BEEL (NZ) (C. Lindop) raced fiercely in the early and middle stages of the event.

From the entrance to the straight until the vicinity of the 200 metres ALANAJUNE (J. Holder) was held up when racing behind THE CONCORDE (P. Gatt) and inside WHITE ROE (S. Westover) and then had difficulty obtaining clear ground over the concluding 200 metres.

TRUE SASSO (J. Toeroek) was momentarily held up at the entrance to the straight and had to alter course to the outside of COUP DE BEEL (NZ) (C. Lindop) to obtain clear ground.

J. Toeroek, rider of TRUE SASSO, reported to Stewards that that filly had been inclined to shift about throughout the event. TRUE SASSO was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

STIMULATTE, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

ALANAJUNE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 8 : EXPRESS COLOUR PRINTING HANDICAP – 1000 metres

IMPULSE BUY (A. Herrmann) was slow to begin.

IMPULSE BUY (A. Herrmann) and ALPHA MAN (H. McKechnie) were both inclined to shift about under pressure in the straight.

ON STRIKE (S. Cahill) was inclined lay out under pressure in the straight.

IMPULSE BUY, ALPHA MAN and WISE AND HAPPY were examined by the Club's Veterinary Surgeon who reported no visible abnormalities.
