RACE 1 : MILLERS CHILL / SABOIS MAIDEN PLATE - 1000 metres

MISS BELLARAE required its bridle to be refitted on arrival at the barriers.

DAKOTA CHARLIE (R. Bell) jumped away awkwardly.

THE GET GO (M. Neilson) and HOT COCO (C. Forrest) raced wide without cover in the early stages of the event.

RUBY JUBES (L. Hopwood) hung out severely rounding the home turn taking HOT COCO (C. Forrest) wider on the track. RUBY JUBES was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

TOLLEROUGHYED (K. Brooks) raced greenly in the straight.

DAKOTA CHARLIE, which performed poorly, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

WHERE HEARTS LIE, which performed below expectations, was examined by the Club's Veterinary Surgeon, who reported no visible abnormalities.

RACE 2 : CARLTON DRY / SABOIS MAIDEN PLATE - 1360 metres

JIMMY'S EYE (S. Westover) jumped away awkwardly and shifted in onto MARITA MARIA (R. Bell), which was inconvenienced as CACKLE (W. Kerford), which also jumped away awkwardly, shifted out.

Shortly after the start CACKLE (W. Kerford) attempted to buck. Mr. D. Courtney, the Trainer of CACKLE, was advised a warning had been placed on the filly in relation to its racing manners and any repetition may result in stronger action being taken.

Approaching the 200 metres JAWANNA (S. Cahill) was inclined to lay in under pressure and in doing so momentarily inconvenienced LEWIS STREET (P. Roff).

RACE 3 : CARLTON DRAUGHT RATING 0-62 HANDICAP (Division 1) - 1360 metres

Mr. B. Clarke, the Trainer of SHE'S GOT SOUL, advised Stewards he would instruct Jockey L. Hopwood to attempt to obtain a position forward of mid-field in an attempt to finish the race off better. Mr. Clarke was reminded of his obligations under AR135A in advising Stewards as soon as practicable but no later than thirty minutes prior to the race.

SHE'SMISUNDERSTOOD (D. Tourneur) jumped away awkwardly and shifted out, contacting SHE'S GOT SOUL (L. Hopwood).

RACE 4 : TUNARAMA TWILIGHT 24 JANUARY RATING 0-62 HANDICAP (Division 2) - 1360 metres

On arrival on course MUKARRAR, which had not raced since May 2012, was examined by the Club's Veterinary Surgeon who ruled the gelding fit to race.

On jumping away DAZZA'S GIRL (K. Bishop) and MOON DEVIL (P. Roff) came together and contacted. Shortly thereafter DAZZA'S GIRL shifted out and contacted CAPTAIN PERCY (L. Hopwood).

RACE 5 : CARLTON COLD 3.5 RATING 0-68 HANDICAP - 1000 metres

SUTANOC (L. Hopwood) shifted out on jumping away and contacted AFTONLAND (R. Bell), which was taken out onto STRIDING SUCCESS (C. Forrest), which had shifted in. As a result AFTONLAND was inconvenienced.

ACHENAR (K. Brooks) raced without cover in the early and middle stages of the event.

DOUBLE DEALING (K. Bishop) over-raced in the early and middle stages of the event.

RACE 6 : ANVERS WINES BENCHMARK 80 HANDICAP - 1750 metres

On jumping away OCSMEPOP (K. Bishop) and MISS ABERDEEN (L. Hopwood) brushed.

EBONY ROCK (R. Bell) raced wide without cover in the middle stages of the event.

Approaching the 100 metres JAPAN (P. Roff) rolled in, tightening THE BIG RED VEE (J. Potter), which became unbalanced for a number of strides and was obliged to alter course to the outside of JAPAN. P. Roff was reprimanded and advised to take greater care when his mounts commence to shift ground in future.

RACE 7 : GOODWOOD PARK HOTEL BENCHMARK 80 HANDICAP - 1200 metres

YARTERBERY (L. Stojakovic) raced wide without cover in the middle stages of the event. YARTERBERY was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

K. Bishop, the rider of ROLL ON BAI, reported her mount was inclined to hang in under pressure in the straight and she therefore had difficulty riding the gelding out to the line.

VALUE AS, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported a minor laceration to the outside of the near fore cannon and a slow recovery.

RACE 7 : GOODWOOD PARK HOTEL BENCHMARK 80 HANDICAP - 1200 metres (Cont'd)

HANK'S NEPHEW, which performed below expectations, was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

Stewards questioned D. Tourneur, the rider of DIRE WARNING, in relation to riding his mount out to the line. Stewards adjourned the inquiry to a date to be fixed.

RACE 8 : CAFÉ DE GIORNO'S RATING 0-62 HANDICAP - 1200 metres

On arrival on course MILLIGANS, which had not raced since July 2012, was examined by the Club's Veterinary Surgeon who ruled the mare fit to race.

Inside the 600 metres HARDERS (A. Patterson) broke down, fell and dislodged its rider A. Patterson. As a consequence DANCING MARY (L. Hopwood) and TYCOON CELEBRITY (S. Westover), were inconvenienced and DAZZLING LILLY (S. Price), SOCIAL ASSASSIN (M. Neilson), SEEARDI BLUE (P. Roff), DESTONY HAWK (J. Potter) and HEART OF STONE (L. Stojakovic), which were all severely hampered, fell, dislodging their riders. LOVER'S ROCKS (W. Kerford), which was also severely hampered in the incident, shifted out, unbalancing W. Kerford whose saddle shifted sideways, dislodging W. Kerford. As a further consequence of the fallen horses and riders, RUBY'S ANGEL (C. Forrest) was severely hampered and MILLIGANS (K. Brooks) was inconvenienced when taken wider by LOVER'S ROCKS.

Correct Weight for this event was delayed, initially to allow emergency services to be provided to the seven fallen riders and was further delayed to allow Stewards to view the incident and the remainder of the event. Correct Weight was announced at 7.43 pm.

Prior to leaving the course, Stewards inspected the track in the vicinity of the 600m where the incident occurred and found nothing untoward.

HARDERS was examined by the Club's Veterinary Surgeon who reported a fracture to both front fetlocks and as a consequence had to be humanely euthanised.

SOCIAL ASSASSIN was examined by the Club's Veterinary Surgeon who reported a hematoma to the chest and first-aid was administered. Mr J Dunn, the trainer of SOCIAL ASSASSIN, was advised a veterinary certificate of fitness would be required prior to accepting for a future race or trial.

As a result of the incident inside the 600m all riders were examined on-course by First Care Medical staff resulting in A. Patterson, J. Potter, L. Stojakovic and P. Roff being transported to hospital for further observation.
